5 A BILL

6 For an Act entitled: "An Act relating to the Alaska Land Commission; and
7 providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 41 is amended by adding a new chapter to read:

10 CHAPTER 45. ALASKA LAND COMMISSION.

11 Sec. 41.45.010. PURPOSE. The purpose of this chapter is to pro-
12 vide for a common system of planning and classification by the state and
13 the United States of mutually agreed upon areas of public land in Alaska
14 by establishing land use planning and classification institutions which
15 provide full protection of nationally significant natural values, enable
16 a flexible response to energy and other commodity needs as they arise,
17 and minimize conflicts among landowners and between competing land uses.

18 Sec. 41.45.020. POLICY. The legislature recognizes the best use
19 of the public domain will change with time and that only an active
20 classification system can meet these changing needs. The legislature
21 further recognizes that there is a valid national public interest in
22 public land in Alaska, including state land, as well as a valid interest
23 on the part of the people of Alaska in federal land in Alaska.

24 Sec. 41.45.030. COMMISSION. There is established the Alaska Land
25 Commission.

26 Sec. 41.45.040. MEMBERSHIP. (a) The commission shall consist of
27 six full-time members.

28 (b) Three members of the commission, one of whom shall be desig-
29 nated as state co-chairman, shall be appointed by the governor and shall

1 serve at his pleasure.

2 (c) Members appointed by the governor are subject to confirmation
3 by a majority of the members of the legislature in joint session.

4 Sec. 41.45.050. TERM. The term of office of a state member of the
5 commission is four years and shall coincide with that of the governor.
6 A vacancy in the office of a member representing the state shall be
7 filled by appointment by the governor. The appointee selected to fill
8 the vacancy shall hold office for the balance of the full term for which
9 his predecessor was appointed. An appointee to an unexpired term shall
10 be subject to the same confirmation requirements as any other appointee.

11 Sec. 41.45.060. COMPENSATION. The three members of the commission
12 appointed by the governor shall receive an annual salary as established
13 under AS 39.23. Members appointed by the governor are entitled to per
14 diem and travel expenses authorized by law for boards and commissions.

15 Sec. 41.45.070. DUTIES. The commission shall

16 (1) initiate and maintain a continuing process of land use
17 planning and classification, including but not limited to submitting
18 recommendations to the governor and legislature of Alaska and the
19 Congress of the United States concerning state and federal land to be
20 designated as "common management areas", the identification of land
21 amenable to special use designation, the determination of federal and
22 state land which may be made available for disposal, and recommendations
23 regarding the use of other land remaining in federal and state owner-
24 ship;

25 (2) classify land included within common management areas;

26 (3) establish procedures to govern the performance of the
27 business of the commission, including provision for public hearings to
28 obtain public comment on existing and proposed land use planning and
29 management programs of the state and federal governments;

1 (4) review and recommend to the federal government and to the
2 state changes in statutes and regulations affecting land in the state
3 which is subject to cooperative management under this chapter which are
4 necessary or desirable;

5 (5) review resource inventories prepared by the managing
6 agencies of land designated as "common management areas";

7 (6) make recommendations to appropriate federal and state
8 officials with respect to ways to improve coordination and consultation
9 between the state and federal governments in wildlife management, trans-
10 portation planning, wilderness review, and other governmental activities
11 which appear to require regional or statewide coordination;

12 (7) make recommendations to appropriate federal and state
13 officials with respect to ways to insure that economic development is
14 orderly and planned and is compatible with state and national economic,
15 social, and environmental objectives;

16 (8) make recommendations to appropriate federal and state
17 officials with respect to those changes in laws, policies, and programs
18 relating to public land and resources which the commission considers
19 necessary;

20 (9) make recommendations to appropriate federal and state
21 officials with respect to the inventory, planning, classification,
22 management, and use of federal and state land, respectively, and to
23 provide such assistance to Native corporations upon their request;

24 (10) make recommendations to appropriate federal and state
25 officials with respect to needed modifications in existing withdrawals
26 of federal and state public land;

27 (11) make recommendations to appropriate federal and state
28 officials with respect to the programs and budgets of federal and state
29 agencies responsible for the administration of public land in Alaska;

1 and

2 (12) establish citizens' advisory committees to assist the
3 commission in carrying out its duties and to ensure that affected par-
4 ties may comment upon actions proposed for consideration by the commis-
5 sion.

6 Sec. 41.45.080. POWERS. The commission may

7 (1) classify state and federal land within a common manage-
8 ment area;

9 (2) enter into common management agreements with private
10 landowners and municipal corporations;

11 (3) enter into agreements with agencies of the state and
12 federal government to implement the work of the commission;

13 (4) employ staff and consultants as necessary to perform the
14 duties established in this chapter.

15 Sec. 41.45.090. LAND MANAGEMENT IN COMMON MANAGEMENT AREAS. The
16 agency responsible under law for the management of that land included
17 within a common management area shall retain that authority but shall be
18 subject to the authority of the commission to classify land according to
19 its beneficial uses.

20 Sec. 41.45.100. PROPERTY TAX EXEMPTION. If a private landowner,
21 including, but not limited to, any entity established under the Alaska
22 Native Claims Settlement Act, enters into an agreement by which the
23 commission classifies land owned or selected by the private landowner,
24 for a minimum of five years, that land shall be exempt from any property
25 tax or special assessment for capital improvements on the land during
26 the time it is managed by the commission. If the land is withdrawn from
27 the common management area before the minimum five-year period, then all
28 property taxes or special assessments for capital improvements on the
29 land which would otherwise have been payable shall be due at the time

1 the land is withdrawn.

2 Sec. 41.45.110. TECHNICAL ASSISTANCE. With respect to land which
3 is the subject of a cooperative management agreement, state agencies may
4 provide technical and other assistance in fire suppression, trespass
5 control, and mineral exploration. This assistance may be provided
6 without compensation if the agency determines that to do so would foster
7 the intent of cooperative management and the public good.

8 Sec. 41.45.120. HEARINGS. The commission or, on the authorization
9 of the majority of its members, any subcommittee or member of the com-
10 mission may, for the purpose of carrying out the provisions of this
11 chapter, hold hearings, receive testimony and evidence, and sit and act
12 at those times and places as the commission or subcommittee determines.
13 Hearings shall be held, insofar as practicable, in communities and areas
14 which are to be affected.

15 Sec. 41.45.130. MEETINGS. All commission meetings shall be public
16 and notice of a meeting shall be given at least 15 days before the date
17 when the meeting is to take place.

18 Sec. 41.45.140. ANNUAL REPORT. On or before January 10 of each
19 year, the commission shall submit to the President of the United States,
20 Congress, the governor and the legislature a written report with respect
21 to its activities during the preceding calendar year. The report shall
22 also include the activities that the commission contemplates over the
23 next calendar year, and the amount of funding required.

24 Sec. 41.45.150. LAND FOR INCLUSION WITHIN COMMON MANAGEMENT AREAS.
25 (a) The commission shall establish a process to provide for the identi-
26 fication and submission of recommendations concerning areas in federal
27 and state ownership for inclusion in common management areas. Land
28 designated for inclusion within common management areas shall be submit-
29 ted by the commission to Congress and the legislature. A recommendation

1 which includes state land shall be presented to the legislature during
2 the first 10 days of any regular session. The recommendation shall
3 become effective at the adjournment of the session unless disapproved,
4 in whole or in part, by a resolution concurred in by a majority of the
5 members of each house of the legislature.

6 (b) Classification of state land within a common management area
7 supersedes the authority of the director of the division of lands to
8 classify the land under AS 38.05.300.

9 (c) The state may withdraw any portion of state land in a "common
10 management area" with six months notice to the commission.

11 Sec. 41.45.160. VETO. With respect to all state land subject to
12 this chapter, the governor may veto a decision of the commission, within
13 45 days of the action of the commission.

14 Sec. 41.45.170. EXECUTIVE COORDINATION COMMITTEE. There is estab-
15 lished an Executive Coordination Committee composed of the commissioners
16 of natural resources, fish and game, transportation and public facili-
17 ties, environmental conservation, commerce and economic development,
18 revenue, community and regional affairs, or their designees, and the
19 state co-chairman of the Alaska Land Commission. The committee shall
20 meet regularly in order to coordinate those programs and functions of
21 their departments which could affect the administration of state and
22 federal public land. The governor shall designate the chairman of the
23 committee.

24 Sec. 41.45.180. PRINCIPAL OFFICE. The principal office of the
25 commission shall be located in Alaska.

26 Sec. 41.45.190. FUNDING. The state shall pay 50 per cent of the
27 costs and other expenses incurred by the commission in any one fiscal
28 year.

29 Sec. 41.45.200. EXPIRATION OF THE COMMISSION. (a) On or before

1 the ninth anniversary of the effective date of this Act, the governor
2 shall present to the legislature a report on the desirability of con-
3 tinued state participation in the commission.

4 (b) State participation in the commission shall terminate on the
5 tenth anniversary of the effective date of this Act, unless otherwise
6 provided by law.

7 Sec. 41.45.210. JUDICIAL REVIEW. A person aggrieved by a decision
8 of the commission in any determination involving state land subject to
9 the provisions of this chapter may seek review of the decision in the
10 superior court.

11 * Sec. 2. AS 39.23.060 is amended to read:

12 Sec. 39.23.060. REVIEW OF COMPENSATION AND BENEFITS; OFFICERS
13 COVERED. The commission shall conduct an on-going review of compensa-
14 tion and retirement benefits for members of the legislature; the gover-
15 nor; the lieutenant governor; commissioners, deputy commissioners, and
16 division directors of each executive department; members of the Alaska
17 Public Utilities Commission; members of the Alaska Pipeline Commission;
18 members of the Alaska Transportation Commission; members of the Alaska
19 Commercial Fisheries Entry Commission; state members of the Alaska Land
20 Commission; and the judiciary, to determine the appropriateness of
21 compensation and benefits.

22 * Sec. 3. AS 41.40.070 is amended to read:

23 Sec. 41.40.070. TERMINATION OF THE COMMISSION. The commission
24 ceases to exist 120 days after the establishment of the Alaska Land
25 Commission or on April 30, 1981, whichever comes first [ON JUNE 30,
26 1979].

27 * Sec. 4. FEDERAL MEMBERSHIP ON THE COMMISSION. Section 1 of this Act
28 contemplates the authorization by Congress of legislation complementing the
29 provisions of this Act. It is the intent of the legislature that Congress

1 provide for the designation of three representatives to serve as members of
2 the Alaska Land Commission.

3 * Sec. 5. Sections 1, 2, and 4 of this Act take effect on the effective
4 date of legislation enacted by the Congress of the United States providing
5 for the establishment of an Alaska Land Commission and containing provisions
6 which are not in conflict with the provisions of this Act, if such legisla-
7 tion is passed by congress before January 1, 1981.
