5 A BILL

6 For an Act entitled: "An Act making supplemental appropriations to the
7 Office of the Governor, telecommunications; the legis-
8 lative finance division; the Department of Commerce and
9 Economic Development, division of business loans; the
10 Legislative Affairs Agency; and the Alaska State
11 Council on the Arts; and providing for an effective
12 date."

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

14 * Section 1. The sum of \$235,000 is appropriated from the general fund to
15 the Office of the Governor, telecommunications, for participation in intra-
16 state tariff hearings and rate separation hearings.

17 * Sec. 2. The sum of \$34,000 is appropriated from the general fund to the
18 legislative finance division for the fiscal year ending June 30, 1978 to
19 defray the expenses of that division.

20 * Sec. 3. The sum of \$84,100 is appropriated from the general fund to the
21 Department of Commerce and Economic Development, division of business loans,
22 for processing of loan applications during the fiscal year ending June 30,
23 1978.

24 * Sec. 4. The sum of \$31,000 is appropriated to the Legislative Affairs
25 Agency for the following purposes:

26 (1) \$22,500 for miscellaneous expenses relating to the work of the
27 Senate Special Committee to Consider Royalty Oil Sales Proposals;

28 (2) \$8,500 for miscellaneous expenses relating to the work of the
29 House Special Committee on the Sale of Royalty Oil and Gas.

1 * Sec. 5. The sum of \$42,000 is appropriated from the general fund to the
2 Legislative Affairs Agency to defray the expenses of the Senate Special
3 Committee on the Revision of AS 4 (Alcoholic Beverages) during the current
4 legislative session and the expenses of the Interim Committee of the Legisla-
5 tive Council on Revision of AS 4 (Alcoholic Beverages), as provided for in
6 Senate Concurrent Resolution 88.

7 * Sec. 6. The sum of \$31,270 is appropriated from the general fund to the
8 Alaska State Council on the Arts for the following purposes:

9 (1) \$8,570 for payment as a grant to the Arctic Chamber Orchestra
10 for unfunded orchestra statewide tour expenses;

11 (2) \$2,700 for payment as a grant to the Anchorage Youth Symphony
12 Association, to meet unfunded expenses of its Southeastern Alaska tour;

13 (3) \$20,000 for payment as a grant to the Choir of the North,
14 University of Alaska.

15 * Sec. 7. This Act takes effect immediately in accordance with AS 01.10.-
16 070(c).
