6 For an Act entitled: "An Act making supplemental appropriations to the
7 Department of Health and Social Services, Medicaid
8 miscellaneous, general relief medical, and handi-
9 capped children; and providing for an effective
10 date."

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

12 * Section 1. The sum of \$465,902 is appropriated to the Department of
13 Health and Social Services for Medicaid FY 77 and FY 78 hospital miscella-
14 neous expenditures. Sources of this appropriation are as follows:

15	Federal Funds	\$232,951
16	General Fund	232,951

17 * Sec. 2. The sum of \$246,300 is appropriated to the Department of
18 Health and Social Services for Medicaid FY 78 physician services. Sources
19 of this appropriation are as follows:

20	Federal Funds	\$123,100
21	General Fund	123,200

22 * Sec. 3. The sum of \$8,600 is appropriated from federal funds to the
23 Department of Health and Social Services for FY 78 miscellaneous Medicaid
24 services.

25 * Sec. 4. The sum of \$31,900 is appropriated to the Department of
26 Health and Social Services for the FY 78 Medicaid Early Screening Program.
27 Sources of this appropriation are as follows:

28	Federal Funds	\$ 16,000
29	General Fund	15,900

1 * Sec. 5. The sum of \$489,200 is appropriated to the Department of
2 Health and Social Services for FY 78 Medicaid nursing home services.

3 Sources of this appropriation are as follows:

4 Federal Fund \$244,600

5 General Fund 244,600

6 * Sec. 6. The sum of \$1,764,700 is appropriated to the Department of
7 Health and Social Services for FY 77 and FY 78 miscellaneous general relief
8 medical expenditures. Sources of this appropriation are as follows:

9 Federal Funds \$1,327,135

10 General Fund 437,565

11 * Sec. 7. The sum of \$92,100 is appropriated to the Department of
12 Health and Social Services for the FY 78 Handicapped Children's Program.

13 Sources of this appropriation are as follows:

14 Federal Funds \$53,600

15 General Fund 38,500
