6 For an Act entitled: "An Act revising the criminal laws of the state;
7 changing Rule 35 of the Alaska Supreme Court's Rules
8 of Criminal Procedure; and providing for an effective
9 date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 * Section 1. AS 11 is amended by adding a new chapter to read:

12 CHAPTER 16. PARTIES TO CRIME.

13 Sec. 11.16.100. LEGAL ACCOUNTABILITY BASED UPON CONDUCT. A person
14 is guilty of an offense if it is committed by his own conduct or by the
15 conduct of another person for which he is legally accountable under sec.
16 110 of this chapter, or by both.

17 Sec. 11.16.110. LEGAL ACCOUNTABILITY BASED UPON THE CONDUCT OF
18 ANOTHER: COMPLICITY. A person is legally accountable for the conduct
19 of another person constituting an offense if

20 (1) he is made legally accountable by a provision of law
21 defining the offense;

22 (2) with intent to promote or facilitate the commission of
23 the offense,

24 (A) he solicits the other person to commit the offense;

25 or

26 (B) he aids or abets the other person in planning or
27 committing the offense; or

28 (3) acting with the culpable mental state that is sufficient
29 for the commission of the offense, he causes an innocent person or a

1 person who lacks criminal responsibility to engage in the proscribed
2 conduct.

3 Sec. 11.16.120. EXEMPTIONS TO LEGAL ACCOUNTABILITY FOR CONDUCT OF
4 ANOTHER. (a) In a prosecution for an offense in which legal accoun-
5 tability is based on the conduct of another person,

6 (1) it is an affirmative defense that the defendant, under
7 circumstances manifesting a voluntary and complete renunciation of his
8 criminal intent,

9 (A) terminated his complicity before the commission of
10 the offense;

11 (B) wholly deprived his complicity of its effectiveness
12 in the commission of the offense; and

13 (C) gave timely warning to law enforcement authorities
14 or, if timely warning could not be given to law enforcement autho-
15 rities by reasonable efforts, otherwise made a reasonable effort to
16 prevent the commission of the offense;

17 (2) it is not a defense that

18 (A) the other person has not been prosecuted for or
19 convicted of an offense based upon the conduct in question or has
20 been convicted of a different offense or degree of offense;

21 (B) the offense, as defined, can be committed only by a
22 particular class of persons to which the defendant does not belong,
23 and he is for that reason legally incapable of committing the
24 offense in an individual capacity; or

25 (C) the other person is not guilty of the offense.

26 (b) Except as otherwise provided by a provision of law defining an
27 offense, a person is not legally accountable for the conduct of another
28 constituting an offense if

29 (1) he is the victim of the offense; or

1 (2) the offense is so defined that his conduct is inevitably
2 incidental to its commission.

3 Sec. 11.16.130. LEGAL ACCOUNTABILITY OF ORGANIZATIONS. (a)
4 Except as otherwise expressly provided, an organization is legally
5 accountable for conduct constituting an offense if the conduct

6 (1) is the conduct of its agent and

7 (A) within the scope of his employment and in behalf of
8 the organization; or

9 (B) is solicited, subsequently ratified, or subsequently
10 adopted by the organization; or

11 (2) consists of an omission to discharge a specific duty of
12 affirmative performance imposed on organizations by law.

13 (b) In this section "agent" means a director, officer, or employee
14 of an organization or any other person who is authorized to act in
15 behalf of the organization.

16 * Sec. 2. AS 11 is amended by adding a new chapter to read:

17 CHAPTER 31. ATTEMPT AND SOLICITATION.

18 Sec. 11.31.100. ATTEMPT. (a) A person is guilty of an attempt to
19 commit a crime if, with intent to commit a crime, he engages in conduct
20 which constitutes a substantial step toward the commission of that
21 crime.

22 (b) In a prosecution under this section, it is not a defense that
23 it was factually or legally impossible to commit the crime which was the
24 object of the attempt if the conduct engaged in by the defendant would
25 be a crime had the circumstances been as he believed them to be.

26 (c) In a prosecution under this section, it is an affirmative
27 defense that the defendant, under circumstances manifesting a voluntary
28 and complete renunciation of his criminal intent, prevented the commis-
29 sion of the attempted crime.

1 (d) An attempt is a

2 (1) class A felony if the crime attempted is murder in any
3 degree or kidnapping;

4 (2) class B felony if the crime attempted is a class A
5 felony;

6 (3) class C felony if the crime attempted is a class B
7 felony;

8 (4) class A misdemeanor if the crime attempted is a class C
9 felony;

10 (5) class B misdemeanor if the crime attempted is a class A
11 or class B misdemeanor.

12 Sec. 11.31.110. SOLICITATION. (a) A person commits the crime of
13 solicitation if, with intent to cause another to engage in conduct
14 constituting a crime, he solicits the other person to engage in that
15 conduct.

16 (b) In a prosecution under this section,

17 (1) it is not a defense

18 (A) that the defendant belongs to a class of persons who
19 by definition are legally incapable in an individual capacity of
20 committing the crime that is the object of the solicitation; or

21 (B) that a person whom the defendant solicits could not
22 be guilty of the crime that is the object of the solicitation;

23 (2) it is an affirmative defense that the defendant, under
24 circumstances manifesting a voluntary and complete renunciation of his
25 criminal intent, after soliciting another person to engage in conduct
26 constituting a crime, prevented the commission of the crime.

27 (c) Solicitation is a

28 (1) class A felony if the crime solicited is murder in any
29 degree or kidnapping;

1 (2) class B felony if the crime solicited is a class A
2 felony;

3 (3) class C felony if the crime solicited is a class B
4 felony;

5 (4) class A misdemeanor if the crime solicited is a class C
6 felony;

7 (5) class B misdemeanor if the crime solicited is a class A
8 or class B misdemeanor.

9 Sec. 11.31.140. MULTIPLE CONVICTIONS BARRED. (a) It is not a
10 defense to a prosecution under sec. 100 or 110 of this chapter that the
11 crime that is the object of the attempt or solicitation was actually
12 committed pursuant to the attempt or solicitation.

13 (b) A person may not be convicted of more than one crime defined
14 by sec. 100 or 110 of this chapter for conduct designed to commit or
15 culminate in commission of the same crime.

16 (c) A person may not be convicted on the basis of the same course
17 of conduct of both (1) a crime defined by sec. 100 or 110 of this chap-
18 ter; and (2) the crime that is the object of the attempt or sollicita-
19 tion.

20 (d) This section does not bar inclusion of multiple counts in a
21 single indictment or information charging commission of a crime defined
22 by sec. 100 or 110 of this chapter and commission of the crime that is
23 the object of the attempt or solicitation.

24 Sec. 11.31.150. SUBSTANTIVE CRIMES INVOLVING ATTEMPT OR SOLICITATION. Notwithstanding sec. 140(d) of this chapter,

25 (1) a person may not be charged under sec. 100 of this chap-
26 ter if the crime allegedly attempted by the defendant is defined in such
27 a way that an attempt to engage in the proscribed conduct constitutes
28 commission of the crime itself;
29

1 (2) a person may not be charged under sec. 110 of this chap-
2 ter if the solicitation in question is defined as a specific crime under
3 other provisions of law.

4 * Sec. 3. AS 11 is amended by adding a new chapter to read:

5 CHAPTER 41. OFFENSES AGAINST THE PERSON.

6 ARTICLE 1. HOMICIDE.

7 Sec. 11.41.100. MURDER IN THE FIRST DEGREE. (a) A person commits
8 the crime of murder in the first degree if, with intent to cause the
9 death of another person, he

10 (1) causes the death of any person; or

11 (2) compels or induces any person to commit suicide through
12 duress or deception.

13 (b) Murder in the first degree is an unclassified felony and is
14 punishable as provided in AS 12.55.

15 Sec. 11.41.110. MURDER IN THE SECOND DEGREE. (a) A person com-
16 mits the crime of murder in the second degree if

17 (1) with intent to cause serious physical injury to another
18 person or knowing that his conduct is substantially certain to cause
19 death or serious physical injury to another person, he causes the death
20 of any person;

21 (2) he intentionally performs an act that results in the
22 death of another person under circumstances manifesting an extreme
23 indifference to the value of human life; or

24 (3) acting either alone or with one or more persons, he com-
25 mits or attempts to commit arson in the first degree, kidnapping, sexual
26 assault in the first degree under sec. 410(a)(1) or (2) of this chapter,
27 sexual assault in the second degree, burglary in the first degree,
28 escape in the first or second degree, or robbery in any degree and, in
29 the course of or in furtherance of that crime, or in immediate flight

1 from that crime, any person causes the death of a person other than one
2 of the participants.

3 (b) Murder in the second degree is an unclassified felony and is
4 punishable as provided in AS 12.55.

5 Sec. 11.41.115. DEFENSES TO MURDER. (a) In a prosecution under
6 sec. 100(a)(1) or 110(a)(1) of this chapter, it is a defense that the
7 defendant acted in a heat of passion, before there had been a reasonable
8 opportunity for the passion to cool, when the heat of passion resulted
9 from a serious provocation by the intended victim.

10 (b) In a prosecution under sec. 110(a)(3) of this chapter, it is
11 an affirmative defense that the defendant

12 (1) did not commit the homicidal act or in any way solicit or
13 aid in its commission;

14 (2) was not armed with a dangerous instrument;

15 (3) had no reasonable ground to believe that another parti-
16 cipant, if any, was armed with a dangerous instrument; and

17 (4) had no reasonable ground to believe that another partici-
18 pant, if any, intended to engage in conduct likely to result in death or
19 serious physical injury.

20 (c) A person may not be convicted of murder in the second degree
21 under sec. 110(a)(3) of this chapter if the only underlying crime is
22 burglary, the sole purpose of the burglary is a criminal homicide, and
23 the person killed is the intended victim of the defendant. However, if
24 the defendant causes the death of any other person, the defendant may be
25 convicted of murder in the second degree under sec. 110(a)(3) of this
26 chapter. Nothing in this subsection precludes a prosecution for or
27 conviction of murder in the first degree or murder in the second degree
28 under sec. 110(a)(1) or (2) of this chapter or of any other crime, in-
29 cluding manslaughter or burglary.

1 (d) In a prosecution under sec. 100(a)(1) or 110(a)(1) of this
2 chapter, it is an affirmative defense that, at the time of the homicidal
3 act, the defendant honestly but unreasonably believed that the circum-
4 stances were such that, had they been as he believed them to be, they
5 would have constituted a justification for the killing under AS
6 11.81.300 - 11.81.430.

7 (e) Nothing in (a), (b), or (d) of this section precludes a pro-
8 secution for or conviction of manslaughter or any other crime not speci-
9 fically precluded.

10 (f) In this section,

11 (1) "intended victim" means a person whom the defendant was
12 attempting to kill or to whom the defendant was attempting to cause
13 serious physical injury when he caused the death of the person he is
14 charged with killing;

15 (2) "serious provocation" means conduct which is sufficient
16 to excite an intense passion in a reasonable person in the defendant's
17 situation, other than a person who is intoxicated, under the circum-
18 stances as he reasonably believed them to be; insulting words, insulting
19 gestures, or hearsay reports of conduct engaged in by the intended
20 victim do not, alone or in combination with each other, constitute
21 serious provocation.

22 Sec. 11.41.120. MANSLAUGHTER. (a) A person commits the crime of
23 manslaughter if he

24 (1) intentionally, knowingly, or recklessly causes the death
25 of another person under circumstances not amounting to murder in the
26 first or second degree; or

27 (2) intentionally aids another person to commit suicide.

28 (b) Manslaughter is a class A felony.

29 Sec. 11.41.130. CRIMINALLY NEGLIGENT HOMICIDE. (a) A person

1 commits the crime of criminally negligent homicide if, with criminal
2 negligence, he causes the death of another person.

3 (b) Criminally negligent homicide is a class C felony.

4 Sec. 11.41.140. DEFINITION. As used in secs. 100 - 140 of this
5 chapter, "person", when referring to the victim of a crime, means a
6 human being who has been born and was alive at the time of the criminal
7 act. A person is "alive" if he has spontaneous respiratory or cardiac
8 function or, when respiratory and cardiac functions are maintained by
9 artificial means, he has spontaneous brain function.

10 ARTICLE 2. ASSAULT AND RECKLESS ENDANGERMENT.

11 Sec. 11.41.200. ASSAULT IN THE FIRST DEGREE. (a) A person com-
12 mits the crime of assault in the first degree if

13 (1) with intent to cause serious physical injury to another
14 person, he causes physical injury to any person by means of a dangerous
15 instrument;

16 (2) with intent to cause serious physical injury to another
17 person, he causes serious physical injury to any person; or

18 (3) he intentionally performs an act that results in serious
19 physical injury to another person under circumstances manifesting ex-
20 tremeness of indifference to the value of human life.

21 (b) Assault in the first degree is a class A felony.

22 Sec. 11.41.210. ASSAULT IN THE SECOND DEGREE. (a) A person
23 commits the crime of assault in the second degree if

24 (1) with intent to cause physical injury to another person,
25 he causes serious physical injury to any person;

26 (2) he intentionally places another person in fear of immi-
27 nent serious physical injury by means of a dangerous instrument; or

28 (3) he recklessly causes serious physical injury to another
29 person by means of a dangerous instrument.

1 (b) Assault in the second degree is a class B felony.

2 Sec. 11.41.230. ASSAULT IN THE THIRD DEGREE. (a) A person com-
3 mits the crime of assault in the third degree if

4 (1) he intentionally or recklessly causes physical injury to
5 another person;

6 (2) with criminal negligence he causes physical injury to
7 another person by means of a dangerous instrument; or

8 (3) by words or other conduct he intentionally places another
9 person in fear of imminent physical injury.

10 (b) Assault in the third degree is a class A misdemeanor.

11 Sec. 11.41.250. RECKLESS ENDANGERMENT. (a) A person commits the
12 crime of reckless endangerment if he recklessly engages in conduct which
13 creates a substantial risk of serious physical injury to another person.

14 (b) Reckless endangerment is a class A misdemeanor.

15 ARTICLE 3. KIDNAPPING AND CUSTODIAL INTERFERENCE.

16 Sec. 11.41.300. KIDNAPPING. (a) A person commits the crime of
17 kidnapping if

18 (1) he restrains another person with intent to

19 (A) hold him for ransom, reward, or other payment;

20 (B) use him as a shield or hostage;

21 (C) inflict physical injury upon him or place him or a
22 third person in apprehension that any person will be subjected to
23 serious physical injury;

24 (D) interfere with the performance of a governmental or
25 political function; or

26 (E) facilitate the commission of a felony or flight
27 after commission of a felony; or

28 (2) he restrains another person

29 (A) by secreting and holding him in a place where he is

1 not likely to be found; or

2 (B) under circumstances which expose him to a substantial
3 risk of serious physical injury.

4 (b) In a prosecution under (a)(2)(A) of this section, it is an
5 affirmative defense that

6 (1) the defendant was a relative of the victim;

7 (2) the victim was a child under 18 years of age or an incom-
8 petent person; and

9 (3) the primary intent of the defendant was to assume custody
10 of the victim.

11 (c) Except as provided in (d) of this section, kidnapping is an
12 unclassified felony and is punishable as provided in AS 12.55.

13 (d) In a prosecution for kidnapping, it is an affirmative defense
14 which reduces the crime to a class A felony that the defendant volun-
15 tarily caused the release of the victim alive in a safe place before
16 arrest, or within 24 hours after arrest, without having caused serious
17 physical injury to the victim and without having engaged in conduct
18 described in sec. 410(a)(1) or (2) or 420 of this chapter.

19 Sec. 11.41.320. CUSTODIAL INTERFERENCE IN THE FIRST DEGREE. (a)
20 A person commits the crime of custodial interference in the first degree
21 if he violates sec. 330 of this chapter and causes the victim to be
22 removed from the state.

23 (b) Custodial interference in the first degree is a class C
24 felony.

25 Sec. 11.41.330. CUSTODIAL INTERFERENCE IN THE SECOND DEGREE. (a)
26 A person commits the crime of custodial interference in the second
27 degree if, being a relative of a child under 18 years of age or a rela-
28 tive of an incompetent person and knowing that he has no legal right to
29 do so, he takes, entices, or keeps that child or incompetent person from

1 his lawful custodian with intent to hold him for a protracted period.

2 (b) Custodial interference in the second degree is a class A
3 misdemeanor.

4 Sec. 11.41.370. DEFINITIONS. In secs. 300 - 370 of this chapter,
5 unless the context requires otherwise,

6 (1) "lawful custodian" means a parent, guardian, or other
7 person responsible by authority of law for the care, custody, or control
8 of another;

9 (2) "relative" means a parent, stepparent, ancestor, descen-
10 dant, sibling, uncle, or aunt, including a relative of the same degree
11 through marriage or adoption;

12 (3) "restrain" means to restrict a person's movements unlaw-
13 fully and without consent, so as to interfere substantially with his
14 liberty by moving him from one place to another or by confining him
15 either in the place where the restriction commences or in a place to
16 which he has been moved; a restraint is "without consent" if it is
17 accomplished

18 (A) by acquiescence of the victim, if the victim is
19 under 16 years of age or is an incompetent person and his lawful
20 custodian has not acquiesced in the movement or confinement; or

21 (B) by force, threat, or deception.

22 ARTICLE 4. SEXUAL OFFENSES.

23 Sec. 11.41.410. SEXUAL ASSAULT IN THE FIRST DEGREE. (a) A person
24 commits the crime of sexual assault in the first degree if,

25 (1) being any age, he engages in sexual penetration with
26 another person without consent of that person;

27 (2) being any age, he attempts to engage in sexual penetra-
28 tion with another person without consent of that person and causes
29 serious physical injury to that person;

1 (3) being 16 years of age or older, he engages in sexual
2 penetration with another person under 13 years of age; or

3 (4) being 18 years of age or older, he engages in sexual
4 penetration with another person who is under 18 years of age and who

5 (A) is entrusted to his care by authority of law; or

6 (B) is his son or daughter, whether adopted, illegiti-
7 mate, or stepchild.

8 (b) Sexual assault in the first degree is a class A felony.

9 Sec. 11.41.420. SEXUAL ASSAULT IN THE SECOND DEGREE. (a) A
10 person commits the crime of sexual assault in the second degree if he
11 coerces another person to engage in sexual contact by the express or
12 implied threat of imminent death, imminent physical injury, or imminent
13 kidnapping to be inflicted on anyone or by causing physical injury to
14 any person, regardless of whether the victim resists.

15 (b) Sexual assault in the second degree is a class B felony.

16 Sec. 11.41.430. SEXUAL ASSAULT IN THE THIRD DEGREE. (a) A person
17 commits the crime of sexual assault in the third degree if he engages in
18 sexual penetration with a person who he knows

19 (1) is suffering from a mental disorder or defect which
20 renders him incapable of appraising the nature of the conduct under cir-
21 cumstances in which a person who is capable of appraising the nature of
22 the conduct would not engage in sexual penetration; or

23 (2) is incapacitated.

24 (b) Sexual assault in the third degree is a class C felony.

25 Sec. 11.41.440. SEXUAL ABUSE OF A MINOR. (a) A person commits
26 the crime of sexual abuse of a minor if, being 16 years of age or older,
27 he engages in

28 (1) sexual penetration with a person who is under 16 years of
29 age but 13 years of age or older; or

1 (2) sexual contact with a person who is under 13 years of
2 age.

3 (b) Sexual abuse of a minor is a class C felony.

4 Sec. 11.41.445. GENERAL PROVISIONS. (a) In a prosecution under
5 secs. 410 - 440 of this chapter, it is an affirmative defense that, at
6 the time of the alleged offense, the victim was the legal spouse of the
7 defendant unless

8 (1) the spouses were living apart; or

9 (2) the defendant caused physical injury to the victim.

10 (b) In a prosecution under secs. 410 - 440 of this chapter, when-
11 ever a provision of law defining an offense depends upon a victim's
12 being under a certain age, it is an affirmative defense that, at the
13 time of the alleged offense, the defendant reasonably believed the
14 victim to be that age or older, unless the victim was under 13 years of
15 age at the time of the alleged offense.

16 Sec. 11.41.450. INCEST. (a) A person commits the crime of incest
17 if, being 18 years of age or older, he engages in sexual penetration
18 with a person who is related to him, either legitimately or illegiti-
19 mately, as

20 (1) his ancestor or descendant of the whole or half blood;

21 (2) his brother or sister of the whole or half blood; or

22 (3) his uncle, aunt, nephew, or niece by blood.

23 (b) Incest is a class C felony.

24 Sec. 11.41.455. UNLAWFUL EXPLOITATION OF A MINOR. (a) A person
25 commits the crime of unlawful exploitation of a minor if, in this state
26 and with the intent of producing for any commercial purpose a live per-
27 formance, film, photograph, negative, slide, book, newspaper, or maga-
28 zine that depicts such conduct, he knowingly induces or employs a child
29 under 16 years of age to engage in, or photographs, films, or televises

1 a child under 16 years of age engaged in

2 (1) sexual penetration;

3 (2) the obscene touching of another person's genitals, anus,
4 or female breast;

5 (3) the obscene touching by another person of the child's
6 genitals, anus, or female breast;

7 (4) masturbation;

8 (5) bestiality; or

9 (6) the obscene exhibition of the child's genitals.

10 (b) Unlawful exploitation of a minor is a class B felony.

11 Sec. 11.41.470. DEFINITIONS. For purposes of secs. 410 - 470 of
12 this chapter, unless the context requires otherwise,

13 (1) "incapacitated" means that a person is temporarily in-
14 capable of appraising the nature of his conduct and is physically unable
15 to express unwillingness to act;

16 (2) "victim" means the person alleged to have been subjected
17 to sexual assault in any degree or sexual abuse of a minor;

18 (3) "without consent" means that a person

19 (A) with or without resisting, is coerced by the use of
20 force against a person or property, or by the express or implied
21 threat of imminent death, imminent physical injury, or imminent
22 kidnaping to be inflicted on anyone; or

23 (B) is incapacitated as a result of an act of the de-
24 fendant.

25 ARTICLE 5. ROBBERY, EXTORTION, AND COERCION.

26 Sec. 11.41.500. ROBBERY IN THE FIRST DEGREE. (a) A person com-
27 mits the crime of robbery in the first degree if he violates sec. 510 of
28 this chapter and, in the course of violating that section or in immedi-
29 ate flight thereafter, he or another participant

1 (1) is armed with a deadly weapon or represents by words or
2 other conduct that he or another participant is so armed;

3 (2) uses or attempts to use a dangerous instrument or repre-
4 sents by words or other conduct that he or another participant is armed
5 with a dangerous instrument; or

6 (3) causes or attempts to cause serious physical injury to
7 any person.

8 (b) Robbery in the first degree is a class A felony.

9 Sec. 11.41.510. ROBBERY IN THE SECOND DEGREE. (a) A person
10 commits the crime of robbery in the second degree if, in the course of
11 taking or attempting to take property from the immediate presence and
12 control of a person, he uses or threatens the immediate use of force
13 upon any person with intent to

14 (1) prevent or overcome resistance to his taking the property
15 or his retention of the property after taking; or

16 (2) compel any person to deliver the property or engage in
17 other conduct which might aid in the taking of the property.

18 (b) Robbery in the second degree is a class B felony.

19 Sec. 11.41.520. EXTORTION. (a) A person commits the crime of
20 extortion if he obtains the property of another by threatening or sug-
21 gesting that he or another may

22 (1) inflict physical injury on anyone, except under circum-
23 stances constituting robbery in any degree, or commit any other crime;

24 (2) accuse anyone of a crime;

25 (3) expose confidential information or a secret, whether true
26 or false, tending to subject a person to hatred, contempt, or ridicule
27 or to impair his credit or business repute;

28 (4) take or withhold action as a public servant or cause a
29 public servant to take or withhold action;

1 (5) bring about or continue a strike, boycott, or other col-
2 lective unofficial action, if the property is not demanded or received
3 for the benefit of the group in whose interest the person making the
4 threat or suggestion purports to act;

5 (6) testify or provide information or withhold testimony or
6 information with respect to a person's legal claim or defense; or

7 (7) inflict any other harm which would not benefit the person
8 making the threat or suggestion.

9 (b) A threat or suggestion to perform any of the acts described in
10 (a) of this section includes an offer to protect another from any harm-
11 ful act when the offeror has no apparent means to provide the protection
12 or when the price asked for rendering the protection service is grossly

Sec. 11.46.410. ARSON IN THE SECOND DEGREE. (a) A person commits the crime of arson in the second degree if he intentionally damages a building by starting a fire or causing an explosion.

(b) In a prosecution under this section, it is an affirmative defense

(1) that no person other than the defendant had a possessory, proprietary, or security interest in the building or that all persons having such an interest consented to the defendant's conduct; and

(2) that the sole intent of the defendant was to damage or destroy the building for a lawful purpose.

(c) Arson in the second degree is a class B felony.

Sec. 11.46.430. CRIMINALLY NEGLIGENT BURNING. (a) A person commits the crime of criminally negligent burning if with criminal negligence he damages property of another by fire or explosion.

(b) Criminally negligent burning is a class A misdemeanor.

Sec. 11.46.450. FAILURE TO CONTROL OR REPORT A DANGEROUS FIRE.

(a) A person commits the crime of failure to control or report a dangerous fire if he knows that a fire is endangering life or a substantial amount of property of another and fails to take reasonable measures to

1 put out or control the fire, when he can do so without substantial risk
2 to himself, or to give a prompt fire alarm if

3 (1) he knows that he is under an official, contractual, or
4 other legal duty to prevent or combat the fire; or

5 (2) the fire was started by him, with his consent, or on

5 (2) knowingly possesses a forged instrument; or

6 (3) knowingly utters a forged instrument.

7 (b) Forgery in the third degree is a class A misdemeanor.

8 Sec. 11.46.520. CRIMINAL POSSESSION OF A FORGERY DEVICE. (a) A
9 person commits the crime of criminal possession of a forgery device if,
10 with intent to use it or aid another to use it for purposes of forgery,

11 (1) he makes or possesses a plate, die, or other device,
12 apparatus, equipment, or article specifically designed for use in forg-
13 ing written instruments; or

6 labeling prescribed by law or, if none, as set by established

9 though otherwise labeled accurately as to quality and quantity.

10 (c) Deceptive business practices is a class A misdemeanor.

11 Sec. 11.46.720. MISREPRESENTATION OF USE OF A PROPELLED VEHICLE.

12 (a) A person commits the crime of misrepresentation of use of a pro-
13 pelled vehicle if, with intent to deceive any person, he sells, leases,
14 or offers or exposes for sale or lease a propelled vehicle knowing that
15 a usage registering device on the vehicle has been disconnected, ad-
16 justed, or replaced so as to misrepresent the distance traveled by the
17 vehicle or the hours of engine use.

18 (b) As used in this section, "usage registering device" means any
19 odometer, speedometer, recording tachometer, hobbsmeter, or other in-
20 strument that registers the distance traveled by the vehicle or the

22 (c) Misrepresentation of use of a propelled vehicle is a class A

1 (B) destroys, removes, conceals, encumbers, transfers,

29 (b) Contributing to the delinquency of a minor is a class A misde-

1 meanor.

2 Sec. 11.51.140. UNLAWFUL MARRYING. (a) A person commits the
3 crime of unlawful marrying if he knowingly marries or purports to marry

4 (1) another person when he or the other person is lawfully
5 married to a third person;

6 (2) more than one person simultaneously; or

7 (3) a person who simultaneously is marrying another person.

8 (b) Unlawful marrying is a class A misdemeanor.

9 * Sec. 6. AS 11 is amended by adding a new chapter to read:

10 CHAPTER 56. OFFENSES AGAINST PUBLIC ADMINISTRATION.

11 ARTICLE 1. BRIBERY AND RELATED OFFENSES.

27 (2) accepts or agrees to accept a benefit upon an agreement
28 or understanding that his vote, opinion, judgment, action, decision, or

1 (b) Receiving a bribe is a class B felony.

2 Sec. 11.56.120. RECEIVING UNLAWFUL GRATUITIES. (a) A public ser-
3 vant commits the crime of receiving unlawful gratuities if, for having

5 form and for which he was not entitled to any special or additional
6 compensation, he

5 (1) in an application for a benefit; or

6 (2) on a form bearing notice, authorized by law, that false
7 statements made in it are punishable.

8 (b) Unsworn falsification is a class A misdemeanor.

9 Sec. 11.56.220. PROOF OF GUILT. In a prosecution for perjury or
10 unsworn falsification it is not necessary that proof be made by a parti-
11 cular number of witnesses or by documentary or other type of evidence.

12 Sec. 11.56.230. PERJURY BY INCONSISTENT STATEMENTS. (a) A person
13 commits the crime of perjury by inconsistent statements if

14 (1) in the course of one or more official proceedings he

28 (b) Escape in the second degree is a class B felony.

29 Sec. 11.56.320. ESCAPE IN THE THIRD DEGREE. (a) A person commits

1 the crime of escape in the third degree if he removes himself from
2 official detention during any lawful movement or activity incident to
3 confinement within a correctional facility on a charge of a misdemeanor.

4 (b) Escape in the third degree is a class C felony.

5 Sec. 11.56.330. ESCAPE IN THE FOURTH DEGREE. (a) A person com-
6 mits the crime of escape in the fourth degree if, without lawful autho-
7 rity, he removes himself from official detention on a charge of a mis-
8 demeanor or if he violates sec. 340 or 350 of this chapter and leaves or
9 attempts to leave the state.

10 (b) Escape in the fourth degree is a class A misdemeanor.

11 Sec. 11.56.340. UNLAWFUL EVASION IN THE FIRST DEGREE. (a) A
12 person commits the crime of unlawful evasion in the first degree if he
13 fails to return to official detention on a charge of a felony following
14 temporary leave granted for a specific purpose or limited period, in-
15 cluding privileges granted under AS 33.30.150, 33.30.250, or 33.30.260.

16 (b) Unlawful evasion in the first degree is a class A misdemeanor.

17 Sec. 11.56.350. UNLAWFUL EVASION IN THE SECOND DEGREE. (a) A
18 person commits the crime of unlawful evasion in the second degree if he
19 fails to return to official detention on a charge of a misdemeanor
20 following temporary leave granted for a specific purpose or limited
21 period, including privileges granted under AS 33.30.150, 33.30.250, or
22 33.30.260.

23 (b) Unlawful evasion in the second degree is a class B misde-
24 meanor.

25 Sec. 11.56.370. PERMITTING AN ESCAPE. (a) A public servant who
26 is required by law to have charge of a person charged with or convicted
27 of a crime commits the crime of permitting an escape if with criminal
28 negligence he permits a person under official detention to escape.

29 (b) Permitting an escape is a class C felony.

1 Sec. 11.56.375. PROMOTING CONTRABAND IN THE FIRST DEGREE. (a) A
2 person commits the crime of promoting contraband in the first degree if
3 he violates sec. 380 of this chapter and the contraband is

4 (1) a deadly weapon;

5 (2) an article that is intended by the defendant to be used
6 as a means of facilitating an escape; or

7 (3) a controlled substance.

8 (b) Promoting contraband in the first degree is a class C felony.

9 Sec. 11.56.380. PROMOTING CONTRABAND IN THE SECOND DEGREE. (a) A
10 person commits the crime of promoting contraband in the second degree if
11 he

12 (1) introduces, takes, conveys, or attempts to introduce,
13 take, or convey contraband into a correctional facility; or

14 (2) makes, obtains, possesses, or attempts to make, obtain,

14 Sec. 11.56.520. RECEIVING A BRIBE BY A WITNESS OR JUROR. (a) A
15 person commits the crime of receiving a bribe by a witness or juror if
16 he solicits a benefit with the intent that, or accepts or agrees to
17 accept a benefit upon an agreement or understanding that,

18 (1) he will be improperly influenced as a witness; or

19 (2) his vote, decision, opinion, or other action as a juror
20 will be influenced.

21 (b) Receiving a bribe by a witness or juror is a class B felony.

22 Sec. 11.56.540. TAMPERING WITH A WITNESS. (a) A person commits
23 the crime of tampering with a witness if he knowingly induces or at-
24 tempts to induce a witness to

25 (1) testify falsely, offer misleading testimony, or unlaw-
26 fully withhold testimony in an official proceeding; or

27 (2) absent himself from an official proceeding to which he
28 has been summoned.

29 (b) Tampering with a witness is a class A misdemeanor.

1 Sec. 11.56.590. JURY TAMPERING. (a) A person commits the crime
2 of jury tampering if he directly or indirectly communicates with a juror
3 other than as permitted by the rules governing the official proceeding
4 with intent to

5 (1) influence the juror's vote, opinion, decision, or other
6 action as a juror; or

7 (2) otherwise affect the outcome of the official proceeding.

8 (b) Jury tampering is a class C felony.

9 Sec. 11.56.600. MISCONDUCT BY A JUROR. (a) A person commits the
10 crime of misconduct by a juror if, being a juror, he promises or agrees,
11 before the submission of any part of an official proceeding to a jury
12 for deliberation, to vote for or agree to a verdict for or against a
13 party in the official proceeding, or otherwise to affect the outcome of

20 (2) committing any degree of criminal mischief; or

21 (3) any means that creates a substantial risk of physical
22 injury to any person.

23 (b) Resisting or interfering with arrest is a class A misdemeanor.

24 Sec. 11.56.720. REFUSING TO ASSIST A PEACE OFFICER OR JUDICIAL
25 OFFICER. (a) A person commits the offense of refusing to assist a
26 peace officer or judicial officer if, upon a request, command, or order
27 by a person he knows to be a peace officer or judicial officer, he
28 unreasonably fails to make a good faith effort to physically assist that
29 person in the exercise of his official duties.

1 (b) A person who, without expecting compensation, assists a person
2 in accordance with this section is not liable for civil damages as a
3 result of an act or omission in rendering that assistance. This sub-
4 section does not preclude liability for civil damages as a result of
5 reckless, wilful, wanton, or intentional misconduct.

6 (c) Refusing to assist a peace officer or judicial officer is a
7 violation.

8 Sec. 11.56.770. HINDERING PROSECUTION IN THE FIRST DEGREE. (a) A
9 person commits the crime of hindering prosecution in the first degree if
10 he renders assistance to a person who has committed a crime punishable
11 as a felony with intent to

12 (1) hinder the apprehension, prosecution, conviction, or
13 punishment of that person; or

14 (2) assist that person in profiting or benefiting from the
15 commission of the crime.

16 (b) For purposes of this section, a person "renders assistance" to
17 another if he

18 (1) harbors or conceals that person;

19 (2) warns that person of impending discovery or apprehension;

20 (3) provides or aids in providing that person with money,

16 Sec. 11.56.790. COMPOUNDING. (a) A person commits the crime of
17 compounding if, unless authorized by AS 12.45.120 or 12.45.130, he

18 (1) confers, offers to confer, or agrees to confer a benefit
19 on another in consideration of that person's concealing an offense,
20 refraining from initiating or aiding in the prosecution of an offense,
21 or withholding evidence of an offense; or

22 (2) accepts or agrees to accept a benefit in consideration of
23 his concealing an offense, refraining from initiating or aiding in the
24 prosecution of an offense, or withholding evidence of an offense.

25 (b) Compounding is a class A misdemeanor.

26 Sec. 11.56.800. MAKING A FALSE REPORT. (a) A person commits the
27 crime of making a false report if he knowingly

28 (1) gives false information to a peace officer with the

3 (3) makes a false report or gives a false alarm that a fire

6 (b) Making a false report is a class A misdemeanor.

7 Sec. 11.56.810. TERRORISTIC THREATENING. (a) A person commits
8 the crime of terroristic threatening if he knowingly makes a false
9 report that a circumstance dangerous to human life exists or is about
10 to exist and

11 (1) places a person in fear of physical injury to any per-
12 son;

13 (2) causes evacuation of a building; or

14 (3) causes serious public inconvenience.

15 (b) Terroristic threatening is a class C felony.

16 Sec. 11.56.820. TAMPERING WITH PUBLIC RECORDS. (a) A person
17 commits the crime of tampering with public records if he knowingly

18 (1) makes a false entry in or falsely alters a public record;
19 or

20 (2) destroys, mutilates, suppresses, conceals, removes, or
21 otherwise impairs the verity, legibility, or availability of a public
22 record, knowing that he lacks the authority to do so.

23 (b) Tampering with public records is a class A misdemeanor.

24 Sec. 11.56.830. IMPERSONATING A PUBLIC SERVANT. (a) A person
25 commits the crime of impersonating a public servant if he pretends to be
26 a public servant and does any act in that capacity.

27 (b) It is not a defense to a prosecution under this section that

27 proceeding; or

12 crime of disorderly conduct if,

15 conduct is having that effect after being informed that it is having
16 that effect, he makes unreasonably loud noise;

17 (2) in a public place or in a private place of another with-
18 out consent, and with intent to disturb the peace and privacy of another
19 or with reckless disregard that his conduct is having that effect after
20 being informed that it is having that effect, he makes unreasonably loud
21 noise;

22 (3) in a public place, when a crime has occurred, he refuses
23 to comply with a lawful order of a peace officer to disperse;

24 (4) in a private place, he refuses to comply with an order of
25 a peace officer to leave premises in which he has neither a right of
26 possession nor the express invitation to remain of a person having a
27 right of possession;

28 (5) in a public or private place, he challenges another to

4 female breast to another with reckless disregard for the offensive or

7 considering the nature and purpose of the defendant's conduct and the
8 circumstances known to him, including the nature of the location and the
9 time of day or night, his conduct involves a gross deviation from the
10 standard of conduct that a reasonable person would follow in the same
11 situation. "Noise" does not include speech which is constitutionally
12 protected.

13 (c) Disorderly conduct is a class B misdemeanor and is punishable
14 as authorized in AS 12.55 except that a sentence of imprisonment, if im-
15 posed, shall be for a definite term of not more than 10 days.

16 Sec. 11.61.120. HARASSMENT. (a) A person commits the crime of

1 commits the crime of misconduct involving a corpse if

2 (1) except as authorized by law or in an emergency, he inten-
3 tionally disinters, removes, conceals, or mutilates a corpse;

4 (2) he engages in sexual penetration of a corpse; or

5 (3) he detains a corpse for a debt or demand or upon a lien
6 or charge.

7 (b) Misconduct involving a corpse is a class A misdemeanor.

8 Sec. 11.61.140. CRUELTY TO ANIMALS. (a) A person commits the
9 crime of cruelty to animals if, except as authorized by law, he

10 (1) intentionally inflicts severe and prolonged physical pain
11 or suffering on an animal;

12 (2) owns, possesses, keeps, or trains an animal with intent
13 that it be engaged in an exhibition of fighting; or

14 (3) instigates, promotes, attends, or has a pecuniary inter-
15 est in an exhibition of fighting animals.

16 (b) It is a defense to a prosecution under this section that the
17 conduct of the defendant

18 (1) conformed to accepted veterinary practice;

19 (2) was part of scientific research governed by accepted
20 standards; or

21 (3) was necessarily incident to lawful hunting or trapping

23 (c) As used in this section, "animal" means a vertebrate living
24 creature not a human being, but does not include fish.

25 (d) Cruelty to animals is a class A misdemeanor.

26 Sec. 11.61.150. OBSTRUCTION OF HIGHWAYS. (a) A person commits
27 the crime of obstruction of highways if he knowingly

28 (1) places, drops, or permits to drop on a highway any sub-
29 stance that creates a substantial risk of physical injury to others

1 using the highway; or

2 (2) renders a highway impassable or passable only with un-
3 reasonable inconvenience or hazard.

4 (b) It is an affirmative defense to a prosecution under (a)(1) of
5 this section that

6 (1) the defendant took reasonable steps to remove the sub-

15 (1) knowingly possesses a firearm capable of being concealed

17 state, a court of the United States, or a court of another state or
18 territory;

19 (2) knowingly sells or transfers a firearm capable of being
20 concealed on one's person to a person who has been convicted of a felony

12 Sec. 11.81.370. JUSTIFICATION: USE OF FORCE BY A PEACE OFFICER IN
13 MAKING AN ARREST OR TERMINATING AN ESCAPE. (a) In addition to using
14 force justified under other sections of this chapter, a peace officer
15 may use nondeadly force and may threaten to use deadly force when and to
16 the extent he reasonably believes it necessary to make an arrest, to
17 terminate an escape or attempted escape from custody, or to make a
18 lawful stop. He may use deadly force only when and to the extent he
19 reasonably believes the use of deadly force is necessary to make the
20 arrest or terminate the escape or attempted escape from custody of a
21 person he reasonably believes

22 (1) has committed or attempted to commit a felony which in-
23 volved the use of force against a person;

24 (2) has escaped or is attempting to escape from custody while
25 in possession of a firearm on or about his person; or

26 (3) may otherwise endanger life or inflict serious physical
27 injury unless arrested without delay.

28 (b) The use of force in making an arrest or stop is not justified
29 under this section unless the peace officer reasonably believes the

1 arrest or stop is lawful.

2 (c) Nothing in this section prohibits or restricts a peace officer
3 in preparing to use or threatening to use a dangerous instrument.

4 Sec. 11.81.380. JUSTIFICATION: USE OF FORCE BY PRIVATE PERSON
5 ASSISTING AN ARREST OR TERMINATING AN ESCAPE. (a) Except as provided
6 in (b) of this section, a person who has been directed by a person he
7 reasonably believes to be a peace officer to assist him in making an
8 arrest or terminating or preventing an escape may use nondeadly force
9 when and to the extent he reasonably believes it necessary to carry out
10 the peace officer's direction. A person may use deadly force under this
11 section only when he reasonably believes it necessary to carry out the
12 peace officer's direction to use deadly force.

13 (b) The use of force under (a) of this section is not justified if
14 the person believes that the peace officer is not justified in using
15 that degree of force under the circumstances.

16 Sec. 11.81.390. USE OF FORCE BY A PRIVATE PERSON IN MAKING ARREST
17 OR TERMINATING AN ESCAPE. In addition to using force justified under
18 other sections of this chapter, a person, acting on his own account, may
19 use nondeadly force to make the arrest or terminate the escape or
20 attempted escape from custody of a person who he reasonably believes has
21 committed a misdemeanor in his presence or a felony when and to the
22 extent he reasonably believes it necessary to make that arrest or ter-
23minate that escape or attempted escape from custody. He may use deadly
24force under this section only when and to the extent he reasonably
25believes the use of deadly force is necessary to make the arrest or
26terminate the escape or attempted escape from custody of a person he
27reasonably believes

28 (1) has committed or attempted to commit a felony which in-
29volved the use of force against a person; or

1 (2) has escaped or is attempting to escape from custody while
2 in possession of a firearm on or about his person.

3 Sec. 11.81.400. JUSTIFICATION: USE OF FORCE IN RESISTING OR
4 INTERFERING WITH ARREST. (a) A person may not use force to resist the
5 arrest of himself or interfere with the arrest of another by a peace
6 officer who is known by him, or reasonably appears, to be a peace offi-
7 cer, whether the arrest is lawful or unlawful, unless

8 (1) the force used by the peace officer exceeds that allowed
9 under sec. 370 of this chapter; or

10 (2) the person resisted the arrest of himself and

11 (A) the arrest was unlawful;

12 (B) the person knew the arrest to be unlawful; and

13 (C) the person did not use deadly force in resisting the
14 arrest.

15 (b) The use of force justified under this section in resisting
16 arrest or interfering with the arrest of another may not exceed the use
17 of force justified under sec. 330 or 335 of this chapter.

18 Sec. 11.81.410. JUSTIFICATION: USE OF FORCE BY GUARDS. (a) In
19 addition to using force justified under other sections of this chapter,
20 a guard or peace officer employed in a correctional facility may, if
21 authorized by regulations adopted by the Department of Health and Social
22 Services, use nondeadly force upon another person when and to the extent
23 reasonably necessary and appropriate to maintain order.

24 (b) Except as provided in (c) of this section, a guard or peace
25 officer employed in a correctional facility or a peace officer in the
26 immediate vicinity of a correctional facility at the time of an escape
27 from the facility may use deadly force when and to the extent he reason-
28 ably believes it necessary to terminate the escape or attempted escape
29 of a prisoner from the correctional facility.

1 (c) The use of deadly force under (b) of this section is not
2 justified if the guard or peace officer knows that the prisoner was
3 under official detention in the correctional facility on a charge of a
4 misdemeanor and does not believe that the prisoner is armed with a
5 firearm, in which event only nondeadly force may be used.

6 Sec. 11.81.420. JUSTIFICATION: PERFORMANCE OF PUBLIC DUTY. (a)
7 Unless inconsistent with secs. 320 - 410 of this chapter, conduct which
8 would otherwise constitute an offense is justified when it is required
9 or authorized by law or by a judicial decree, judgment, or order.

10 (b) The justification afforded by this section also applies when

11 (1) the person reasonably believes his conduct to be required
12 or authorized by a decree, judgment, or order of a court of competent
13 jurisdiction or in the lawful execution of legal process, notwithstand-
14 ing lack of jurisdiction of the court or defect in the legal process; or

15 (2) the person reasonably believes his conduct to be required
16 or authorized to assist a peace officer in the performance of his duties,
17 notwithstanding that the officer exceeded his authority.

18 Sec. 11.81.430. JUSTIFICATION: USE OF FORCE, SPECIAL RELATION-
19 SHIPS. (a) The use of force upon another person that would otherwise
20 constitute an offense is justified under any of the following circum-
21 stances:

22 (1) When and to the extent reasonably necessary and appro-
23 priate to promote the welfare of the child or incompetent person, a
24 parent, guardian, or other person entrusted with the care and super-
25 vision of a child under 18 years of age or an incompetent person may use
26 reasonable and appropriate nondeadly force upon that child or incom-
27 petent person.

28 (2) When and to the extent reasonably necessary and appro-
29 priate to maintain order and when the use of force is consistent with

1 the welfare of the students, a teacher may, if authorized by school
2 regulations and the principal of the school, use reasonable and appro-
3 priate nondeadly force upon a student. If authorized by school regula-
4 tions and the principal of the school, a teacher may use nondeadly force
5 under this paragraph in any situation in which he is responsible for the
6 supervision of students. A teacher employed by a school board, in-
7 cluding a regional educational attendance area school board, may use
8 nondeadly force under this paragraph only if the school regulations
9 authorizing the use of force have been adopted by the school board.

10 (3) When and to the extent reasonably necessary and appro-
11 priate to maintain order, a person responsible for the maintenance of
12 order in a common carrier of passengers, or a person acting under his
13 direction, may use reasonable and appropriate nondeadly force.

14 (4) When and to the extent reasonably necessary to prevent a
15 suicide, a person who reasonably believes that another is imminently
16 about to commit suicide may use reasonable and appropriate nondeadly
17 force upon that person.

18 (5) A licensed physician, paramedic, or registered nurse, or
19 a person acting under his direction, or any person who renders emergency
20 care at the scene of an emergency, may use reasonable and appropriate
21 nondeadly force for the purpose of administering a recognized and lawful
22 form of treatment which is reasonably adapted to promoting the physical
23 or mental health of the patient if

24 (A) the treatment is administered with the consent of
25 the patient or, if the patient is a child under 18 years of age or
26 an incompetent person, with the consent of his parent, guardian, or
27 other person entrusted with his care and supervision; or

28 (B) the treatment is administered in an emergency if the
29 person administering the treatment reasonably believes that no one

1 competent to consent can be consulted under the circumstances and
2 that a reasonable person, wishing to safeguard the welfare of the
3 patient, would consent.

4 (b) A person who raises a defense under (a)(1) of this section and
5 claims that the person upon whom force was used was an incompetent
6 person has the burden of establishing by a preponderance of the evidence
7 that, at the time force was used, the person upon whom the force was
8 used was an incompetent person.

9 Sec. 11.81.440. DURESS. (a) In any prosecution for an offense,
10 it is an affirmative defense that the defendant engaged in the pro-
11 scribed conduct because he was coerced to do so by the use of unlawful
12 force upon him or a third person, which force a reasonable person in his
13 situation would have been unable to resist.

14 (b) The defense of duress is not available when a person reckless-
15 ly places himself in a situation in which it is probable that he will be
16 subject to duress.

17 Sec. 11.81.450. ENTRAPMENT. In any prosecution for an offense, it
18 is an affirmative defense that, in order to obtain evidence of the
19 commission of an offense, a public law enforcement official or a person
20 working in cooperation with him induced the defendant to commit the
21 offense by persuasion or inducement as would be effective to persuade an
22 average person, other than one who is ready and willing, to commit the
23 offense. Inducement or persuasion which would induce only a person
24 engaged in an habitual course of unlawful conduct for gain or profit
25 does not constitute entrapment.

26 ARTICLE 5. GENERAL PRINCIPLES OF CRIMINAL LIABILITY.

27 Sec. 11.81.600. GENERAL REQUIREMENTS OF CULPABILITY. (a) The
28 minimal requirement for criminal liability is the performance by a
29 person of conduct which includes a voluntary act or the omission to per-

1 form an act which he is capable of performing.

2 (b) A person is not guilty of an offense unless he acts with a
3 culpable mental state with respect to each element of the offense,
4 except that

5 (1) no culpable mental state must be proved with respect to
6 any element of an offense if the description of the offense does not
7 specify a culpable mental state and the offense is

8 (A) a violation; or

9 (B) designated as one of "strict liability";

10 (2) no culpable mental state must be proved with respect to a
11 particular element of the offense if an intent to dispense with the
12 culpable mental state requirement for that element clearly appears.

13 Sec. 11.81.610. CONSTRUCTION OF STATUTES WITH RESPECT TO CULPA-
14 BILITY. (a) When only one culpable mental state appears in a provision
15 of law defining an offense, it is rebuttably presumed to apply to every
16 element of the offense unless an intent to limit its application clearly
17 appears.

18 (b) Except as provided in sec. 600(b) of this chapter, if a pro-
19 vision of law defining an offense does not prescribe a culpable mental
20 state, the culpable mental state that must be proved with respect to

21 (1) conduct is "knowingly"; and

22 (2) a circumstance or a result is "recklessly".

23 (c) When a provision of law provides that criminal negligence
24 suffices to establish an element of an offense, that element is also
25 established if a person acts intentionally, knowingly, or recklessly.
26 If acting recklessly suffices to establish an element, that element also
27 is established if a person acts intentionally or knowingly. If acting
28 knowingly suffices to establish an element, that element is also estab-
29 lished if a person acts intentionally.

1 Sec. 11.81.615. OFFENSES DEFINED BY AGE OR VALUE. Whenever a
2 provision of law defining an offense requires a determination of the age
3 of the victim or the value of property or services, it is not a defense
4 to the lowest class of offense established by the evidence that the age
5 of the victim is less than the age which would make the offense a higher
6 class of offense or that the value of the property or services exceeds
7 the value which would make the offense a higher class of offense, and a
8 person may be charged and convicted accordingly.

9 Sec. 11.81.620. EFFECT OF IGNORANCE OR MISTAKE UPON LIABILITY.

10 (a) Knowledge, recklessness, or criminal negligence as to whether con-
11 duct constitutes an offense, or knowledge, recklessness, or criminal
12 negligence as to the existence, meaning, or application of the provision
13 of law defining an offense, is not an element of an offense unless the
14 provision of law clearly so provides. Use of the phrase "intent to
15 commit a crime", "intent to promote or facilitate the commission of a
16 crime", or like terminology in a provision of law does not require that
17 the defendant act with a culpable mental state as to the criminality of
18 the conduct that is the object of his intent.

19 (b) A person is not relieved of criminal liability for conduct
20 because he engages in the conduct under a mistaken belief of fact,
21 unless

22 (1) the factual mistake negates the culpable mental state
23 required for the commission of the offense;

24 (2) the provision of law defining the offense or a related
25 provision of law expressly provides that the factual mistake constitutes
26 a defense or exemption; or

27 (3) the factual mistake is of a kind that supports a defense
28 of justification as provided in secs. 320 - 430 of this chapter.

29 Sec. 11.81.630. INTOXICATION AS A DEFENSE. Voluntary intoxication

1 is not a defense to a prosecution for an offense, but evidence that the
2 defendant was intoxicated may be offered whenever it is relevant to
3 negate an element of the offense that requires that the defendant in-
4 tentionally cause a result.

5 Sec. 11.81.640. APPLICATION OF SECS. 600 - 630. Sections 600 -
6 630 of this chapter apply only to this title.

7 ARTICLE 6. DEFINITIONS.

8 Sec. 11.81.900. DEFINITIONS. (a) For purposes of this title,
9 unless the context requires otherwise,

10 (1) a person acts "intentionally" with respect to a result
11 described by a provision of law defining an offense when his conscious
12 objective is to cause that result;

13 (2) a person acts "knowingly" with respect to conduct or to a
14 circumstance described by a provision of law defining an offense when he
15 is aware that his conduct is of that nature or that the circumstance
16 exists; when knowledge of the existence of a particular fact is an
17 element of an offense, that knowledge is established if a person is
18 aware of a substantial probability of its existence, unless he actually
19 believes it does not exist; a person who is unaware of conduct or a cir-
20 cumstance of which he would have been aware had he not been intoxicated
21 acts knowingly with respect to that conduct or circumstance;

22 (3) a person acts "recklessly" with respect to a result or to
23 a circumstance described by a provision of law defining an offense when
24 he is aware of and consciously disregards a substantial and unjusti-
25 fiable risk that the result will occur or that the circumstance exists;
26 the risk must be of such a nature and degree that disregard of it con-
27 stitutes a gross deviation from the standard of conduct that a reason-
28 able person would observe in the situation; a person who is unaware of a
29 risk of which he would have been aware had he not been intoxicated acts

1 recklessly with respect to that risk;

2 (4) a person acts with "criminal negligence" with respect to
3 a result or to a circumstance described by a provision of law defining
4 an offense when he fails to perceive a substantial and unjustifiable
5 risk that the result will occur or that the circumstance exists; the
6 risk must be of such a nature and degree that the failure to perceive it
7 constitutes a gross deviation from the standard of care that a reason-
8 able person would observe in the situation.

9 (b) As used in this title, unless otherwise specified or unless
10 the context requires otherwise,

11 (1) "affirmative defense" means that

12 (A) some evidence must be admitted which places in issue
13 the defense; and

14 (B) the defendant has the burden of establishing the
15 defense by a preponderance of the evidence;

16 (2) "benefit" means a present or future gain or advantage to
17 the beneficiary or to a third person pursuant to the desire or consent
18 of the beneficiary;

19 (3) "building", in addition to its usual meaning, includes
20 any propelled vehicle or structure adapted for overnight accommodation
21 of persons or for carrying on business; when a building consists of
22 separate units, including apartment units, offices, or rented rooms,
23 each unit is considered a separate building;

24 (4) "cannabis" has the meaning ascribed to it in AS 17.12.-
25 150;

26 (5) "conduct" means an act or omission and its accompanying
27 mental state;

28 (6) "controlled substance" means

29 (A) a narcotic drug as defined in AS 17.10.230; or

1 (B) a depressant, hallucinogenic, or stimulant drug,
2 other than cannabis, as defined in AS 17.12.150;

3 (7) "correctional facility" means premises, or a portion of
4 premises, used for the confinement of persons under official detention;

5 (8) "credit card" means any instrument or device, whether
6 known as a credit card, credit plate, courtesy card, or identification
7 card or by any other name, issued with or without fee by an issuer for
8 the use of the cardholder in obtaining property or services on credit;

9 (9) "crime" means an offense for which a sentence of impris-
10 sonment is authorized; a crime is either a felony or a misdemeanor;

11 (10) "culpable mental state" means "intentionally", "knowing-
12 ly", "recklessly", or with "criminal negligence", as those terms are
13 defined in (a) of this section;

14 (11) "dangerous instrument" means anything which, under the
15 circumstances in which it is used, attempted to be used, or threatened
16 to be used, is capable of causing death or serious physical injury;
17 "dangerous instrument" includes "deadly weapon";

18 (12) "deadly force" means force which the person uses with the
19 intent of causing, or uses under circumstances which he knows create a
20 substantial risk of causing, death or serious physical injury; "deadly
21 force" includes intentionally discharging a firearm in the direction of
22 another person or in the direction in which another person is believed
23 to be;

24 (13) "deadly weapon" means any firearm, or anything designed
25 for and capable of causing death or serious physical injury, including a
26 knife, an axe, a club, metal knuckles, or an explosive;

27 (14) "deception" means to knowingly

28 (A) create or confirm another's false impression which
29 the defendant does not believe to be true, including false im-

1 pressions as to law or value and false impressions as to intention
2 or other state of mind;

3 (B) fail to correct another's false impression which the
4 defendant previously has created or confirmed;

5 (C) prevent another from acquiring information pertinent
6 to the disposition of the property or service involved;

7 (D) sell or otherwise transfer or encumber property and
8 fail to disclose a lien, adverse claim, or other legal impediment
9 to the enjoyment of the property, whether or not that impediment is
10 a matter of official record; or

11 (E) promise performance which the defendant does not in-
12 tend to perform or knows will not be performed;

13 (15) "defense", other than an affirmative defense, means that

14 (A) some evidence must be admitted which places in issue
15 the defense; and

16 (B) the state then has the burden of disproving the
17 existence of the defense beyond a reasonable doubt;

18 (16) "drug" means

19 (A) a controlled substance; or

20 (B) cannabis;

21 (17) "dwelling" means a building that is designed for use or
22 is used as a person's permanent or temporary home or place of lodging;

23 (18) "explosive" means a chemical compound, mixture, or device
24 that is commonly used or intended for the purpose of producing a chemi-
25 cal reaction resulting in a substantially instantaneous release of gas
26 and heat, including dynamite, blasting powder, nitroglycerin, blasting
27 caps, and nitrojelly, but excluding salable fireworks as defined in AS
28 18.72.050, black powder, smokeless powder, small arms ammunition, and
29 small arms ammunition primers;

1 (19) "felony" means a crime for which a sentence of imprison-
2 ment for a term of more than one year is authorized;

3 (20) "fiduciary" means a trustee, guardian, executor, adminis-
4 trator, receiver, or any other person carrying on functions of trust on
5 behalf of another person or organization;

6 (21) "firearm" means

7 (A) a loaded or unloaded pistol, revolver, rifle, or
8 shotgun; or

9 (B) any weapon, whether loaded or unloaded, designed for
10 discharging a shot capable of causing death or serious physical
11 injury;

12 (22) "force" means any bodily impact, restraint, or confine-
13 ment or the threat of imminent bodily impact, restraint, or confinement;
14 "force" includes deadly and nondeadly force;

15 (23) "government" means the United States, any state or any
16 municipality or other political subdivision within the United States or
17 its territories; any department, agency, or subdivision of any of the
18 foregoing; an agency carrying out the functions of government; or any
19 corporation or agency formed under interstate compact or international
20 treaty;

21 (24) "highway" means a public road, road right-of-way, street,
22 alley, bridge, walk, trail, tunnel, path, or similar or related facili-
23 ty, as well as ferries and similar or related facilities;

24 (25) "includes" means "includes but is not limited to";

25 (26) "incompetent person" means a person who is impaired by
26 reason of mental illness or mental deficiency to the extent that he
27 lacks sufficient understanding or capacity to make or communicate re-
28 sponsible decisions concerning his person;

29 (27) "intoxicated" means intoxicated from the use of a drug or

1 alcohol;

2 (28) "law" includes statutes and regulations;

3 (29) "leased" includes "rented";

4 (30) "metal knuckles" means a device that consists of finger
5 rings or guards made of a hard substance and designed, made, or adapted
6 for inflicting serious physical injury or death by striking a person;

7 (31) "misdemeanor" means a crime for which a sentence of im-
8 prisonment for a term of more than one year may not be imposed;

9 (32) "nondeadly force" means force other than deadly force;

10 (33) "offense" means conduct for which a sentence of imprison-
11 ment or fine is authorized; an offense is either a crime or a violation;

12 (34) "official detention" means custody, arrest, surrender in
13 lieu of arrest, or confinement under an order of a court in a criminal
14 or juvenile proceeding, other than an order of conditional bail release;

15 (35) "official proceeding" means a proceeding heard before a
16 legislative, judicial, administrative, or other governmental body or
17 official authorized to hear evidence under oath;

18 (36) "omission" means a failure to perform an act for which a
19 duty of performance is imposed by law;

20 (37) "organization" means a legal entity, including a corpora-
21 tion, company, association, firm, partnership, joint stock company,
22 foundation, institution, society, union, club, church, or any other
23 group of persons organized for any purpose;

24 (38) "peace officer" means a public servant vested by law with
25 a duty to maintain public order or to make arrests, whether the duty
26 extends to all offenses or is limited to a specific class of offenses or
27 offenders;

28 (39) "person" means a natural person and, when appropriate, an
29 organization, government, or governmental instrumentality;

1 (40) "physical injury" means physical pain or an impairment of
2 physical condition;

3 (41) "possess" means having physical possession or the exer-
4 cise of dominion or control over property;

5 (42) "premises" means real property and any building;

6 (43) "propelled vehicle" means a device upon which or by which
7 a person or property is or may be transported, and which is self-pro-
8 pelled, including automobiles, vessels, airplanes, motorcycles, snow
9 machines, all-terrain vehicles, sailboats, and construction equipment;

10 (44) "property" means an article, substance, or thing of
11 value, including money, tangible and intangible personal property, real
12 property, a credit card, choses-in-action, and evidence of debt or of
13 contract, a commodity of a public utility such as gas, electricity,
14 steam, or water constitutes property but the supplying of such a com-
15 modity to premises from an outside source by means of wires, pipes,
16 conduits, or other equipment is considered a rendition of a service
17 rather than a sale or delivery of property;

18 (45) "public place" means a place to which the public or a
19 substantial group of persons has access and includes highways, transpor-
20 tation facilities, schools, places of amusement or business, parks,
21 playgrounds, prisons, and hallways, lobbies, and other portions of
22 apartment houses and hotels not constituting rooms or apartments de-
23 signed for actual residence;

24 (46) "public record" means a document, paper, book, letter,
25 drawing, map, plat, photo, photographic file, motion picture, film,
26 microfilm, microphotograph, exhibit, magnetic or paper tape, punched
27 card or other document of any other material, regardless of physical
28 form or characteristic, developed or received under law or in connection
29 with the transaction of official business and preserved or appropriate

1 for preservation by an agency, municipality, or any body subject to the
2 open meeting provision of AS 44.62.310, as evidence of the organization,
3 function, policies, decisions, procedures, operations, or other activi-
4 ties of the state or municipality or because of the informational value
5 in it; it also includes staff manuals and instructions to staff that
6 affect the public;

7 (47) "public servant" means each of the following, whether
8 compensated or not, but does not include jurors or witnesses:

9 (A) an officer or employee of the state, a municipality
10 or other political subdivision of the state, or a governmental
11 instrumentality of the state, including legislators, members of the
12 judiciary, and peace officers;

13 (B) a person who participates as an advisor, consultant,
14 or assistant at the request or direction of the state, a munici-
15 pality or other political subdivision of the state, or a govern-
16 mental instrumentality;

17 (C) a person who serves as a member of a board or com-
18 mission created by statute or by legislative, judicial, or admini-
19 strative action by the state, a municipality or other political
20 subdivision of the state, or a governmental instrumentality;

21 (D) a person nominated, elected, appointed, employed, or
22 designated to act in a capacity defined in (A) - (C) of this para-
23 graph, but who does not occupy the position;

24 (48) a "renunciation" is not "voluntary and complete" if it is
25 substantially motivated, in whole or in part, by

26 (A) a belief that circumstances exist which increase the
27 probability of detection or apprehension of the defendant or
28 another participant in the criminal enterprise, or which render
29 more difficult the accomplishment of the criminal purpose; or

1 (B) a decision to postpone the criminal conduct until
2 another time or to transfer the criminal effort to another victim
3 or another but similar objective;

4 (49) "serious physical injury" means physical injury which
5 creates a substantial risk of death or which causes serious and pro-
6 tracted disfigurement, protracted impairment of health, or protracted
7 loss or impairment of the function of a bodily organ, or physical injury
8 which unlawfully terminates a pregnancy;

9 (50) "services" includes labor, professional services, trans-
10 portation, telephone or other communications service, entertainment, the
11 supplying of food, lodging, or other accommodations in hotels, restau-
12 rants, or elsewhere, admission to exhibitions, and the supplying of
13 equipment for use;

14 (51) "sexual contact" means

15 (A) the intentional touching, directly or through cloth-
16 ing, by the defendant of the victim's genitals, anus, or female
17 breast; or

18 (B) the defendant's intentionally causing the victim to
19 touch, directly or through clothing, the defendant's or victim's
