6 For an Act entitled: "An Act making miscellaneous appropriations to the
7 Municipality of Anchorage, the Department of Revenue,
8 the Legislative Affairs Agency, the Steering Council
9 for Alaska Lands, and the Department of Commerce and
10 Economic Development; and providing for an effective
11 date."

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

13 * Section 1. The sum of \$60,000 is appropriated from the general fund to
14 the Municipality of Anchorage to fund the youth employment services program.

15 * Sec. 2. The sum of \$35,000 is appropriated from the general fund to the
16 Department of Revenue to fund participation by that department in a study
17 which will analyze the extent of investment in tanker vessels, costs of the
18 use of those vessels, and rates charged for the use of those vessels in the
19 transport of Alaskan crude oil.

20 * Sec. 3. The sum of \$35,000 is appropriated from the general fund to the
21 Legislative Affairs Agency to defray the costs of the Legislative Council's
22 investigation of the extent of investment in tanker vessels, costs of the use
23 of those vessels, and rates charged for the use of those vessels in the
24 transport of Alaskan crude oil.

25 * Sec. 4 The sum of \$58,000 is appropriated from the general fund to the
26 Steering Council for Alaska Lands to produce five forums for public television
27 and radio that provide the public with a balanced presentation on the national
28 public interest lands issues under Sec. 17(d)(2) of the Alaska Native Claims
29 Settlement Act (P.L 92-203).

1 * Sec. 5. The sum of \$10,000 is appropriated from the general fund to the
2 Department of Commerce and Economic Development for the purpose of a grant to
3 establish a bottom fish research association.

4 * Sec. 6. The sum of \$83,700 is appropriated from the general fund to
5 the Department of Revenue for the purpose of adjusting income tax returns
6 and processing income tax refunds occasioned by the change in federal law
7 and to notify all practitioners of the proper method to adjust a return to
8 take the standard deduction.

9 * Sec. 7. The sum of \$33,000 is appropriated from the general fund to
10 the Legislative Affairs Agency for the fiscal year ending June 30, 1978 to
11 defray the expenses of the Senate Special Committee on Employment Resources
12 and Opportunities.

13 * Sec. 8. This Act takes effect immediately in accordance with AS 01.10.-
14 070(c).
