6 For an Act entitled: "An Act making appropriations for miscellaneous pur-
7 poses; and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. The sum of \$9,109,202 is appropriated from the general fund
10 to the Department of Education for the fiscal year ending June 30, 1977, to
11 be allocated as follows:

12	Foundation Program - Regular	\$1,956,733
13	Foundation Program - REAA's	2,638,000
14	Pupil Transportation - Regular	2,163,100
15	Local Formula - REAA's	1,217,470
16	AVEC and other	615,000
17	Safe Water	103,000
18	Audit Exception - Vocational Education	15,889
19	Bering Strait REAA	400,000

20 * Sec. 2. The sum of \$3,431,400 is appropriated from the general fund to
21 the Department of Education for the fiscal year ending June 30, 1978 to be
22 allocated as follows:

23 Major maintenance projects having a cost
24 in excess of \$10,000 such as, but not
25 limited to, roof repair, water and
26 sewer improvement, fire and life safety,
27 boilers, power generators and correction
28 of building code deficiencies - REAA's \$3,216,400
29 Survey of existing REAA facilities for

1 cost of correcting life safety and
2 other deficiencies of the facilities \$ 215,000

3 * Sec. 3. The sum of \$150,000 is appropriated from the general fund to
4 the Office of the Governor for the Bodily Injury Reparation Commission for
5 the fiscal year ending June 30, 1978.

6 * Sec. 4. The sum of \$2,533,200 is appropriated from the general fund to
7 the Department of Administration for the teachers' retirement system match
8 for fiscal years ending June 30, 1976, and June 30, 1977.

9 * Sec. 5. The sum of \$150,000 is appropriated from the general fund to
10 the University of Alaska to fund the costs of professional managers and con-
11 sultants retained by the University of Alaska during the fiscal year ending
12 June 30, 1977.

13 * Sec. 6. Sections 1, 4 and 5 of this Act take effect immediately in
14 accordance with AS 01.10.070(c). Sections 2 and 3 of this Act take effect
15 July 1, 1977.
