5 A BILL

6 For an Act entitled: "An Act authorizing the Alcoholic Beverage Control
7 Board to issue club permits."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 04.10 is amended by adding a new section to read:

10 ARTICLE 6. PERMITS.

11 Sec. 04.10.500. CLUB PERMITS. (a) The board may provide by
12 regulation for the issuance of club permits. A club permit authorizes
13 the organization holding the permit to sponsor social events, for the
14 period of time stipulated in the permit, during which a member of the
15 organization or his guests may consume beer on the premises specified in
16 the permit. In no case shall a permit issued under this section author-
17 ize a single organization to sponsor an event more frequently than once
18 every two weeks.

19 (b) A permit issued to an organization under this section does not
20 authorize the sale, offer of sale, supply or provision of alcoholic
21 beverages by the holder of the permit.

22 (c) Only nonprofit civic, service, charitable, fraternal or educa-
23 tional organizations which have been active for a period of not less
24 than one year may receive a permit under this section.

25 (d) Applications for permits under this section must be received
26 by the director of the board at least 30 days before the date or dates
27 the permit is desired. Applications shall be signed and notarized by
28 the president and secretary of the organization, shall be accompanied by
29 an affidavit showing the length of time the organization has been active,

1 and shall include a certified copy of the resolution or other action by
2 the board of directors of the organization authorizing submission of the
3 application. In addition, if the application is for premises located
4 within a municipality, the application shall be accompanied by a certi-
5 fied copy of a resolution adopted by the assembly or council of the
6 municipality supporting the issuance of the permit.

7 (e) The board may issue a club permit for a single event or for a
8 period of time not to exceed one year. If a permit is issued to an
9 organization authorizing the organization to sponsor more than one
10 event, the organization is limited to the sponsorship of not more than
11 one event during each two weeks for the period prescribed in the permit.

12 (f) A club permit authorized under this section may be issued by
13 the board without regard to secs. 430 - 460 of this section.

14 (g) The provisions of ch. 15 of this title are applicable to
15 organizations receiving permits under this section.

16 (h) The board shall revoke the permit for failure of an organiza-
17 tion to comply with any provision of this section.

18 (i) The board shall, by regulation, determine the fee for a permit
19 authorized by this section. The fee shall not exceed \$25 for each
20 social event sponsored by the holder of the permit for the period of the
21 permit.

22 (j) In this section,

23 (1) "charitable organization" means an organization, not or-
24 ganized for pecuniary profit, which is operated for the relief of po-
25 verty, distress, or other condition of public concern in the state;

26 (2) "civic or service organization" means a branch, lodge or
27 chapter of a national or state organization, not organized for pecuniary
28 profit, and authorized by its written constitution, charter, articles or
29 incorporation, or bylaws to engage in a fraternal, civic, or service

1 purpose in the state;

2 (3) "educational organization" means a civic, service or
3 charitable organization in the state, not organized for pecuniary
4 profit, whose primary purpose is educational in nature and designed to
5 develop the capabilities of individuals by instruction;

6 (4) "fraternal organization" means a civic, service or chari-
7 table organization of the state, except a high school or college frater-
8 nity, not organized for pecuniary profit, which is a branch, lodge or
9 chapter of a national or state organization and exists for the common
10 business, brotherhood, or other interests of its members.
