9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

12 of game by nonresident aliens which are separate from the open and  
13 closed seasons established under (2) of this subsection for the taking  
14 of game by other persons;

15 (12) establishment of the maximum number of nonresident aliens  
16 allowed to take a species of game in all or part of a game management  
17 unit.
