6 For an Act entitled: "An Act relating to local ownership of the Anchorage
7 and Fairbanks airports; and providing for an effective
8 date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. Upon written request from the Mayor of the Municipality of
11 Anchorage delivered to the Department of Natural Resources on or before
12 June 1, 1981, the commissioner of natural resources shall transfer to the
13 Municipality of Anchorage all rights, title and interest of the State of
14 Alaska to the airport facilities commonly known as Anchorage International
15 Airport and including facilities at Lake Hood and Lake Spenard and located
16 within Section 3 of Township 12 North, Range 4 West, Seward Meridian, and
17 Sections 21, 26, 27, 28, 33, 34 and 35 of Township 13 North, Range 4 West,
18 Seward Meridian. This conveyance shall include all state property, real and
19 personal, including but not limited to, equipment, structures, fixtures and
20 supplies related to the operation of the airport facilities, and shall be
21 concluded only after delivery before July 1, 1981, to the commissioner of
22 natural resources of a resolution by the Assembly of the Municipality of
23 Anchorage approving the conveyance.

24 * Sec. 2. The conveyance authorized by sec. 1 of this Act may be con-
25 cluded only after delivery before July 1, 1981, to the commissioner of
26 natural resources of an ordinance adopted by the Municipality of Anchorage,
27 which assumes the obligation to comply with all requirements imposed by the
28 terms, covenants or conditions of any revenue bonds sold under AS 37.15.410 -
29 37.15.550 to acquire, equip, construct, improve or install any portion of the

1 airport facilities.

2 * Sec. 3. Upon written request from the Mayor of the Fairbanks North Star
3 Borough delivered to the Department of Natural Resources on or before June 1,
4 1981, the commissioner of natural resources shall transfer to the Fairbanks
5 North Star Borough all rights, title and interest of the State of Alaska to
6 the facilities commonly known as Fairbanks International Airport and located
7 within Sections 18 and 19 of Township 1 South, Range 1 West, Fairbanks Meri-
8 dian, and Sections 13, 23, 24, 25 and 26 of Township 1 South, Range 2 West,
9 Fairbanks Meridian. This conveyance shall include all state property, real
10 and personal, including but not limited to, equipment, structures, fixtures
11 and supplies related to the operation of the airport facilities, and shall be
12 concluded only after delivery before July 1, 1981, to the commissioner of
13 natural resources of a joint resolution by the Assembly of the Fairbanks
14 North Star Borough and the Fairbanks International Airport Task Force approv-
15 ing the conveyance.

16 * Sec. 4. The conveyance authorized under sec. 3 of this Act may be
17 concluded only after delivery before July 1, 1981, to the commissioner of
18 natural resources of an ordinance adopted by the Fairbanks North Star Borough
19 which assumes the obligation to comply with all requirements imposed by the
20 terms, covenants or conditions of any revenue bonds sold under AS 37.15.410 -
21 37.15.550 to acquire, equip, construct, improve or install any portion of the
22 airport facilities.

23 * Sec. 5. This Act takes effect immediately in accordance with AS 01.10.-
24 070(c).
