IN THE LEGISLATURE OF THE STATE OF ALASKA

ELEVENTH LEGISLATURE - FIRST SESSION

Relating to interstate claims for un-  
employment benefits.

7 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8

WHEREAS unemployment benefits payable under the unemployment law of  
9 Alaska may be paid to claimants who work in Alaska but claim benefits while  
10 residing in another state; and

11

WHEREAS section 3304(a)(9)(A) of the Federal Unemployment Tax Act (26  
12 U.S.C. 3304(a)(9)(A)) prohibits a state from decreasing the amount of bene-  
13 fits paid to a claimant solely because he claims benefits while residing in  
14 another state; and

15

WHEREAS Alaska has the highest per capita personal income in the United  
16 States and a correspondingly high cost of living; and

17

WHEREAS the amount of unemployment benefits payable under Alaska law is  
18 set by the legislature to compensate unemployed individuals who reside in  
19 Alaska and the payment of equal benefits to a claimant who resides in a state  
20 with a lower cost of living overcompensates that person and encourages poten-  
21 tial claimants to remain unemployed while outside Alaska; and

WHEREAS in 1977 interstate claims represented 43 per cent of the money  
23 paid out of the state unemployment insurance trust fund; and

24

WHEREAS the payment of this amount of interstate claims is a drain on  
25 Alaska's unemployment insurance trust fund which impedes Alaska's ability to  
26 increase benefits payable to claimants to compensate them for the higher cost  
27 of living in the state;

BE IT RESOLVED by the Alaska State Legislature that Congress is respect-  
29 fully requested to enact legislation which allows a state to pay unemployment

1 benefits to out-of-state claimants based on the average annual wage of the  
2 state in which the claimant resides while receiving unemployment benefits;  
3 and be it

4 FURTHER RESOLVED that Congress is respectfully requested to enact legis-  
5 lation allowing states which are under the extended benefits program to pay  
6 interstate claims for extended benefits only to interstate claimants who  
7 reside in other states which are under the extended benefits program.

9 Williams, Jr., Chairman of the Senate Governmental Affairs Committee; the  
10 Honorable Carl D. Perkins, Chairman of the House Education and Labor Commit-  
11 tee; Mr. Lawrence E. Weatherford, Administrator, Unemployment Insurance  
12 Service, United States Department of Labor; and to the Honorable Ted Stevens  
13 and the Honorable Mike Gravel, U. S. Senators, and the Honorable Don Young,  
14 U. S. Representative, members of the Alaska delegation in Congress.
