BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. The sum of \$2,894,200 is appropriated to the Office of the

Governor, division of budget and management, for payment of fiscal year 1979

16

additional communication costs resulting from the RCA interim intrastate rate

increase. This sum is appropriated from the following funds:

* Sec. 2. The sum of \$10,400 is appropriated from the general fund to the

office of the ombudsman for payment of fiscal year 1979 additional communica-

1 tion costs resulting from the RCA interim intrastate rate increase.

2 * Sec. 3. The sum of \$27,500 is appropriated from the general fund to the
3 Department of Transportation and Public Facilities, division of communica-
4 tions, for payment of the required deposit for the initiation of a communica-
5 tions wide-band link system.

6 * Sec. 4. The sum of \$406,000 is appropriated from the general fund to
7 the Alaska Court System for contract payments to private attorneys appointed
8 to represent indigents.

9 * Sec. 5. The unexpended and unobligated portions of the appropriations
10 made in this Act lapse into the funds from which appropriated on June 30,
11 1979.

12 * Sec. 6. This Act takes effect immediately in accordance with AS 01.10.-
13 070(c).
