6 For an Act entitled: "An Act relating to parking permits for disabled per-
7 sons."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 28.10.495 is amended to read:

10 Sec. 28.10.495. PARKING PERMIT FOR VEHICLE TRANSPORTING DISABLED
11 PERSON. (a) Upon application by [WHEN THE OWNER OR PERSON IN LAWFUL
12 POSSESSION OF A VEHICLE PRESENTS TO THE DEPARTMENT WRITTEN PROOF, IN THE
13 FORM OF AN AFFIDAVIT, THAT HE IS PRIMARILY RESPONSIBLE FOR THE TRANSPOR-
14 TATION OF] a disabled or medically handicapped person, the department
15 shall issue to the applicant, without charge, a special permit bearing
16 the control number of the applicant [APPLICANT'S NAME, ADDRESS, DRIVER'S
17 LICENSE NUMBER, AND THE REGISTRATION PLATE NUMBERS OF THE VEHICLES TO BE
18 USED FOR THAT TRANSPORTATION]. The permit issued under this section,
19 when displayed in the front windshield of a parked or standing vehicle,
20 shall provide for special consideration by the public with respect to
21 the parking or standing in designated spaces of a vehicle [WHICH IS NOT
22 REGISTERED IN THE NAME OF THE DISABLED OR MEDICALLY HANDICAPPED PERSON,
23 BUT] which is being used for the [PRIMARY] transportation of the dis-
24 abled or medically handicapped [THAT] person.

25 (b) No person is entitled to use the special permit provided for
26 in (a) of this section except

27 [(1) THE DRIVER NAMED ON THE PERMIT;
28 (2) WHEN IN A VEHICLE HAVING ITS REGISTRATION NUMBER ON THE

(3) ONLY] when providing transportation for the disabled or handicapped person with respect to whom the permit was issued.

(c) Proof of disablement or medical handicap, for the purpose of this section, shall be provided as specified in AS 28.10.181(d).
