5 A BILL

6 For an Act entitled: "An Act relating to the Alaska Commercial Fishing and
7 Agriculture Bank; and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 44.54.020(a) is amended to read:

10 (a) The bank shall be managed by a board of directors consisting
11 of seven members. At least one member of the board shall be an Alaska
12 farmer with at least 10 years of Alaskan farm experience. Initial
13 appointments to the board shall be made by the governor. Two of the
14 initial appointments shall be made at the time of the first annual
15 membership meeting of the bank. Thereafter, five board members shall be
16 elected by the members of the bank [SHAREHOLDERS], with at least one of
17 the elected board members being an Alaska farmer with at least 10 years
18 of Alaskan farm experience, and two board members shall be appointed by
19 the governor until the repurchase of all the nonvoting, preferred shares
20 initially issued by the bank and purchased by agencies of the state.
21 After repurchase is completed, all board members shall be elected by the
22 members of the bank [SHAREHOLDERS]. The board members shall annually
23 elect a chairman from among themselves. The purpose of the board is to
24 manage the assets of the bank.

26 (b) Loans made to members [SHAREHOLDERS] of the bank under the
27 provisions of this chapter shall be in accordance with a schedule of
28 maximum amounts adopted by the board of directors based upon proportion-
29 al ownership of membership shares.

1 * Sec. 3. AS 44.54.070 is repealed and re-enacted to read:

2 Sec. 44.54.070. PRESIDENT; OFFICERS AND EMPLOYEES. (a) The board
3 of directors shall employ a president. The president may not be a
4 member of the board of directors. The president serves at the pleasure
5 of the board of directors. The president is the chief executive officer
6 of the bank.

7 (b) The board of directors shall appoint one or more vice-presi-
8 dents, as prescribed in the bylaws of the bank, a secretary, a treasurer
9 and other officers as the board of directors considers necessary. The
10 board of directors may appoint one person to more than one of the posi-
11 tions described in this subsection. The officers described in this sub-
12 section are not required to be members of the board of directors.

13 (c) The president may hire employees of the bank reasonably neces-
14 sary for the efficient performance of the functions of the bank. Sub-
15 ject to the approval of the board of directors, the president may also
16 contract for and engage the services of professional and technical
17 advisors. The board of directors shall prescribe the duties and com-
18 pensation of employees of the bank.

20 (a) Neither the members of the board of directors, the president
21 [EXECUTIVE DIRECTOR], staff, nor a person executing the bonds is liable
22 personally on the bonds or subject to personal liability or account-
23 ability by reason of the issuance of the bonds.

24 * Sec. 5. AS 44.54.210(1) is amended to read:

25 (1) make variable rate or fixed rate loans to individuals who
26 are residents and who are engaged in commercial agriculture or fishing,
27 including harvesters, processors, suppliers and marketers, or to cor-
28 porations, partnerships or joint ventures [PRIMARILY] engaged in com-
29 mercial agriculture or fishing, the majority interest of which is bene-

1 ficially owned by residents of the state and a majority of the owners of
2 which are residents of the state, if the recipient of the loan is a
3 member [SHAREHOLDER] of the bank; however, the bank may make a loan
4 under this paragraph to a corporation, partnership, or joint venture for
5 the purchase of a new or existing fishing vessel or for the repair or
6 renovation of an existing fishing vessel, the primary purpose of which
7 is to commercially harvest fishery resources, only if the corporation,
8 partnership, or joint venture is wholly owned and controlled by
9 residents of the state and if the recipient of the loan is a member
10 [SHAREHOLDER] of the bank.

11 * Sec. 6. AS 44.54.210(16) is amended to read:

12 (16) provide technical services to members of the bank [SHARE-
13 HOLDERS]; for the purposes of this paragraph, "technical services"
14 includes services that will enhance the ability of the member [SHARE-
15 HOLDER] to obtain financial assistance from the bank;

16 * Sec. 7. AS 44.54.210 is amended by adding a new paragraph to read:

17 (21) indemnify a director, officer or employee of the bank and
18 his heirs, executors and administrators against all liabilities and
19 related expenses including, but not limited to, court costs and attorney
20 fees, judgments, and the cost of reasonable settlements, incurred by him
21 in connection with or arising out of an action or proceeding brought
22 against him because of an act or omission in the performance of his
23 official duties as director, officer or employee of the bank regardless
24 of whether he is a director, officer or employee at the time the ex-
25 penses or liabilities are incurred.

26 * Sec. 8. AS 44.54.210 is amended by adding a new subsection to read:

27 (b) The provisions of (a)(21) of this section do not authorize the
28 bank to indemnify a director, officer or employee of the bank who is
29 adjudged liable for negligence or misconduct in the performance of his

1 official duties.

2 * Sec. 9. AS 44.54.230(a) is amended to read:

3 (a) A loan under AS 44.54.210(20) for the purchase of a limited
4 entry permit may be made only upon certification by the commission
5 [ALASKA COMMERCIAL FISHERIES ENTRY COMMISSION (AS 16.43.020)] that the
6 fisherman is a person who qualifies as a transferee for the permit under
7 AS 16.43 and the regulations adopted by the commission.

8 * Sec. 10. AS 44.54.230(b) is amended to read:

9 (b) Upon approval by the bank, the permit to be purchased may be
10 pledged as security for a loan under (a) of this section, if

11 (1) the certificate for the pledged permit lists [THE EXECU-
12 TIVE DIRECTOR OF] the bank as the legal owner of the permit;

13 (2) the certificate for the pledged permit lists the debtor
14 as the equitable owner of the permit;

15 (3) all annual permit cards issued under the pledged permit
16 list the name of the debtor;

17 (4) all obligations and responsibilities of a permit owner
18 are assumed by the debtor;

19 (5) co-signers or other sureties for performance under the
20 note are not vested with any rights in the pledged permit and their
21 obligation is limited to satisfaction of the note and payment of costs
22 directly incurred by the bank in administering the loan.

24 (c) Upon satisfaction of the note by the debtor, the bank [EXECU-
25 TIVE DIRECTOR] shall certify to the commission that the note has been
26 satisfied.

28 Sec. 44.54.240. DEFAULT AND FORECLOSURE OF LOANS FOR LIMITED ENTRY
29 PERMITS. (a) If the debtor defaults upon a note for which a limited

1 entry permit has been pledged as security under AS 44.54.230, [THE
2 EXECUTIVE DIRECTOR OF] the bank shall provide the debtor, by registered
3 or certified mail sent to his last known address on file with the bank,
4 with a notice of default which includes

5 (1) a description of the security given for the note includ-
6 ing the number assigned to the pledged permit by the commission [ALASKA
7 COMMERCIAL FISHERIES ENTRY COMMISSION];

8 (2) the date upon which the default occurred;

9 (3) the amount of arrearages as of the date of the notice,
10 the total amount remaining on the note less unearned interest, and the
11 amount of daily interest;

12 (4) a statement that the debtor may, within 15 days of the
13 postmark date of the notice, request a hearing at which he may submit
14 evidence showing he has not defaulted;

15 (5) a statement that the note may be reinstated if brought
16 current within 60 days from the postmark date of the notice;

17 (6) a statement that the note may be paid in full less un-
18 earned interest within 90 days from the postmark date of the notice;

19 (7) the place where reinstatement or payment in full may be
20 made; and

21 (8) a notice in at least 10-point bold type stating: "IMPOR-
22 TANT: YOUR FAILURE TO REINSTATE OR PAY THIS NOTE IN FULL BY THE DATE
23 SPECIFIED WILL RESULT IN A FORFEITURE OF ALL RIGHTS TO THE PERMIT AND
24 THE POSSIBILITY OF LEGAL ACTION BEING INSTITUTED AGAINST YOU."

25 (b) Upon the debtor's failure to reinstate or satisfy the note
26 within the time specified in (a) of this section, his equitable interest
27 is terminated by operation of law without further notice. Any entry
28 permit cards issued to him under the permit shall be cancelled immedi-
29 ately upon receipt by the commission of a certificate of termination

1 containing a copy of the notice required by (a) of this section issued
2 by [THE EXECUTIVE DIRECTOR OF] the bank.

3 * Sec. 13. AS 44.54.250(a) is amended to read:

4 (a) Upon a foreclosure on an entry permit as provided in AS 44.-
5 54.240, [THE EXECUTIVE DIRECTOR OF] the bank shall offer the commission
6 [ALASKA COMMERCIAL FISHERIES ENTRY COMMISSION] a right of first refusal
7 if the permit is subject to a buy-back program under AS 16.43.290 -
8 16.43.330 at a price equal to the amount outstanding on the note plus
9 any costs the bank directly incurred in administering the loan.

10 * Sec. 14. AS 44.54.250(c) is amended to read:

11 (c) If the debtor is unable to nominate a qualified person to
12 assume the note under (b) of this section, the permit must be made
13 available to a qualified person, chosen as provided in this section, who
14 shall assume the note subject to all rights and liabilities of the
15 original debtor. The commission [ALASKA COMMERCIAL FISHERIES ENTRY
16 COMMISSION] shall provide the bank with a list of persons chosen by
17 lottery who qualify as transferees of entry permits under AS 16.43 and
18 regulations adopted by the commission and who have met the residency and
19 commercial fishing participation requirements of AS 44.54.210(20). The
20 [EXECUTIVE DIRECTOR OF THE] bank shall then determine, in order of
21 presentation, any remaining qualifications. The bank [EXECUTIVE DIREC-
22 TOR] shall allow the first applicant meeting all qualifications to
23 assume the note.

25 (d) Nothing in this section affects the right of [THE EXECUTIVE
26 DIRECTOR OF] the bank to institute legal action for a deficiency result-
27 ing from a default on a note given under AS 44.54.230. In addition to
28 any deficiency, the debtor is liable for the costs of administering the
29 note and for costs and attorney fees.

Sec. 44.54.260. DEFINITIONS. In this chapter

(1) "bank" means the Alaska Commercial Fishing and Agriculture Bank;

(2) "commission" means the Alaska Commercial Fisheries Entry Commission (AS 16.43.020);

(3) "member of the bank" includes a holder of a share of membership stock of the bank or a patron of the bank with retained patronage earnings of \$2,500 or more to his credit;

(4) "supplier" means a person whose main source of income is from providing goods or services that are directly related to commercial fishing or agriculture to individuals, corporations, partnerships or joint ventures engaged in commercial fishing or agriculture.
