2 SENATE CONCURRENT RESOLUTION NO. 54  
3 IN THE LEGISLATURE OF THE STATE OF ALASKA  
4 ELEVENTH LEGISLATURE - SECOND SESSION

5 Approving the district coastal  
6 management program of the City of  
7 Haines and the findings, conclusions,  
8 and stipulations of the Alaska  
9 Coastal Policy Council.

10 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 WHEREAS AS 44.19.891 establishes the Alaska Coastal Policy Council and  
12 AS 46.40.010 - 46.40.070 charges the council with the responsibility of  
13 reviewing district coastal management programs and approving them if they are  
14 substantially consistent with the guidelines and standards of the council and  
15 the Alaska coastal management program; and

16 WHEREAS the City of Haines accordingly prepared a district coastal  
17 management program, gave conceptual approval to its district coastal manage-  
18 ment program on October 16, 1979, and submitted the program to the Alaska  
19 Coastal Policy Council on October 21, 1979; and

20 WHEREAS the Alaska Coastal Policy Council conducted its review of the  
21 district coastal management program of the City of Haines, held a public  
22 hearing, gave public notice, provided ample opportunity for review and com-  
23 ment, and, on January 16, 1980, adopted the findings and conclusions of the  
24 office of coastal management which recommended approval of the Haines dis-  
25 trict program with certain stipulations; and

26 WHEREAS, having completed its responsibilities, the Alaska Coastal  
27 Policy Council has submitted the City of Haines district coastal management  
28 program and its official findings and conclusions approving that program to  
29 the legislature for its approval; and

1           WHEREAS AS 46.40.080 requires approval of portions of the state coastal  
2 management program either by adoption of concurrent resolution by a majority  
3 of the members of each house of the legislature, or by the majority vote of  
4 the members of each house at the time the houses are convened in joint  
5 legislative session to confirm executive appointments submitted by the  
6 governor; and

7           WHEREAS, in accordance with this law, the Alaska Coastal Policy Council  
8 has submitted this adopted portion of the Alaska coastal management program  
9 for legislative approval;

10          BE IT RESOLVED that in accordance with AS 46.40.080 the Alaska State  
11 Legislature approves the City of Haines district coastal management program  
12 and the findings, conclusions, and stipulations of the Alaska Coastal Policy  
13 Council.
