6 For an Act entitled: "An Act abolishing the Administrative Regulation
7 Review Committee."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 18.56.088 is amended to read:

10 Sec. 18.56.088. ADMINISTRATIVE PROCEDURE. (a) Except for
11 AS 44.62.310 and 44.62.312, regarding public meetings, and AS 44.62.-
12 320(a) regarding legislative review of regulations, the Administrative
13 Procedure Act (AS 44.62) does not apply to this chapter. The corpora-
14 tion shall make available to members of the public copies of the regu-
15 lations adopted under (b) - (e) of this section. [WITHIN 45 DAYS AFTER
16 ADOPTION, THE CHAIRMAN OF THE BOARD SHALL SUBMIT A REGULATION ADOPTED
17 UNDER (b) - (e) OF THIS SECTION TO THE CHAIRMAN OF THE ADMINISTRATIVE
18 REGULATION REVIEW COMMITTEE UNDER AS 24.20.400 - 24.20.460.] The
19 provisions of AS 44.62.320(a) apply to regulations adopted under (b) -
20 (e) of this section.

21 * Sec. 2. AS 24.30.060(b) is amended to read:

22 (b) Bills introduced by the Legislative Council shall be delivered
23 with a letter of explanation to the rules committee of either house and
24 bear the inscription "Rules Committee by Request of the Legislative
25 Council"; [BILLS INTRODUCED BY THE ADMINISTRATIVE REGULATION REVIEW
26 COMMITTEE SHALL BE DELIVERED WITH A LETTER OF EXPLANATION TO THE RULES
27 COMMITTEE OF EITHER HOUSE AND BEAR THE INSCRIPTION "RULES COMMITTEE BY
28 REQUEST OF THE ADMINISTRATIVE REGULATION REVIEW COMMITTEE";] bills
29 introduced by the Legislative Budget and Audit Committee shall be

1 delivered with a letter of explanation to the rules committee of either
2 house and bear the inscription "Rules Committee by Request of the
3 Legislative Budget and Audit Committee." Bills presented by the gover-
4 nor shall be delivered with a letter to the rules committee of either
5 house and bear the inscription "Rules Committee by Request of the
6 Governor"; bills so presented and inscribed shall be received as bills
7 carrying the approval of the governor as to policy and budget impact.
8 The governor may submit a statement of purpose and effect with each
9 bill and appear personally or through a representative before any
10 committee considering legislation.
