6 For an Act entitled: "An Act relating to appropriations and grants from
7 boroughs to service areas and cities; and providing
8 for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. AS 29.13.100 is amended by adding new paragraphs to read:

11 (48) AS 29.73.080 (revenue sharing by boroughs)

12 (49) AS 29.63.090(b)(2) (financing of service areas)

13 * Sec. 2. AS 29.48.210 is amended to read:

14 Sec. 29.48.210. EXPENDITURE OF BOROUGH REVENUES. Borough revenues
15 levied and collected on an areawide basis by a home rule or general law
16 borough may be expended on general administrative costs, [AND] on area-
17 wide functions, and for the appropriations and grants authorized in
18 AS 29.63.090(b)(2) and 29.73.080 only. Revenues levied and collected
19 in the area outside cities only may be expended on general administra-
20 tive costs and functions which render service to the area outside
21 cities only.

22 * Sec. 3. AS 29.53.010 is amended to read:

23 Sec. 29.53.010. GENERAL PROPERTY TAX. Home rule and general law
24 boroughs may levy (1) an areawide property tax for areawide functions,
25 and for the appropriations and grants authorized in AS 29.63.090(b)(2)
26 and in AS 29.73.080; and (2) a property tax limited to the area outside
27 cities for functions limited to the area outside cities. A property
28 tax if levied must be assessed, levied and collected on real and per-
29 sonal property as provided in this chapter.

1 * Sec. 4. AS 29.63.090(b) is amended to read:

2 (b) The assembly may

3 (1) levy or authorize the levying of taxes, charges, or
4 assessments in service areas to finance the special services; or
5 (2) by ordinance appropriate money from areawide taxes or
6 other areawide revenues to finance all or part of the special services,
7 if the power to finance the special services from those revenue sources
8 is acquired in an areawide election on the question.

9 * Sec. 5. AS 29.73 is amended by adding a new section to read:

10 Sec. 29.73.080. REVENUE SHARING GRANTS BY BOROUGHES. A home rule
11 or general law borough may make grants from areawide taxes or other
12 areawide revenues to a city within the borough or to a service area of
13 the borough to finance a function the city or service area is author-
14 ized by law to perform, if the power to use areawide taxes or other
15 areawide revenues for the grants to cities or service areas is acquired
16 in an areawide election on the question.

17 * Sec. 6. This Act takes effect immediately in accordance with AS 01.10.-
18 070(c).
