6 For an Act entitled: "An Act relating to limited entry to commercial
7 fisheries; and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 16.43.150(d) is amended to read:

10 (d) Failure to renew an entry permit for a period of two years
11 from the year [DATE] of last renewal results in a forfeiture of the
12 entry permit to the commission, except as waived by the commission for
13 good cause. An entry permit may not be renewed until the fees for
14 each preceding year during which the entry permit was not renewed are
15 paid. However, failure to renew an entry permit in a year in which
16 there is an administrative closure for the entire season for a speci-
17 fic fishery is good cause not to renew the entry permit. The commission
18 shall waive the payment of fees for that year.

19 * Sec. 2. AS 16.43.270(b) is amended to read:

20 (b) If, within the lowest priority classification of qualified
21 applicants to which some entry permits may be issued, there are more
22 applicants than there are entry permits to be issued, then the alloca-
23 tion of entry permits within that priority classification shall be by
24 lottery. However, the commission shall issue entry permits to all
25 qualified applicants in that priority classification if the total num-
26 ber of permits issued for the fishery does not exceed the maximum num-
27 ber of entry permits established under AS 16.43.240 for that fishery by
28 more than five percent or 10 permits, whichever is greater.

29 * Sec. 3. AS 16.43.355(a) is amended to read:

1 (a) The commission may revoke an entry permit or interim-use
2 permit if a person knowingly supplies, assists in supplying, or fails
3 to correct false information provided to the commission for the purpose
4 of

5 (1) permit application; [OR]

6 (2) permit transfer; or

7 (3) permit renewal.

8 * Sec. 4. AS 16.43.355 is amended by adding a new subsection to read:

9 (i) An entry permit revoked by the commission under this section
10 which is taken as security for a loan under AS 16.10.333 or AS 44.81.-
11 230 shall be reassigned as provided in AS 16.10.337 or AS 44.81.250.

12 * Sec. 5. AS 16.43.360 is amended by adding a new subsection to read:

13 (f) An entry permit forfeited under this section which is taken
14 as security for a loan under AS 16.10.333 or AS 44.81.230 shall be
15 reassigned as provided in AS 16.10.337 or AS 44.81.250.

16 * Sec. 6. AS 16.43.360(c) is repealed.

17 * Sec. 7. This Act takes effect immediately in accordance with AS 01.-
18 10.070(c).
