6 For an Act entitled: "An Act relating to jury service; and providing for an
7 effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 09.20.030 is amended to read:

10 Sec. 09.20.030. EXEMPTIONS. A person may claim exemption and may
11 be excused from service as a juror if it is shown that [JURY SERVICE
12 WILL CAUSE HIM TO SUFFER MATERIAL INJURY OR DESTRUCTION TO HIS PROPERTY
13 OR TO THE PROPERTY ENTRUSTED TO HIM, OR IF] his health, the health or
14 proper care of his family, a permanent physical or mental disability,
15 or other substantial hardship expected to last more than two years. [OR
16 THE SICKNESS OR DEATH OF A MEMBER OF HIS FAMILY] makes it necessary for
17 him to be excused [, OR IF HE IS

18 (1) A JUDICIAL OFFICER;

19 (2) ANY OTHER CIVIL OFFICER OF THE STATE OR UNITED STATES
20 WHOSE DUTIES ARE AT THE TIME INCONSISTENT WITH HIS ATTENDANCE OR SERVICE
21 AS A JUROR;

22 (3) AN ATTORNEY;

23 (4) A MINISTER OF THE GOSPEL OR PRIEST OF ANY DENOMINATION;

24 (5) A TEACHER IN A UNIVERSITY, COLLEGE, ACADEMY, OR SCHOOL;

25 (6) A PRACTICING PHYSICIAN;

26 (7) A PRACTICING DENTIST].

27 * Sec. 2. AS 09.20 is amended by adding a new section to read:

28 Sec. 09.20.035. DEFERRAL OF JURY SERVICE. A person may have his
29 jury service deferred if he shows that jury service at the time for

1 which he is summoned will cause hardship to himself or others, or that
2 transportation problems make it temporarily impossible for him to
3 serve. Jury service may be deferred under this section only if the
4 person seeking the deferment agrees to a deferred date. Jury service
5 may not be deferred for more than 10 months from the date the initial
6 jury service was to begin.

7 * Sec. 3. This Act takes effect January 1, 1982.
