6 For an Act entitled: "An Act relating to the teachers', judicial, national
7 guard, and public employees' retirement systems; creat-
8 ing the Public Employees' and Teachers' Disability
9 Review Board; and providing for an effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 * Section 1. AS 14.20.345(b) is amended to read:

12 (b) A leave of absence is not an interruption of the continuous
13 service necessary to attain or retain retirement or tenure rights
14 according to AS 14.20.150, 14.20.155, or 14.20.160. However, the time
15 spent on leave of absence may not be counted in determining when a
16 teacher has sufficient service to enable the teacher [HIM] to acquire
17 retirement or tenure rights, except that time on leave of absence for
18 specific educational purposes approved by a school board may be counted
19 as membership service to complete the requirements for retirement under
20 AS 14.25.110, if the teacher makes contributions for the period of the
21 leave of absence under (d) of this section.

23 (1) formulate and recommend to the Alaska Teachers' Retirement

4 ate ratio to a year. Credit for service in the Peace Corps, VISTA, or
5 Teachers' Corps shall be granted only if the member makes contributions

8 credited under this section shall be included in the 10-year limitation
9 of outside service as specified in AS 14.25.060, except that if entry

11 by Alaska membership service and termination from the Peace Corps,
12 VISTA, or Teachers' Corps is followed by Alaska membership service
13 within one year, the service in the Peace Corps, VISTA, or Teachers'
14 Corps may not be included in the 10-year limitation on outside service.

6 normal retirement, and (2) the proximate cause of death is a bodily in-
7 jury sustained or hazard undergone while in the performance and within
8 the scope of the member's duties of employment, and (3) the injury or
9 hazard is not the proximate result of wilful negligence on the part of
10 the member, a monthly survivor's pension equal to 40 percent of the mem-
11 ber's base salary at the time of termination of employment, divided by

13 viving spouse, the monthly survivor's pension shall be paid in equal

6 or her spouse or a dependent approved by the administrator as the con-

4 (e) If either the member or contingent beneficiary dies before the
5 member is appointed to retirement, the election becomes inoperative.
6 Once the member is appointed to retirement, the election is irrevocable,
7 even if the retired member is reemployed. Any additional retirement
8 benefit to which the reemployed member may become entitled will be paid
9 in accordance with the initial election made under this section, unless
10 the contingent beneficiary is deceased. If the contingent beneficiary
11 is deceased, the benefits earned during the period of reemployment are
12 subject to AS 14.25.110, or this section if another contingent benefici-
