6 For an Act entitled: "An Act making miscellaneous supplemental appro-
7 priations; and providing for an effective date."
8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
9 * Section 1. The sum of \$25,100,000 is appropriated from the general
10 fund to the Department of Revenue to fund FY 83 municipal assistance under
11 AS 43.18.
12 * Sec. 2. The sum of \$2,938,000 is appropriated from the general fund
13 to the Department of Community and Regional Affairs to cover the revenue
14 sharing shortfall under AS 29.89.
15 * Sec. 3. The sum of \$4,000,000 is appropriated from the general fund
16 to the Department of Natural Resources to pay the land deficiency entitle-
17 ment to the Municipality of Anchorage for FY 82, under AS 29.18.208.
18 * Sec. 4. The sum of \$1,000,000 is appropriated from the general fund
19 to the Department of Natural Resources to pay the land deficiency entitle-
20 ment to the Municipality of Anchorage for FY 83, under AS 29.18.208.
21 * Sec. 5. The sum of \$1,467,300 is appropriated from the general fund
22 to the Department of Administration to fund the state match to the Teach-
23 ers' Retirement System for FY 82.
24 * Sec. 6. The sum of \$2,136,600 is appropriated from the general fund
25 to the Department of Administration to fund the state match to the Teach-
26 ers' Retirement System for FY 83.
27 * Sec. 7. The sum of \$6,000,000 is appropriated from the general fund
28 to the Department of Revenue to fund added costs of the political campaign
29 contribution refund program for FY 83.

1 * Sec. 8. The sum of \$1,972,700 is appropriated from the general fund
2 to the Department of Health and Social Services to fund the costs of in-
3 creased prisoner population.

4 * Sec. 9. The sum of \$89,100 is appropriated from the general fund to
5 the Department of Law to cover costs of miscellaneous settlements and
6 judgments arising from litigation against the state for FY 83.

7 * Sec. 10. This Act takes effect immediately in accordance with AS 01.-
8 10.070(c).
