A BILL

6 For an Act entitled: "An Act establishing a waterfowl conservation stamp
7 and fee."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 16.05.110 is amended to read:

10 Sec. 16.05.110. COMPOSITION OF FUND. The fish and game fund
11 shall be made up of the following money and other money the legisla-
12 ture appropriates, which shall be deposited and retained in the fund
13 until expended:

14 (1) money received from the sale of state sport fishing,
15 hunting, and trapping licenses, [AND] special permits, and waterfowl
16 conservation stamps;

17 (2) proceeds received from the sale of furs, skins, and
18 specimens taken by predator hunters and other employees;

19 (3) money received in settlement of a claim or loss caused
20 by damage to the fish and game resources of the state;

21 (4) money received from federal, state, or other govern-
22 mental unit, or from a private donor for fish and game purposes;

23 (5) interest earned upon money in the fund;

24 (6) money from any other source.

25 * Sec. 2. AS 16.05.130 is amended by adding a new subsection to read:

26 (b) Funds accruing to the state from waterfowl conservation
27 stamp fees may not be diverted to a purpose other than (1) the conser-
28 vation and enhancement of waterfowl; (2) the acquisition, by lease or
29 otherwise of wetlands that are important for waterfowl and public use

1 of waterfowl in the state; (3) waterfowl related projects approved by
2 the commissioner; and (4) the administration of the stamp program.
3 The department shall maintain a state waterfowl conservation stamp
4 account within the fish and game fund to permit separate accounting
5 records for the receipt and expenditure of funds derived from the sale
6 of waterfowl conservation stamps. The department shall report an-
7 nually to the public on the use of funds derived from waterfowl con-
8 servation stamps.

9 * Sec. 3. AS 16.05 is amended by adding a new section to read:

10 Sec. 16.05.826. WATERFOWL CONSERVATION STAMP CONTEST. (a) The
11 department shall conduct an annual waterfowl conservation stamp design
12 contest for resident Alaska artists. A contest entrant may submit
13 more than one entry. In this subsection, "resident" has the meaning
14 given in AS 01.10.055.

15 (b) The department shall establish a cash prize of \$1,000 for
16 the best entry in each design contest. The commissioner shall desig-
17 nate a judging panel from the public each year to judge the entries
18 made under this section. The waterfowl conservation stamp contest
19 shall be advertised in newspapers of general circulation within the
20 state. The winning design in each contest shall be published in a
21 department publication.

22 * Sec. 4. AS 16.05 is amended by adding new sections to read:

23 Sec. 16.05.828. WATERFOWL CONSERVATION STAMP AND FEE. Using the
24 waterfowl conservation stamp design selected each year under
25 AS 16.05.826, the department shall publish

26 (1) 500 serial numbered waterfowl conservation stamps each
27 year for sale to the public for \$100 per stamp; and

28 (2) unnumbered waterfowl conservation stamps each year for
29 sale to licensed waterfowl hunters for \$5 a stamp.

1 Sec. 16.05.829. REGULATIONS. The commissioner may propose
2 regulations for adoption by the board of game to implement AS 16.05.-
3 826 and 16.05.828.
