6 For an Act entitled: "An Act amending statutory references to the Pacific  
7 time zone; and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 01.10.070(b) is amended to read:

10 (b) The actual effective date of an Act having no effective-  
11 date provision is determined by starting with the day after it is  
12 signed by the governor or the day after the governor's veto is over-  
13 ridden or the day after expiration of the period allowed for gubernatorial  
14 action by art. II, sec. 17 of the Alaska Constitution, and  
15 counting 90 calendar days, the Act becoming effective at 12:01 a.m.,  
16 Alaska [PACIFIC] Standard Time on the 90th day.

18 (c) The actual effective date and time of an Act having an  
19 immediate-effective-date provision is 12:01 a.m., Alaska [PACIFIC]  
20 Standard Time, on the day after it is signed by the governor or on the  
21 day after the governor's veto is overridden or on the day after ex-  
22 piration of the period allowed for gubernatorial action by art. II,  
23 sec. 17 of the Alaska Constitution.

25 (d) An Act which specifies a definite effective date becomes  
26 effective at 12:01 a.m., Alaska [PACIFIC] Standard Time on the date

29 Sec. 24.05.090. REGULAR SESSIONS. The legislature shall convene

1 at the capital each year on the second Monday in January at 10:00 a.m.  
2 [PACIFIC STANDARD TIME]; however, following a gubernatorial election  
3 year the legislature shall convene on the third Monday in January at  
4 10:00 a.m. [PACIFIC STANDARD TIME]. Except as provided in this sec-  
5 tion, each legislature shall have a duration of two years and shall  
6 consist of a "First Regular Session" which shall meet in the odd-  
7 numbered years and a "Second Regular Session" which shall meet in the  
8 even-numbered years and any special session or sessions which the  
9 governor or legislature may find necessary to call.

11 (c) If no stop order is in effect and no proceeding is pending  
12 under AS 45.55.120, a registration statement under this section auto-  
13 matically becomes effective at three o'clock Alaska [PACIFIC] Standard  
14 Time in the afternoon of the second full business day after the filing  
15 of the registration statement or the last amendment, or at an earlier  
16 time as the administrator determines.
