9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
10 * Section 1. AS 15.25.160 is amended to read:
11 Sec. 15.25.160. REQUIRED NUMBER OF SIGNATURES FOR STATEWIDE
12 OFFICE. Petitions for the nomination of candidates for the office of
13 governor, lieutenant governor, United States senator and United States
14 representative shall be signed by qualified voters of the state equal
15 in number to at least one [THREE] percent of the number of ballots
16 [VOTES] cast in the preceding general election at which that office
17 was presented to the voters. Candidates for the office of governor
18 and lieutenant governor shall file jointly.
19 * Sec. 2. AS 15.25.170 is amended to read:
20 Sec. 15.25.170. REQUIRED NUMBER OF SIGNATURES FOR DISTRICT-WIDE
21 OFFICE. Petitions for the nomination of candidates for the office of
22 state senator or state representative shall be signed by qualified
23 voters of the election or senate district in which the proposed nomi-
24 nee desires to be a candidate equal in number to at least one [THREE]
25 percent of the number of ballots [VOTES] cast in the [HIS] respective
26 election or senate district in the preceding general election. A [,
27 PROVIDED THAT NO] nominating petition [NEED CONTAIN MORE THAN 200
28 SIGNATURES NOR] may not [IT] contain less than 50 signatures for any
29 district.

2 (a) Supporters of a candidate for nomination for President of
3 the United States may file a petition to have the name of the candi-
4 date of their choice on the ballot. A petition under this section
5 must be filed by the last Tuesday in February of a presidential elec-
6 tion year and must contain the signatures of qualified voters residing
7 in no less than two-thirds of the election districts of the state
8 equal in number to three [FIVE] percent of the number of ballots
9 [VOTES] cast [FOR THE CANDIDATES FOR GOVERNOR] in the preceding elec-
10 tion for governor. A petition under this section shall include (1)
11 the full name of the candidate; (2) the name of the political group
12 supporting the candidate; (3) the name of the political party in which
13 the candidate is registered; (4) a statement that the subscribers are
14 qualified voters of the state; and (5) a statement that the subscrib-
15 ers request that the candidate's name be placed on the ballot. The
16 signature sheets shall also contain the printed name and residence
17 address of each qualified voter whose signature appears on the peti-
18 tion.

20 (a) A limited political party may be organized for the purpose
21 of selecting candidates for electors of President and Vice President
22 of the United States by filing [A PETITION] with the director at least
23 90 days before a presidential general election a petition signed by
24 qualified voters of this state equaling in number at least one [THREE]
25 percent of Alaska's total vote for President at the last presidential
26 election. The petition shall state that the signers intend to orga-
27 nize a limited political party, that they intend to select candidates
28 for electors of President and Vice President of the United States at
29 the next succeeding presidential election, and the name of the limited

6 political party shall be signed by qualified voters equal in number to
7 at least one [THREE] percent of the number of ballots [VOTES] cast in
8 the [HIS] respective election or senate district in the preceding
9 general election. A [, PROVIDED THAT NO] nominating petition [NEED
10 CONTAIN MORE THAN 200 SIGNATURES NOR] may not [IT] contain less than
11 50 signatures for any district, and shall state in substance that
12 which is required in petitions for nomination for general elections
13 provided in AS 15.25.180.

15 (20) "political party" means an organized [A] group of
