Relating to the eligibility of the

6

University of Alaska's athletic teams

7

for NCAA competition.

8 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES:

WHEREAS National Collegiate Athletic Association (NCAA) regulations  
10 require that schools with Division II status have a student athletic  
11 program consisting of six complete teams; and

12

WHEREAS the University of Alaska Anchorage (UAA) swim team never  
13 anticipated that it would drop below the NCAA required minimum of 11  
14 swimmers during the 1982-1983 school year because of illness, and in one  
15 case because of a failure to meet academic qualifications, thus placing the  
16 UAA men's varsity athletic program in noncompliance with the NCAA  
17 regulations requiring six complete teams; and

WHEREAS the UAA men's athletic varsity teams have been disqualified  
19 from competing in any NCAA national playoff in 1984 as a result of the  
20 unintentional 1982-1983 NCAA infraction because of circumstances beyond  
21 their control; and

WHEREAS the UAA always has made a sincere and good faith effort to  
23 comply with the NCAA regulations, a fact that has been acknowledged by the  
24 NCAA, and the UAA did notify the NCAA of the situation that inadvertently  
25 led to the infraction; and

26

WHEREAS the UAA is today in total compliance with the NCAA Division II  
27 requirements to muster a full-strength men's varsity athletic program; and

WHEREAS the UAA has struggled and worked extremely hard to establish a  
29 strong Division II program in all sports; and

1           WHEREAS disqualification of the UAA athletic teams by the NCAA would  
2 have an adverse impact on this new and growing athletic program and would  
3 no doubt unfairly tarnish UAA's image not only in Alaska but nationally as  
4 well; and

5           WHEREAS the disqualification of UAA teams by the NCAA could inhibit  
6 the university's ability to continue strengthening its athletic program and  
7 to recruit athletes; and

8           WHEREAS the UAA men's hockey team, with an incredible two-year record  
9 of 30 wins and 3 losses, is the pride of Alaska, has gained enormous public  
10 support and accolades for the university's athletic program, and would  
11 almost certainly have qualified for this year's Division II championship  
12 playoffs; and

13           WHEREAS the NCAA's steering committee has stated at its December 1983  
14 meeting that it was never the NCAA's intent that the team size regulation  
15 would penalize a program in UAA's unfortunate situation; and

16           WHEREAS the UAA athletic program honestly and sincerely attempted to  
17 comply with the NCAA regulations and to fulfill the intent of the regu-  
18 lation in question to assure a balanced athletic program; and

19           WHEREAS it is inherent in our system that interpretation and enforce-  
20 ment of the spirit of a law is often more equitable than following the  
21 strict letter of the law; and

22           WHEREAS the citizens of Alaska through the media, through a petition  
23 drive, and through this resolution have shown their overwhelming support  
24 for the UAA Division II athletic program and their concern over the  
25 disqualification of the teams from participation in the NCAA national  
26 playoffs in 1984;

27           BE IT RESOLVED that the Alaska House of Representatives respectfully  
28 requests that the NCAA Administrative Committee officials reconsider the  
29 appeal by the University of Alaska, considering this unique set of

1 circumstances, at their January 26, 1984, meeting; and be it

2       FURTHER RESOLVED that the Alaska House of Representatives supports the  
3 decision of the City of Anchorage to send a citizen delegation to meet with  
4 the NCAA president and other officials to lend support to the UAA appeal;  
5 and be it

6       FURTHER RESOLVED that the NCAA Division II is respectfully urged to  
7 grant UAA a special waiver because this unfortunate situation was beyond  
8 the control of the university's athletic program and its participants.

9       COPIES of this resolution shall be sent to the Honorable Ted Stevens  
10 and the Honorable Frank Murkowski, U.S. Senators, and the Honorable Don  
11 Young, U.S. Representative, members of the Alaska delegation in Congress.
