6 For an Act entitled: "An Act relating to municipal government; and provid-  
7 ing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 29.03 is amended by adding a new section to read:

10 Sec. 29.03.030. PLATTING AUTHORITY. Subject to AS 40.15.075,  
11 the Department of Natural Resources is the platting authority in the  
12 unorganized borough in the area outside all cities.

13 \* Sec. 2. AS 29 is amended by adding a new chapter to read:

14 CHAPTER 04. CLASSIFICATION OF MUNICIPALITIES.

15 Sec. 29.04.010. HOME RULE. A home rule municipality is a  
16 municipal corporation and political subdivision. It is a city or a  
17 borough that has adopted a home rule charter, or it is a unified  
18 municipality. A home rule municipality has all legislative powers not  
19 prohibited by law or charter.

20 Sec. 29.04.020. GENERAL LAW. A general law municipality is a  
21 municipal corporation and political subdivision and is an unchartered  
22 borough or city. It has legislative powers conferred by law.

23 Sec. 29.04.030. CLASSES OF GENERAL LAW. General law municipali-  
24 ties are of five classes:

- 25 (1) first class boroughs;  
26 (2) second class boroughs;  
27 (3) third class boroughs;  
28 (4) first class cities;  
29 (5) second class cities.

1           **Sec. 29.04.040. RECLASSIFICATION OF SECOND CLASS CITIES.** (a) A  
2 second class city may be reclassified as a first class city by holding  
3 an election on the question, if the department determines from the  
4 best figures available that the population of the city has reached 600  
5 permanent residents.

6           (b) An election on the question of reclassification may be ini-  
7 tiated in two ways:

8           (1) a number of voters equal to 15 percent of the number of  
9 votes cast in the city at the preceding regular election may file a  
10 petition with the council; or

11           (2) the council may propose reclassification.

12           (c) The council shall hold at least one public hearing in the  
13 city on the question of reclassification. The council shall then  
14 evaluate the ability of the city to assume first class status and make  
15 its findings public.

16           (d) The council shall, within 30 days after its findings have  
17 been made public, order an election on the question of reclassifica-  
18 tion. The election shall be held at least 30 days after the order and  
19 not later than the next regular election occurring after the 30-day  
20 period. If more than one question is to be voted on at the election,  
21 each shall appear separately on the ballot.

22           (e) The council shall certify the election results to the de-  
23 partment. If the majority of votes cast is favorable, the city shall  
24 be considered reclassified to first class status 30 days after certi-  
25 fication of the election results.

26           **Sec. 29.04.050. RECLASSIFICATION OF SECOND CLASS BOROUGHS.** A  
27 second class borough may reclassify as a first class borough in the  
28 manner provided by AS 29.35.320 - 29.35.330 for the addition of an  
29 areawide power by a first or second class borough, except the petition

1 or proposal requests reclassification instead of requesting addition  
2 of a power.

3 Sec. 29.04.060. RECLASSIFICATION OF THIRD CLASS BOROUGH. (a)

4 A third class borough may reclassify as a first or second class bor-  
5 ough in the manner provided by AS 29.35.320 - 29.35.330 for the addi-  
6 tion of an areawide power by a first or second class borough, except  
7 the petition or proposal requests reclassification instead of request-  
8 ing addition of a power. At the time of voting on reclassification of  
9 a third class borough to first or second class status, voters shall  
10 vote also on whether the borough shall, on reclassification, retain a  
11 combined assembly and school board or elect a separate assembly and  
12 board as otherwise provided for first and second class boroughs.

13 (b) If a combined assembly and school board are approved at the  
14 reclassification election, the assembly serving at the time of the  
15 election continues to serve as the assembly and board on voter ap-  
16 proval of reclassification and until terms of assembly members expire  
17 as provided before reclassification.

18 (c) If a separate assembly and school board are approved at the  
19 reclassification election, a school board shall be elected in confor-  
20 mity with AS 14.12.030 - 14.12.100 at the next regular election, if it  
21 occurs within 90 days of the date of the reclassification election, or  
22 otherwise at a special election within 90 days of the date of the  
23 reclassification election. Expiration dates of terms of school board  
24 members elected at a special election must coincide with the date of  
25 the regular election. Until a board is elected and qualified, the  
26 assembly continues to serve as the board.

27 \* Sec. 3. AS 29 is amended by adding a new chapter to read:

28 CHAPTER 05. INCORPORATION.

29 ARTICLE 1. REQUIREMENTS.

1           Sec. 29.05.010. INCORPORATION OF A CITY. (a) A community that  
2 meets the following standards may incorporate as a home rule or first  
3 class city:

4           (1) the community has 600 or more permanent residents;

5           (2) the boundaries of the proposed city include all areas  
6 necessary to provide municipal services on an efficient scale;

7           (3) the economy of the community includes the human and  
8 financial resources necessary to provide municipal services; in con-  
9 sidering the economy of the community, the Local Boundary Commission  
10 shall consider property values, economic base, personal income, re-  
11 source and commercial development, anticipated functions, and the  
12 expenses and income of the proposed city, including the ability of the  
13 community to generate local revenue;

14           (4) the population of the community is stable enough to  
15 support city government;

16           (5) there is a demonstrated need for city government.

17           (b) A community that meets all the standards under (a) of this  
18 section except (a)(1) may incorporate as a second class city.

19           Sec. 29.05.020. LIMITATIONS ON INCORPORATION OF A CITY. (a) A  
20 community in the unorganized borough may not incorporate as a city if  
21 the services to be provided by the proposed city can be provided by  
22 annexation to an existing city.

23           (b) A community within a borough may not incorporate as a city  
24 if the services to be provided by the proposed city can be provided on  
25 an areawide or nonareawide basis by the borough in which the proposed  
26 city is located, or by annexation to an existing city.

27           Sec. 29.05.030. INCORPORATION OF A BOROUGH. (a) An area that  
28 meets the following standards may incorporate as a home rule, first  
29 class, or second class borough:

1 (1) the population of the area is interrelated and inte-  
2 grated as to its social, cultural, and economic activities, and is  
3 large and stable enough to support borough government;

4 (2) the boundaries of the proposed borough conform gener-  
5 ally to natural geography and include all areas necessary for full  
6 development of municipal services;

7 (3) the economy of the area includes the human and finan-  
8 cial resources capable of providing municipal services; evaluation of  
9 an area's economy includes land use, property values, total economic  
10 base, total personal income, resource and commercial development,  
11 anticipated functions, expenses, and income of the proposed borough;

12 (4) land, water, and air transportation facilities allow  
13 the communication and exchange necessary for the development of inte-  
14 grated borough government.

15 (b) An area may not incorporate as a third class borough.

16 ARTICLE 2. PROCEDURE.

17 Sec. 29.05.060. PETITION. Municipal incorporation is proposed  
18 by filing a petition with the department. The petition shall include  
19 the following information about the proposed municipality:

20 (1) class;

21 (2) name;

22 (3) boundaries;

23 (4) maps, documents, and other information required by the  
24 department;

25 (5) composition and apportionment of the governing body;

26 (6) a proposed operating budget for the municipality pro-  
27 jecting sources of income and items of expenditure through the first  
28 full fiscal year of operation;

29 (7) for a borough, based on the number who voted in the

1        respective areas in the last general election, the signature and  
2        resident address of 15 percent of the voters in

3                (A) home rule and first class cities in the area of  
4        the proposed borough; and

5                (B) the area of the proposed borough outside home rule  
6        and first class cities;

7                (8) for a first class borough, a designation of areawide  
8        powers to be exercised;

9                (9) for a second class borough, a designation of areawide  
10       and nonareawide powers to be exercised;

11               (10) for a first or second class city, a designation of the  
12       powers to be exercised;

13               (11) for a home rule or first class city, based on the  
14       number who voted in the area in the last general election, the signa-  
15       tures and resident addresses of 50 voters in the proposed city or of  
16       15 percent of the voters in the proposed city, whichever is greater;

17               (12) for a second class city, based on the number who voted  
18       in the area in the last general election, the signatures and resident  
19       addresses of 25 voters in the proposed city or of 15 percent of the  
20       voters in the proposed city, whichever is greater;

21               (13) for a home rule municipality, a proposed home rule  
22       charter.

23               Sec. 29.05.070. REVIEW. The department shall review an incorpo-  
24       ration petition for content and signatures and shall return a defi-  
25       cient petition for correction and completion.

26               Sec. 29.05.080. INVESTIGATION. (a) If an incorporation peti-  
27       tion contains the required information and signatures, the department  
28       shall investigate the proposal and shall hold at least one public  
29       informational meeting in the area proposed for incorporation. The

1 department shall publish notice of the meeting.

2 (b) The department may combine incorporation petitions from the  
3 same general area.

4 (c) The department shall report its findings to the Local Bound-  
5 ary Commission with its recommendations regarding the incorporation.

6 Sec. 29.05.090. HEARING. The Local Boundary Commission shall  
7 hold at least one public hearing in the area proposed to be incorpo-  
8 rated for the purpose of receiving testimony and evidence on the  
9 proposal.

10 Sec. 29.05.100. DECISION. (a) If the Local Boundary Commission  
11 determines that a proposed municipality fails to meet the standards  
12 for incorporation, it shall reject the petition. If the commission  
13 determines that the proposed municipality meets the standards, it  
14 shall accept the petition. If the commission determines that the  
15 proposed municipal boundaries can be altered to meet the standards, it  
16 may alter the boundaries and accept the petition.

17 (b) A Local Boundary Commission decision under this section may  
18 be appealed under the Administrative Procedure Act (AS 44.62).

19 Sec. 29.05.110. INCORPORATION ELECTION. (a) The Local Boundary  
20 Commission shall immediately notify the director of elections of its  
21 acceptance of an incorporation petition. Within 30 days after notifi-  
22 cation, the director of elections shall order an election in the pro-  
23 posed municipality to determine whether the voters desire incorpora-  
24 tion and, if so, to elect the initial municipal officials. If incor-  
25 poration is rejected, no officials are elected. The election must be  
26 held not less than 30 or more than 90 days after the date of the  
27 election order. The election order must specify the dates during  
28 which nomination petitions for election of initial officials may be  
29 filed.

1 (b) A voter who has been a resident of the area within the pro-  
2 posed municipality for 30 days before the date of the election order  
3 may vote.

4 (c) Areawide borough powers included in an incorporation peti-  
5 tion are considered to be part of the incorporation question. In an  
6 election for the incorporation of a second class borough, each non-  
7 areawide power to be exercised is placed separately on the ballot.  
8 Adoption of a nonareawide power requires a majority of the votes cast  
9 on the question, and the vote is limited to the voters residing in the  
10 proposed borough but outside all cities in the proposed borough.

11 (d) A home rule charter included in an incorporation petition  
12 under AS 29.05.060(13) is considered to be part of the incorporation  
13 question. The home rule charter is adopted if the voters approve in-  
14 corporation of the municipality.

15 (e) The director of elections shall supervise the election in  
16 the general manner prescribed by the Alaska Election Code (AS 15).  
17 The state shall pay all election costs under this section.

18 Sec. 29.05.120. ELECTION OF INITIAL OFFICIALS. (a) Nominations  
19 for initial municipal officials are made by petition. The petition  
20 shall be in the form prescribed by the director of elections and shall  
21 include the name and address of the nominee and a statement of the  
22 nominee that the nominee is qualified under the provisions of this  
23 title for the office that is sought. A person may file for and occupy  
24 more than one office, but may not serve simultaneously as

25 (1) borough mayor and as a member of the assembly; or

26 (2) city mayor and as a member of the council in a first  
27 class city.

28 (b) Except for a proposed second class city, petitions to nomi-  
29 nate initial officials must include the signature and resident address

1 of 50 voters in the area of the proposed municipality, or that area of  
2 the proposed municipality from which the officials are to be elected  
3 under the composition and apportionment set out in the accepted incor-  
4 poration petition.

5 (c) Petitions to nominate initial officials of a second class  
6 city must include the signature and resident address of 10 voters in  
7 the area of the proposed city.

8 (d) The director of elections shall supervise the election in  
9 the general manner prescribed by the Alaska Election Code (AS 15).  
10 The state shall pay all election costs.

11 (e) The initial elected officials take office on the first  
12 Monday following certification of their election.

13 (f) The initial elected members of the governing body shall  
14 determine by lot the length of their terms of office so that a propor-  
15 tionate number of terms expire each year, resulting in staggered terms  
16 of office for members subsequently elected.

17 Sec. 29.05.130. INTEGRATION OF SPECIAL DISTRICTS AND SERVICE  
18 AREAS. (a) A service area in a newly incorporated municipality shall  
19 be integrated into the municipality within two years after the date of  
20 incorporation. On integration the municipality succeeds to all the  
21 rights, powers, duties, assets and liabilities of the service area.  
22 On integration all property in the service area subject to taxation to  
23 pay the principal and interest on bonds at the time of integration  
24 remains subject to taxation for that purpose.

25 (b) After integration, the municipality may exercise in a former  
26 service area all of the rights and powers exercised by the service  
27 area at the time of integration, and, as successor to the service  
28 area, may levy and collect special charges, taxes, or assessments to  
29 amortize bonded indebtedness incurred by the service area or by a

1 municipality in which the service area was formerly located.

2 Sec. 29.05.140. TRANSITION. (a) The powers and duties exer-  
3 cised by cities and service areas that are succeeded to by a newly  
4 incorporated municipality continue to be exercised by the cities and  
5 service areas until the new municipality assumes the powers and func-  
6 tions, which may not exceed two years after the date of incorporation.  
7 Ordinances, rules, resolutions, procedures, and orders in effect  
8 before the transfer remain in effect until superseded by the action of  
9 the new municipality.

10 (b) Before the assumption, the new municipality shall give  
11 written notice of its assumption of the rights, powers, duties, as-  
12 sets, and liabilities under this section and AS 29.05.130 to the city  
13 or service area concerned. Municipal officials shall consult with the  
14 officials of the city or service area concerned and arrange an orderly  
15 transfer.

16 (c) After the incorporation of a new municipality, no service  
17 area in it may assume new bonded indebtedness, make a contract, or  
18 transfer an asset without the consent of the governing body.

19 (d) This section applies to home rule and general law municipal-  
20 ities.

21 Sec. 29.05.150. CHALLENGE OF LEGALITY. A person may not chal-  
22 lenge the formation of a municipality except within six months after  
23 the date of its incorporation.

#### 24 ARTICLE 3. TRANSITIONAL ASSISTANCE.

25 Sec. 29.05.180. ORGANIZATION GRANTS TO CITIES. (a) To defray  
26 the cost of transition to city government and to provide for interim  
27 government operations, each city incorporated after December 31, 1985  
28 is entitled to an organization grant of \$50,000 for the first full or  
29 partial fiscal year after incorporation.

1 (b) To defray the cost of reclassification, each second class  
2 city in the unorganized borough incorporated before January 1, 1986  
3 that reclassifies as a home rule or first class city after  
4 December 31, 1985 is entitled to an organization grant equal to  
5 \$50,000 for the first full or partial fiscal year after reclassifica-  
6 tion.

7 (c) The department shall disburse an organization grant under  
8 (a) or (b) of this section within 30 days after certification of the  
9 incorporation election or the reclassification election, or as soon  
10 after certification as money is appropriated and available for the  
11 purpose.

12 (d) A city entitled to an organization grant under (a) or (b) of  
13 this section is entitled to a second organization grant of \$25,000.  
14 The department shall disburse the second organization grant within 30  
15 days after the beginning of the city's second fiscal year after incor-  
16 poration or reclassification, or as soon after that time as money is  
17 appropriated and available for the purpose.

18 Sec. 29.05.190. ORGANIZATION GRANTS TO BOROUGHES. (a) For the  
19 purpose of defraying the cost of transition to borough government and  
20 to provide for interim governmental operations, each borough incorpo-  
21 rated after December 31, 1985, is entitled to organization grants as  
22 follows:

23 (1) \$300,000 for the borough's first full or partial fiscal  
24 year;

25 (2) \$200,000 for the borough's second fiscal year; and

26 (3) \$100,000 for the borough's third fiscal year.

27 (b) The department shall disburse the first organization grant  
28 to a borough within 30 days after certification of the incorporation  
29 election favoring incorporation of a borough, or as soon after that as

1 money is appropriated and available for the purpose. The second grant  
2 shall be disbursed within 30 days after the beginning of the borough's  
3 second fiscal year, or as soon after that as money is appropriated and  
4 available for the purpose. The third grant shall be disbursed within  
5 30 days after the beginning of the borough's third fiscal year, or as  
6 soon after that as money is appropriated and available for the pur-  
7 pose.

8 (c) This section does not apply to a borough incorporated by  
9 consolidation or to a unified municipality.

10 Sec. 29.05.200. ORGANIZATION GRANT FUND. (a) The organization  
11 grant fund is established in the department. An appropriation made to  
12 the fund shall be used for organization grants to municipalities that  
13 qualify under AS 29.05.180 or 29.05.190.

14 (b) Before August 31 of each fiscal year the department shall  
15 submit a report to the Department of Administration indicating

16 (1) each municipality expected to qualify to receive an  
17 organization grant during the next fiscal year;

18 (2) the amount of money needed to cover all organization  
19 grants expected to be awarded during the next fiscal year.

20 Sec. 29.05.210. TRANSITIONAL ASSISTANCE TO BOROUGHES. (a)  
21 Within 30 days after the date of incorporation of a borough incorpo-  
22 rated after December 31, 1985, the department shall determine the  
23 population of the borough.

24 (b) The department shall provide assistance to each borough in-  
25 corporated after December 31, 1985, in

26 (1) establishing the initial sales and use tax assessment  
27 and collection department if the borough has adopted a sales or use  
28 tax;

29 (2) determining the initial property tax assessment roll if

1 the borough has adopted a property tax, including contracting for  
2 appraisals of property needed to complete the initial assessment.

3 (c) This section does not apply to a borough incorporated by  
4 consolidation or to a unified municipality.

5 \* Sec. 4. AS 29 is amended by adding a new chapter to read:

6 CHAPTER 06. ALTERATION OF MUNICIPALITIES.

7 ARTICLE 1. CHANGE OF NAME.

8 Sec. 29.06.010. CHANGE OF MUNICIPAL NAME. (a) A municipality  
9 may change its official name by adopting an ordinance for the purpose  
10 that is ratified by the voters and filing the ordinance with the  
11 office of the lieutenant governor. Upon receipt of an ordinance  
12 ratified by the voters, the lieutenant governor shall issue an order  
13 to the municipality changing its name. The name change shall become  
14 effective on a date fixed in the order and occurring within 45 days  
15 after receipt of the ordinance. A copy of the order shall be trans-  
16 mitted to the department.

17 (b) If an ordinance adopted under (a) of this section that  
18 results in a change of the municipal name is subsequently repealed,  
19 the lieutenant governor shall issue an order reinstating the former  
20 name within 45 days after the date of the order, unless a different  
21 name is adopted as provided in (a) of this section.

22 (c) When a municipal name change takes effect by means of an  
23 order issued under (a) or (b) of this section, a civil or criminal  
24 suit, application, petition, hearing or other proceeding to which the  
25 municipality is a party and that is pending at or brought after the  
26 date the name change takes effect shall proceed in the municipal name  
27 as changed by the order.

28 (d) This section applies to home rule and general law municipal-  
29 ities.

1                   ARTICLE 2. ANNEXATION AND DETACHMENT.

2           Sec. 29.06.040. LOCAL BOUNDARY COMMISSION.   (a)   The Local  
3 Boundary Commission may consider any proposed municipal boundary  
4 change. It may reject the proposed change, accept the proposed  
5 change, or alter the boundaries and accept the proposal as altered. A  
6 Local Boundary Commission decision under this subsection may be ap-  
7 pealed under the Administrative Procedure Act (AS 44.62).

8           (b) The Local Boundary Commission may present a proposed muni-  
9 cipal boundary change to the legislature during the first 10 days of a  
10 regular session. The change becomes effective 45 days after presenta-  
11 tion or at the end of the session, whichever is earlier, unless dis-  
12 approved by a resolution concurred in by a majority of the members of  
13 each house.

14           (c) In addition to the regulations governing annexation by local  
15 action adopted under AS 44.47.567, the Local Boundary Commission shall  
16 establish procedures for annexation and detachment of territory by  
17 municipalities by local action. The procedures established under this  
18 subsection include a provision that

19                   (1) a proposed annexation and detachment must be approved  
20 by a majority of votes on the question cast by voters residing in the  
21 area proposed to be annexed or detached;

22                   (2) municipally owned property adjoining the municipality  
23 may be annexed by ordinance without voter approval; and

24                   (3) an area adjoining the municipality may be annexed by  
25 ordinance without an election if all property owners and voters in the  
26 area petition the governing body.

27           (d) A boundary change effected under (a) and (b) of this section  
28 prevails over a boundary change initiated by local action, without  
29 regard to priority in time.

1           Sec. 29.06.050. ANNEXATION OF MILITARY RESERVATIONS. A military  
2 reservation may be annexed to a municipality in the same manner as  
3 prescribed for other territory under AS 29.06.040. If a city in a  
4 borough annexes a military reservation under this section, the area  
5 encompassing the military reservation automatically is annexed to the  
6 borough in which the city is located.

7           Sec. 29.06.060. APPLICATION. AS 29.06.040 - 29.06.060 apply to  
8 home rule and general law municipalities.

9                           ARTICLE 3. MERGER AND CONSOLIDATION.

10           Sec. 29.06.090. MERGER AND CONSOLIDATION. (a) Two or more  
11 municipalities may merge or consolidate to form a single municipality,  
12 except a third class borough may not be formed through merger or  
13 consolidation.

14                   (b) Two methods may be used to initiate merger or consolidation  
15 of municipalities:

16                           (1) petition to the Local Boundary Commission under regula-  
17 tions adopted by the commission; or

18                           (2) the local option method specified in AS 29.06.100 -  
19 29.06.160.

20           Sec. 29.06.100. PETITION. (a) Residents of two or more munici-  
21 palities may file a merger or consolidation petition with the depart-  
22 ment. The petition must be signed by a number of voters of each  
23 existing municipality equal to at least 25 percent of the number of  
24 votes cast in each municipality's last regular election.

25                   (b) The petition includes

26                           (1) the name and class of each existing municipality;

27                           (2) the name and class of the proposed municipality;

28                           (3) the proposed composition and apportionment of the  
29 governing body;

1           (4) maps, documents, and other information that shows that  
2 the proposed municipality meets the standards for municipal incorpora-  
3 tion.

4           Sec. 29.06.110. REVIEW. (a) The department shall review a  
5 merger or consolidation petition for content and signatures and shall  
6 return a deficient petition for correction or completion.

7           (b) If the petition contains the required information and signa-  
8 tures, the department shall investigate the proposal.

9           (c) The department shall report its findings to the Local Bound-  
10 ary Commission with its recommendations regarding the merger or con-  
11 solidation.

12          Sec. 29.06.120. HEARING. After receipt of the report by the  
13 department on a merger or consolidation petition, the Local Boundary  
14 Commission shall hold at least one public hearing in each of the  
15 existing municipalities included in the petition, unless officials of  
16 the municipalities agree to a single hearing.

17          Sec. 29.06.130. DECISION. (a) If the Local Boundary Commission  
18 determines that the proposed municipality fails to meet the standards  
19 for incorporation, it shall reject the merger or consolidation peti-  
20 tion. If the commission determines that the proposed municipality  
21 meets these standards, it shall accept the petition. If the commis-  
22 sion determines that the proposed boundaries or the composition and  
23 apportionment of the governing body can be altered to meet the stan-  
24 dards, it may alter the proposal and accept the petition.

25          (b) A Local Boundary Commission decision under this section may  
26 be appealed under the Administrative Procedure Act (AS 44.62).

27          Sec. 29.06.140. ELECTION. (a) The Local Boundary Commission  
28 shall immediately notify the director of elections of its acceptance  
29 of a merger or consolidation petition. Within 30 days after

1 notification, the director of elections shall order an election in the  
2 area to be included in the new municipality to determine whether the  
3 voters desire merger or consolidation. The election must be held not  
4 less than 30 or more than 90 days after the election order. A voter  
5 who is a resident of the area to be included in the proposed muni-  
6 cipality may vote.

7 (b) The director of elections shall supervise the election in  
8 the general manner prescribed by the Alaska Election Code (AS 15).

29 **Sec. 29.06.190. UNIFICATION OF MUNICIPALITIES AUTHORIZED. A**

1 borough and all cities in the borough may unite to form a single unit  
2 of home rule government by complying with AS 29.06.190 - 29.06.410.

3 Sec. 29.06.200. UNIFICATION PROPOSED. (a) Formation of a  
4 charter commission to prepare a unification charter shall be proposed  
5 by resolution of the assembly or by petition. A resolution to propose  
6 formation of a charter commission may be adopted not more often than  
7 once every 12 months.

8 (b) An assembly, a council, or a person living in the area  
9 proposed for unification may initiate a unification petition.

10 Sec. 29.06.210. PETITION REQUIREMENTS. (a) A unification peti-  
11 tion shall read:

12 "PETITION FOR ELECTION OF CHARTER COMMISSION TO PROPOSE UNIFICA-  
13 TION CHARTER. We, the undersigned, qualified voters of the borough do  
14 hereby petition that the following proposition be placed before the  
15 voters as provided by law: 'Shall a charter commission be formed (and

25 (b) The petition shall be signed by at least

26 (1) the number of voters residing outside all home rule and

1 class cities in the borough equal to 25 percent of the votes cast in  
2 all home rule and first class cities in the borough in the last regu-

4 Sec. 29.06.220. REVIEW OF PETITION. The assembly shall review a  
5 unification petition within 15 days to determine whether it complies  
6 with AS 29.06.210. If the petition does not meet the designated re-

20 Sec. 29.20.180. FILLING A VACANCY. (a) If a vacancy occurs in  
21 a governing body, the remaining members shall, within 30 days unless a  
22 different period is provided by ordinance, appoint a qualified person  
23 to fill the vacancy. If less than 30 days remain in a term, a vacancy  
24 may not be filled.

25 (b) Notwithstanding (a) of this section, if the membership is

8 (b) The mayor acts as ceremonial head of government, executes  
9 official documents on authorization of the governing body, and is  
10 responsible for additional duties and powers prescribed by this chap-

12 (c) This section applies to home rule and general law municipal-

14 Sec. 29.20.230. ELECTION AND TERM OF MAYOR. (a) The mayor of a  
15 borough or first class city is elected at large. The mayor of a  
16 borough or first class city serves a term of three years, unless by  
17 ordinance a different term not to exceed four years is provided. The  
18 current term of an incumbent mayor may not be altered. The regular  
19 term of a mayor of a borough or first class city begins on the first

4 voter of the municipality is eligible to hold the office of mayor in a  
5 borough or first class city. A member of the city council is eligible  
6 to hold the office of mayor in a second class city.

7 (b) Residency requirements for the office of mayor not exceeding  
8 three years may be prescribed by ordinance.

9 Sec. 29.20.250. POWERS AND DUTIES OF MAYOR. (a) If a munici-  
10 pality has not adopted a manager plan of government, the mayor is the  
11 chief administrator and the mayor has the same powers and duties as  
12 those of a manager under AS 29.20.500.

13 (b) The mayor may take part in the discussion of a matter before  
14 the governing body. The mayor may not vote, except that the mayor of

15 election or appointment;

16 (2) unless excused by the governing body, is physically  
17 absent for 90 consecutive days;

18 (3) resigns and the resignation is accepted;

29 (b) A vacancy in the office of mayor occurring six months before

1 a regular election shall be filled by the governing body. The person  
2 appointed serves until the next regular election when a successor is

4 ing body is appointed mayor, the member shall resign the seat on the  
5 governing body. If a vacancy occurs more than six months before a

17 the utility.

18 Sec. 29.20.320. OTHER BOARDS AND COMMISSIONS. (a) The govern-  
19 ing body may by ordinance establish advisory, administrative, techni-  
20 cal, or quasi-judicial boards and commissions.

21 (b) Members of boards and commissions, except for members of the  
22 board of adjustment and assembly members serving on the board of  
23 equalization, are appointed by the mayor and confirmed by the govern-

25 ARTICLE 5. OTHER OFFICIALS AND EMPLOYEES.

26 Sec. 29.20.360. APPOINTMENT OF OFFICIALS. Unless otherwise pro-  
27 vided by ordinance, the municipal clerk, attorney, treasurer, and  
28 police chief are appointed by the chief administrator. Unless other-  
29 wise provided by ordinance, an official described in this section

1 serves at the pleasure of the appointing authority and, if appointed  
2 by the chief administrator, must be confirmed by the governing body.

3 Sec. 29.20.370. MUNICIPAL ATTORNEY. The municipal attorney is  
4 the legal advisor of the governing body, the school board, and the  
5 other officials of the municipality. The municipal attorney repre-  
6 sents the municipality as attorney in civil and criminal proceedings.  
7 The school board may hire independent counsel when in its judgment  
8 independent counsel is needed.

9 Sec. 29.20.380. MUNICIPAL CLERK. (a) The municipal clerk shall

10 (1) give notice of the time and place of meetings of the

26 inquiries into the conduct of a municipal department;

13 of-way, facility, or service;

18 cooperative or joint administration of any function or power with a  
19 municipality, the state, or the United States;

21 Sec. 29.35.020. EXTRATERRITORIAL JURISDICTION. (a) To the  
22 extent a municipality is otherwise authorized by law to exercise the  
23 power necessary to provide the facility or service, the municipality

13 Sec. 29.35.080. ALCOHOLIC BEVERAGES. (a) A municipality may  
14 regulate the barter, sale, importation, and consumption of alcoholic  
15 beverages in accordance with AS 04.11.480 - 04.11.506 and AS 04.21.-  
16 010.

17 (b) This section applies to home rule and general law munici-  
18 palities.

19 Sec. 29.35.090. MUNICIPAL PROPERTY. The governing body shall by  
20 ordinance establish a formal procedure for acquisition and disposal of  
21 land and interests in land by the municipality.

22 Sec. 29.35.100. BUDGET AND CAPITAL PROGRAM. (a) The governing  
23 body shall establish the manner for the preparation and submission of  
24 the budget and capital program. After a public hearing, the governing  
25 body may approve the budget with or without amendments, and shall  
26 appropriate the money required for the approved budget.

27 (b) The governing body may make supplemental and emergency  
28 appropriations. Payment may not be authorized or made and an obliga-

2 Sec. 29.35.140. REGULATION OF TRANSPORTATION CARRIERS. A

2 (b) Taxes levied by a city shall be collected by a borough and  
3 returned in full to the levying city. This subsection applies to home  
4 rule and general law municipalities.

5 Sec. 29.35.180. LAND USE REGULATION. (a) A first or second  
6 class borough shall provide for planning, platting, and land use  
7 regulation in accordance with AS 29.40.

8 (b) A home rule borough shall provide for planning, platting,

11 Sec. 29.35.200. FIRST CLASS BOROUGH POWERS. (a) A first class  
12 borough may exercise by ordinance on a nonareawide basis any power not

26 Sec. 29.35.210. SECOND CLASS BOROUGH POWERS. (a) A second  
27 class borough may by ordinance exercise the following powers on a  
28 nonareawide basis:

- 1           (2) regulate the offering for sale, exposure for sale,  
2 sale, use or explosion of fireworks;
- 3           (3) license, impound, and dispose of animals;
- 4           (4) provide garbage, solid waste, and septic waste col-

- 8           (6) provide water pollution control;

- 18           (b) A second class borough may by ordinance exercise the follow-  
19 ing powers on an areawide basis:

- 24           (4) provide water pollution control;

6 Sec. 29.35.220. THIRD CLASS BOROUGH POWERS. (a) A third class  
7 borough may borrow money and issue negotiable or nonnegotiable bonds  
8 or other evidences of indebtedness as provided by AS 29.47.

9 (b) Areawide exercise of a power by a third class borough other  
10 than education and tax assessment and collection is not authorized.

11 (c) A third class borough may acquire the power to provide for  
12 planning, platting, and land use regulation as provided in AS 29.40  
13 for first and second class boroughs, except the power may only be  
14 exercised within a service area.

15 (d) A third class borough may acquire any power not otherwise  
16 prohibited by law, except the power may only be exercised within a  
17 service area.

18 ARTICLE 4. CITY POWERS.

19 Sec. 29.35.250. CITIES INSIDE BOROUGHES. (a) A city inside a  
20 borough may exercise any power not otherwise prohibited by law.

21 (b) On adoption of a borough ordinance to provide for areawide  
22 exercise of a power, no city may exercise the power unless the borough  
23 ordinance provides otherwise or the borough by ordinance ceases to  
24 exercise the power.

25 (c) A home rule city in a third class borough shall provide for  
26 planning, platting, and land use regulation as provided by AS 29.35.-  
27 180(b) for home rule boroughs. A first class city in a third class  
28 borough shall provide for planning, platting, and land use regulation  
29 as provided by AS 29.35.180(a) for first and second class boroughs. A

1 second class city in a third class borough may provide for planning,  
2 platting, and land use regulation as provided by AS 29.35.180(a) for  
3 first and second class boroughs.

4 (d) This section applies to home rule and general law cities.

5 Sec. 29.35.260. CITIES OUTSIDE BOROUGHES. (a) A city outside a  
6 borough may exercise a power not otherwise prohibited by law. A  
7 provision that is incorporated by reference to laws governing boroughs  
8 applies to home rule cities outside boroughs only if the provision is  
9 made applicable to home rule boroughs.

10 (b) A home rule or first class city outside a borough is a city  
11 school district and shall establish, operate, and maintain a system of  
12 public schools as provided by AS 29.35.160 for boroughs. A second  
13 class city outside a borough is not a school district and may not

10 transferred to it by a city.

11 Sec. 29.35.320. INITIATION OF ACQUISITION OF POWER. (a) An  
12 election on the question of adding an areawide power in a first class

7 Within 60 days after its findings have been made public, the assembly

9 Sec. 29.35.330. ELECTION. (a) If more than one power is pro-

23           Sec. 29.35.350. DEFINITION. In AS 29.35.200 - 29.35.350,  
 24 "power" means the provision of a public facility or service, or the  
 25 exercise of a regulatory power.

26           ARTICLE 6. CONSTRUCTION OF POWERS.

27           Sec. 29.35.400. GENERAL CONSTRUCTION. A liberal construction  
 28 shall be given to all powers and functions of a municipality conferred  
 29 in this title.

1           Sec. 29.35.410. EXTENT OF POWERS. Unless otherwise limited by  
2 law, a municipality has and may exercise all powers and functions  
3 necessarily or fairly implied in or incident to the purpose of all  
4 powers and functions conferred in this title.

5           Sec. 29.35.420. ENUMERATION OF POWERS. Specific examples in an  
6 enumerated power or function conferred upon a municipality in this  
7 title is illustrative of the object and not a limitation on or exclu-  
8 sion from the exercise of the power or function.

9                           ARTICLE 7. SERVICE AREAS.

10           Sec. 29.35.450. SERVICE AREAS. (a) A service area to provide  
11 special services in a borough may be established, operated, altered,  
12 or abolished by ordinance. Special services include services not  
13 provided on an areawide or nonareawide basis in the borough, or a  
14 higher or different level of service than that provided on an areawide  
15 or nonareawide basis. The borough may include a city in a service  
16 area if

17                           (1) the city agrees by ordinance; or

18                           (2) approval is granted by a majority of voters residing in  
19 the city, and by a majority of voters residing inside the boundaries

29 the levying of taxes, charges, or assessments in a service area to

1 finance the special services. If the assembly authorizes the levying  
2 of taxes, charges, or assessments, the rate of taxation and the issu-

4 Sec. 29.35.480. SERVICE AREAS IN FIRST CLASS BOROUGHS. In a  
5 first class borough, the assembly may exercise in a service area any  
6 power granted a first class city by law. The assembly may exercise in

9 Sec. 29.35.490. SERVICE AREAS IN SECOND AND THIRD CLASS BOR-  
10 OUGHS. (a) A second class borough may exercise in a service area any  
11 power granted a first class city by law or a nonareawide power that

13 (1) the exercise of the power is approved by a majority of

4 Sec. 29.40.010. PLANNING, PLATTING, AND LAND USE REGULATION.

5 (a) A first or second class borough shall provide for planning,  
6 platting, and land use regulation on an areawide basis.

7 (b) If a city in a borough consents by ordinance, the assembly  
8 may by ordinance delegate any of its powers and duties under this  
9 chapter to the city. The assembly may by ordinance, without first  
10 obtaining the consent of the city, revoke any power or duty delegated  
11 under this section.

12 Sec. 29.40.020. PLANNING COMMISSION. (a) Each first and second  
13 class borough shall establish a planning commission consisting of five  
14 residents unless a greater number is required by ordinance. Commis-  
15 sion membership shall be apportioned so that the number of members  
16 from home rule and first class cities reflects the proportion of  
17 borough population residing in home rule and first class cities lo-

8 and public, of the first or second class borough, and may include, but  
9 is not limited to, the following:

10 (1) statements of policies, goals, and standards;

11 (2) a land use plan;

12 (3) a community facilities plan;

13 (4) a transportation plan; and

14 (5) recommendations for implementation of the comprehensive  
15 plan.

16 (b) With the recommendations of the planning commission, the  
17 assembly shall adopt by ordinance a comprehensive plan. The assembly  
18 shall, after receiving the recommendations of the planning commission,

21 Sec. 29.40.040. LAND USE REGULATION. (a) In accordance with a  
22 comprehensive plan adopted under AS 29.40.030 and in order to imple-

14           (3) street width, arrangement, and rights-of-way, including

23 Sec. 29.40.110. PLAT PROCEDURE. (a) The platting authority  
24 shall approve or disapprove a plat within 60 days after it is filed,  
25 or shall return it to the applicant for modification or correction.  
26 Unless the applicant for plat approval consents to an extension of  
27 time, the plat is considered approved and a certificate of approval

15 (c) The provisions of (a) of this section notwithstanding,

16 (1) a borough may, by ordinance, adjust its property tax  
17 structure in whole or in part to the property tax structure of a city  
18 in the borough, including but not limited to, excluding personal  
19 property from taxation, establishing exemptions, and extending the  
20 redemption period;

21 (2) a home rule or first class city has the same power to  
22 grant exemptions or exclude property from borough taxes that it has as

15 other nonfarm purpose. The assessor shall maintain records valuing

22       attributable to the land. Failure to make the filing required in this  
23       subsection forfeits the exemption.

24            (d) In the event of a crop failure by an act of God the previous  
25       year, the owner or lessee may submit an affidavit affirming that 10  
26       percent of gross income for the past three years was from farming.

27            (e) Subject to legislative appropriations for the purpose, the  
28       state shall reimburse a borough or city, as appropriate, for the prop-  
29       erty tax revenues lost to it by the operation of this section.

1           Sec. 29.45.070. MOBILE HOMES. Mobile homes, trailers, house  
2 trailers, trailer coaches and similar property used or intended to be  
3 used for residential, office, or commercial purposes and attached to  
4 the land or connected to water, gas, electric, or sewage facilities  
5 are classified as real property for tax purposes unless expressly  
6 classified as personal property by ordinance. This section does not  
7 apply to house trailers and mobile homes that are unoccupied and held  
8 for sale by persons engaged in the business of selling mobile homes.

9           Sec. 29.45.080. TAX ON OIL AND GAS PRODUCTION AND PIPELINE PROP-  
10 ERTY. (a) A municipality may levy and collect taxes on taxable  
11 property taxable under AS 43.56 only by using one of the methods set  
12 out in (b) or (c) of this section.

13           (b) A municipality may levy and collect a tax on the full and  
14 true value of taxable property taxable under AS 43.56 as valued by the  
15 Department of Revenue at a rate not to exceed that which produces an  
16 amount of revenue from the total municipal property tax equivalent to  
17 \$1,500 a year for each person residing in its boundaries.

18           (c) A municipality may levy and collect a tax on the full and  
19 true value of that portion of taxable property taxable under AS 43.56  
20 as assessed by the Department of Revenue which value, when combined  
21 with the value of property otherwise taxable by the municipality, does  
22 not exceed the product of 225 percent of the average per capita  
23 assessed full and true value of property in the state multiplied by  
24 the number of residents of the taxing municipality.

25           (d) By February 1 of each assessment year a taxing municipality  
26 must inform the Department of Revenue which method of taxation the  
27 municipality will use.

28           (e) For purposes of this section, population shall be determined  
29 by the commissioner based on the latest statistics of the United

1 States Bureau of the Census or on other reliable population data, and  
2 the commissioner shall advise each municipality of its population by  
3 January 15 of each year.

4 Sec. 29.45.090. TAX LIMITATION. (a) A municipality may not,  
5 during a year, levy and tax for any purpose in excess of three percent  
6 of the assessed value of property in the municipality. All property  
7 on which a tax is levied shall be taxed at the same rate during the  
8 year.

9 (b) A municipality, or combination of municipalities occupying  
10 the same geographical area, in whole or in part, may not levy taxes

11 (1) that will result in tax revenues from all sources ex-  
12 ceeding \$1,500 a year for each person residing within the municipal  
13 boundaries; or

14 (2) upon value that, when combined with the value of prop-  
15 erty otherwise taxable by the municipality, exceeds the product of 225  
16 percent of the average per capita assessed full and true value of  
17 property in the state multiplied by the number of residents of the  
18 taxing municipality.

19 (c) The commissioner shall apportion the lawful levy and equi-  
20 tably divide the tax revenues on the basis of need, services per-  
21 formed, and other considerations in the public interest if two or more  
22 municipalities occupying the same geographical area, in whole or in  
23 part, attempt to levy a tax

24 (1) the combined levy of which would result in tax revenues  
25 from all sources exceeding \$1,500 a year for each person residing  
26 within the municipal boundaries; or

27 (2) upon value that, when combined with the value of prop-  
28 erty otherwise taxable by the municipality, exceeds the product of 225  
29 percent of the average per capita assessed full and true value of

1 property in the state multiplied by the number of residents of the  
2 taxing municipality.

3 (d) For the purpose of (b) and (c) of this section, population  
4 shall be determined by the commissioner based on the latest statistics  
5 of the United States Bureau of the Census or on other reliable popula-  
6 tion data.

7 Sec. 29.45.100. NO LIMITATIONS ON TAXES TO PAY BONDS. The  
8 limitations provided for in AS 29.45.080 - 29.45.090 do not apply to  
9 taxes levied or pledged to pay or secure the payment of the principal  
10 and interest on bonds. Taxes to pay or secure the payment of princi-  
11 pal and interest on bonds may be levied without limitation as to rate  
12 or amount, regardless of whether the bonds are in default or in danger  
13 of default.

14 Sec. 29.45.103. TAXATION RECORDS. (a) Municipal records deal-  
15 ing with assessment, valuation or taxation may be inspected by the  
16 State Assessor or a designee.

17 (b) If a municipality's assessment and valuation has been done  
18 by a private contractor, records concerning the municipality's valua-  
19 tion and assessment shall be made available to the State Assessor or a  
20 designee on request.

21 Sec. 29.45.105. ERRORS IN TAXATION PROCEDURES. (a) If a  
22 municipality receives a notice from the State Assessor that major  
23 errors have been found in its assessment, valuation or taxation proce-  
24 dures, the municipality shall correct its procedures before the begin-  
25 ning of the next fiscal year or file an appeal under (b) of this  
26 section.

27 (b) A municipality may appeal a notice from the State Assessor  
28 that it has made a major error in assessment, valuation or taxation  
29 procedures by filing an appeal with the commissioner within 30 days

1 after receipt of notice of error.

2 (c) The commissioner, after consulting with the Alaska Associa-  
3 tion of Assessing Officers, shall render a decision within 60 days  
4 after the receipt of a request under (b) of this section. If the  
5 commissioner determines that a major error has been made in assess-  
6 ment, valuation or taxation procedures the commissioner shall notify  
7 the municipality of changes that must be made and the municipality  
8 shall correct its procedures before the beginning of the next fiscal  
9 year.

10 (d) If errors in its assessment, valuation or taxation proce-  
11 dures have resulted in a loss of revenue to the state, the municipal-  
12 ity shall reimburse the state for the amount of revenues lost.

13 Sec. 29.45.110. FULL AND TRUE VALUE. (a) The assessor shall  
14 assess property at its full and true value as of January 1 of the  
15 assessment year, except as provided in this section, AS 29.45.060, and  
16 29.45.230. The full and true value is the estimated price that the  
17 property would bring in an open market and under the then prevailing  
18 market conditions in a sale between a willing seller and a willing  
19 buyer both conversant with the property and with prevailing general  
20 price levels.

21 (b) Assessment of business inventories may be based on the  
22 average monthly method of assessment rather than the value existing on  
23 January 1. The method used to assess business inventories shall be  
24 prescribed by the governing body.

25 (c) In the case of cessation of business during the tax year,  
26 the municipality may provide for reassessment of business inventories  
27 using the average monthly method of assessment for the tax year rather  
28 than the value existing on January 1 of the tax year, and for reduc-  
29 tion and refund of taxes. In enacting an ordinance authorized by this

1 section, the municipality may prescribe procedures, restrictions, and  
2 conditions of assessing or reassessing business inventories and of  
3 remitting or refunding taxes.

4 Sec. 29.45.120. RETURNS. (a) The municipality may require each  
5 person having ownership or control of or an interest in property to  
6 submit a return in the form prescribed by the assessor, based on prop-  
7 erty values existing on January 1, except as otherwise provided in  
8 this chapter.

9 (b) The assessor may, by written notice, require a person to  
10 provide additional information within 30 days.

11 Sec. 29.45.130. INDEPENDENT INVESTIGATION. (a) The assessor is  
12 not bound to accept a return as correct. The assessor may make an  
13 independent investigation of property returned or of taxable property  
14 on which no return has been filed. In either case, the assessor may  
15 make the assessor's own valuation of the taxable property and this  
16 valuation is prima facie evidence of the value of the property.

17 (b) For investigation, the assessor or the assessor's agent may  
18 enter a premise during reasonable hours and may examine property on  
19 the premise. The assessor or the assessor's agent may examine all  
20 property records involved. A person shall, on request, furnish to the  
21 assessor or the assessor's agent every facility and assistance for the  
22 investigation. The assessor may seek a court order to compel entry  
23 and production of records needed for assessment purposes.

24 (c) An assessor may examine a person on oath. On request, the  
25 person shall submit to examination at a reasonable time and place  
26 selected by the assessor.

27 Sec. 29.45.140. VIOLATIONS. For knowingly failing to file a tax  
28 statement required by ordinance or knowingly making a false affidavit  
29 to a statement required by a tax ordinance relative to the amount,

1 location, kind or value of property subject to taxation with intent to  
2 evade the taxation, a municipality may by ordinance prescribe a  
3 penalty not to exceed a fine of \$1,000 or imprisonment for 90 days.

4 Sec. 29.45.150. REEVALUATION. A systematic reevaluation of  
5 taxable real and personal property undertaken by the assessor, whether  
6 of specific areas in which real property is located or of specific  
7 classes of real or personal property to be assessed, shall be made  
8 only in accordance with a resolution or other act of the municipality  
9 directing a systematic reevaluation of all taxable property in the  
10 municipality over the shortest period of time practicable, as fixed in  
11 the resolution or act.

12 Sec. 29.45.160. ASSESSMENT ROLL. (a) The assessor shall pre-  
13 pare an annual assessment roll. The roll shall contain

- 14 (1) a description of all taxable property;  
15 (2) the assessed value of all taxable property;  
16 (3) the names and addresses of persons with property sub-  
17 ject to assessment and taxation.

18 (b) The assessor may list real property by any description that  
19 may be made certain. Real property is assessed to the record owner.  
20 The district recorder shall at least monthly provide the assessor a  
21 copy of each recorded change of ownership showing the name and mailing  
22 address of the owner and the name and mailing address of the person  
23 recording the change of ownership. Other persons having an interest  
24 in the property may be listed on the assessment records with the  
25 owner. The person in whose name property is listed as owner is conclu-  
26 sively presumed to be the legal record owner. If the property owner  
27 is unknown, the property may be assessed to "unknown owner". An  
28 assessment is not invalidated by a mistake, omission, or error in the  
29 name of the owner, if the property is correctly described.

1           Sec. 29.45.170. ASSESSMENT NOTICE. (a) The assessor shall give  
2 each person named in the assessment roll a notice of assessment,  
3 showing the assessed value of the person's property. On each notice  
4 is printed a brief summary of the dates when taxes are payable, delin-  
5 quent, and subject to penalty and interest, and the dates when the  
6 board of equalization will sit.

7           (b) Sufficient assessment notice is given if mailed by first  
8 class mail 30 days before the equalization hearings. If the address  
9 is not known to the assessor, the notice may be addressed to the  
10 person at the post office nearest the property. Notice is effective  
11 on the date of mailing.

12           Sec. 29.45.180. CORRECTIONS. (a) A person receiving an assess-  
13 ment notice shall advise the assessor of errors or omissions in the  
14 assessment of the person's property. The assessor may correct errors  
15 or omissions in the roll before the board of equalization hearing.

16           (b) If errors found in the preparation of the assessment roll  
17 are adjusted, the assessor shall mail a corrected notice allowing 30  
18 days for appeal to the board of equalization.

19           Sec. 29.45.190. APPEAL. (a) A person whose name appears on the  
20 assessment roll or the agent or assigns of that person may appeal to  
21 the board of equalization for relief from an alleged error in valua-  
22 tion not adjusted by the assessor to the taxpayer's satisfaction.

23           (b) The appellant shall, within 30 days after the date of mail-  
24 ing of notice of assessment, submit to the assessor a written appeal  
25 specifying grounds in the form that the board of equalization may  
26 require. Otherwise, the right of appeal ceases unless the board of  
27 equalization finds that the taxpayer was unable to comply.

28           (c) The assessor shall notify an appellant by mail of the time  
29 and place of hearing.

1 (d) The assessor shall prepare for use by the board of equaliza-  
2 tion a summary of assessment data relating to each assessment that is  
3 appealed.

4 (e) A city in a borough may appeal an assessment to the borough  
5 board of equalization in the same manner as a taxpayer. Within five  
6 days after receipt of the appeal, the assessor shall notify the person  
7 whose property assessment is being appealed by the city.

8 Sec. 29.45.200. BOARD OF EQUALIZATION. (a) The governing body  
9 sits as a board of equalization for the purpose of hearing an appeal  
10 from a determination of the assessor, or it may delegate this author-  
11 ity to one or more boards appointed by it. An appointed board may be  
12 composed of not less than three persons, who may be members of the  
13 governing body, municipal residents, or a combination of members of  
14 the governing body and residents. The governing body shall by ordi-  
15 nance establish the qualifications for membership.

16 (b) The board of equalization is governed in its proceedings by  
17 rules adopted by ordinance that are consistent with general rules of

23 Sec. 29.45.210. HEARING. (a) If an appellant fails to appear,  
24 the board of equalization may proceed with the hearing in the absence  
25 of the appellant.

26 (b) The appellant bears the burden of proof. The only grounds  
27 for adjustment of assessment are proof of unequal, excessive, im-  
28 proper, or under valuation based on facts that are stated in a valid  
29 written appeal or proven at the appeal hearing. If a valuation is

1 found to be too low, the board of equalization may raise the assess-  
2 ment.

3 (c) The board of equalization shall certify its actions to the  
4 assessor within seven days. Except as to supplementary assessments,  
5 the assessor shall enter the changes and certify the final assessment  
6 roll by June 1.

7 (d) An appellant or the assessor may appeal a determination of  
8 the board of equalization to the superior court as provided by rules  
9 of court applicable to appeals from the decisions of administrative  
10 agencies. Appeals are heard on the record established at the hearing  
11 before the board of equalization.

12 Sec. 29.45.220. SUPPLEMENTARY ASSESSMENT ROLLS. The assessor  
13 shall include property omitted from the assessment roll on a supple-  
14 mentary roll, using the procedures set out in this chapter for the  
15 original roll.

16 Sec. 29.45.230. TAX ADJUSTMENTS ON PROPERTY AFFECTED BY A NATU-  
17 RAL DISASTER. (a) The municipality may provide for assessment or  
18 reassessment and reduction of taxes for property destroyed, damaged,  
19 or otherwise reduced in value as a result of a natural disaster.

20 (b) An assessment or reassessment under this section may be made  
21 by the assessor only upon the receipt of a sworn statement of the tax-  
22 payer that losses exceed \$1,000. A reduction of taxes may be made  
23 only on losses in excess of \$1,000 for the remainder of the year  
24 following the disaster. On reassessment, the municipality shall  
25 recompute this tax and refund taxes that have already been paid.

26 (c) The municipality shall give notice of assessment or re-  
27 assessment under this section and shall hold an equalization hearing  
28 as provided in this chapter, except that a notice of appeal must be  
29 filed with the board of equalization within 10 days after notice of

1 assessment or reassessment is given to the person appealing. Other-  
2 wise, the right of appeal ceases unless the board finds that the  
3 taxpayer is unable to comply.

4 (d) In enacting an ordinance or resolution authorized by this  
5 section the municipality may, consistent with this section, prescribe  
6 procedures, restrictions, and conditions of assessing or reassessing  
7 property and of remitting, refunding, or forgiving taxes.

8 (e) In this section "disaster" means a major disaster declared  
9 by the President of the United States under the provisions of 42  
10 U.S.C. sec. 1855 - 1855g (Federal Disaster Act of 1950), or other  
11 federal law, or a disaster declared by the governor under AS 26.-  
12 23.010 - 26.23.110.

13 Sec. 29.45.240. TAX LEVY AND RATE. (a) The power granted to a  
14 municipality to assess, levy, and collect a property tax shall be  
15 exercised by means of an ordinance. The rate of levy, the date of  
16 equalization, and the date when taxes become delinquent shall be fixed  
17 by resolution.

18 (b) A municipality shall annually determine the rate of levy  
19 before June 15. By July 1 the tax collector shall mail tax statements  
20 setting out the levy, dates when taxes are payable and delinquent, and  
21 penalties and interest.

22 Sec. 29.45.250. RATES OF PENALTY AND INTEREST. (a) A penalty  
23 not to exceed 20 percent of the tax due may be added to all delinquent  
24 taxes, and interest not to exceed 15 percent a year shall accrue upon

6 ARTICLE 2. ENFORCEMENT OF TAX LIENS.

7 Sec. 29.45.290. VALIDITY. Certified assessment and tax rolls  
8 are valid and binding on all persons, notwithstanding a defect, error,  
9 omission, or invalidity in the assessment rolls or proceedings per-  
10 taining to the assessment roll.

11 Sec. 29.45.300. TAX LIABILITY. (a) The owner of assessed per-  
12 sonal property is personally liable for the amount of taxes assessed  
13 against the property. The tax, together with penalty and interest,  
14 may be collected in a personal action brought in the name of the  
15 municipality.

16 (b) Property taxes, together with penalty and interest, are a  
17 lien upon the property assessed, and the lien is prior and paramount  
18 to all other liens or encumbrances against the property.

19 Sec. 29.45.310. ENFORCEMENT OF PERSONAL PROPERTY TAX LIENS BY  
20 DISTRAINT AND SALE. (a) A lien for personal property taxes may be  
21 enforced by distraint and sale of the property. The municipality  
22 shall provide the procedure for distraint and sale by ordinance. A  
23 seizure, levy, or distraint is not legal unless demand is first made  
24 of the person assessed for the amount of the tax, penalty, and inter-  
25 est, and a sale is not valid unless made at public auction no sooner  
26 than 15 days after notice is published. The seizure is made by virtue  
27 of a warrant issued by the municipal clerk to a peace officer.

28 (b) If the personal property sold is not sufficient to satisfy  
29 the tax, penalty, and interest, and costs of sale, the warrant may

1 authorize the seizure of other personal property sufficient to satisfy  
2 the tax, penalty, interest, and costs of sale. If the property is  
3 sold for more money than is needed to satisfy the tax, the municipal-  
4 ity shall remit the excess to the former record owner upon presenta-  
5 tion of a proper claim. A claim for the excess filed after six months  
6 of the date of sale is forever barred.

7 Sec. 29.45.320. REAL PROPERTY TAX COLLECTION. (a) The municipi-  
8 tality shall enforce delinquent real property tax liens by annual  
9 foreclosure, unless otherwise provided by ordinance.

10 (b) If the tax on property described in AS 29.45.070 or on a  
11 taxable interest in tax-exempt property is not paid when due, a muni-  
12 cipality may enforce the tax by a personal action against the delin-  
13 quent taxpayer brought in the district or superior court, in addition  
14 to other remedies available to enforce the lien.

15 Sec. 29.45.330. FORECLOSURE LIST. (a) A municipality shall

16 (1) annually present a petition for judgment and a certi-  
17 fied copy of the foreclosure list for the previous year's delinquent  
18 taxes in the superior court for judgment;

19 (2) publish the foreclosure list for four consecutive weeks  
20 in a newspaper of general circulation distributed in the municipality  
21 or, if there is no newspaper of general circulation distributed in the  
22 municipality, post the list at three public places for at least 30  
23 days;

24 (3) within 10 days after the first publication or posting,  
25 mail to the last known owner of each property as the owner's name and  
26 address appear on the list a notice advising of the foreclosure pro-  
27 ceeding in which a petition for judgment of foreclosure has been filed  
28 and describing the property and the amount due as stated on the list.

29 (b) The list shall be arranged in alphabetical order as to the

1 last name and shall include

2 (1) the last known owner;

3 (2) the property description as stated on the assessment  
4 roll;

5 (3) years and amounts of delinquency;

6 (4) penalty and interest due;

7 (5) a statement that the list is available for public  
8 inspection at the clerk's office;

9 (6) a statement that the list has been presented to the  
10 superior court with a petition for judgment and decree.

11 (c) Completion of the requirements of (a) of this section con-  
12 stitutes and has the same force and effect as the filing of an indi-  
13 vidual and separate complaint and service of summons to foreclose a  
14 lien against each property described on the foreclosure list.

15 Sec. 29.45.340. CLEARING DELINQUENCIES. During the publication  
16 or posting of the foreclosure list and up to the time of transfer to  
17 the municipality a person may pay the taxes, together with the penal-  
18 ty, interest, and costs. The collector shall note payment on the  
19 foreclosure list.

20 Sec. 29.45.350. LIST TO LIENHOLDER. A holder of a mortgage or  
21 other lien on real property may request the clerk to send by certified  
22 mail notice of a foreclosure list that includes the real property.

23 Sec. 29.45.360. GENERAL FORECLOSURE. A municipality shall bring  
24 one general foreclosure proceeding in rem against the properties in-  
25 cluded in the foreclosure list. If the owner is unknown, the property  
26 is proceeded against as belonging to "unknown owner."

27 Sec. 29.45.370. ANSWER AND OBJECTION. A person having an inter-  
28 est in a lot on the foreclosure list may file an answer within 30 days  
29 after the date of last publication, specifying the person's objection.

1 The court shall make its decision in summary proceedings. The fore-  
2 closure list is prima facie evidence that the assessment and levy of  
3 the tax is valid and that the tax is unpaid.

4 Sec. 29.45.380. JUDGMENT. The court shall in a proper case give  
5 judgment and decree that the tax liens be foreclosed. It is a several  
6 judgment against each lot and a lien on each lot.

7 Sec. 29.45.390. TRANSFER AND APPEAL. (a) Foreclosed properties  
8 are transferred to the municipality for the lien amount. When answers  
9 are filed the court may enter judgment against and order the transfer  
10 to the municipality of all other properties on the list pending deter-  
11 mination of the matters in controversy. The court shall hear and  
12 determine the issues raised by the complaint and answers in the same  
13 manner and under the same rules as it hears and determines other  
14 actions.

15 (b) The court clerk shall deliver a certified copy of the judg-  
16 ment and decree to the municipal clerk. The certified judgment and  
17 decree constitutes a transfer to the municipality.

18 (c) The judgment and decree stops objections to it that could  
19 have been presented before judgment and decree. Appeal from a judg-  
20 ment and decree of foreclosure, or from a final order in the proceed-  
21 ing, may be taken in the manner provided for appeals in civil actions.

22 Sec. 29.45.400. REDEMPTION PERIOD. Properties transferred to  
23 the municipality are held by the municipality for at least one year.  
24 During the redemption period a party having an interest in the prop-  
25 erty may redeem it by paying the lien amount plus penalties, interest,  
26 and costs, including all costs incurred under AS 29.45.440(a). Prop-  
27 erty redeemed is subject to all accrued taxes, assessments, liens, and  
28 claims as though it had continued in private ownership. Only the  
29 amount applicable under the judgment and decree must be paid in order

1 to redeem the property.

2           Sec. 29.45.410. EFFECT. Receipt of redemption money by the  
3 municipality releases the judgment obtained under AS 29.45.380. The  
4 clerk or the clerk's designee shall record the redemption and issue a  
5 certificate containing a property description, the redemption amount,  
6 and the dates of judgment and decree of foreclosure. The clerk or the  
7 clerk's designee shall collect the recording fee at the time of re-  
8 demption and shall file the certificate with the record as part of the  
9 judgment roll.

10           Sec. 29.45.420. ADDITIONAL LIENS. If a property included in a  
11 foreclosure list is removed after payment of delinquencies or redemp-  
12 tion by another lienholder, the payment represented by receipt for  
13 payment constitutes an additional lien on the property, collectible by  
14 the lienholder in the same manner as the original lien.

15           Sec. 29.45.430. POSSESSION DURING REDEMPTION PERIOD. Foreclo-  
16 sure does not affect the former owner's right to possession during the  
17 redemption period. If waste is committed by the former owner or by  
18 anyone acting under the permission or control of the former owner, the  
19 municipality may declare an immediate forfeiture of the right to  
20 possession.

21           Sec. 29.45.440. EXPIRATION. (a) At least 30 days before the  
22 expiration of the redemption period the clerk or the clerk's designee  
23 shall publish a redemption period expiration notice. The notice shall  
24 contain the date of judgment, the date of expiration of the period of  
25 redemption, and a warning that all properties ordered sold under the  
26 judgment, unless redeemed, shall be deeded to the municipality immedi-  
27 ately on expiration of the period of redemption and that every right  
28 or interest of a person in the properties will be forfeited forever to  
29 the municipality. The notice appears once a week for four consecutive

1 weeks in a newspaper of general circulation distributed in the muni-  
2 cipality. If there is no newspaper of general circulation distributed  
3 in the municipality, the notice is posted in three public places for  
4 at least four consecutive weeks. The clerk shall send a copy of the  
5 notice by certified mail to each record owner of property against  
6 which a judgment of foreclosure has been taken and, if the assessed  
7 value of the property is more than \$10,000, to all holders of mort-  
8 gages or other liens of record on the property. The notice shall be  
9 mailed within five days after the first publication. The mailing  
10 shall be sufficient if mailed to the property owner and to the holder  
11 of a mortgage or recorded lien at the last address of record.

12 (b) The right of redemption expires 30 days after the date of  
13 the first notice publication.

14 (c) Costs incurred in the determination of holders of mortgages  
15 and other liens of record and costs of notice publication incurred by  
16 a municipality under (a) of this section are a lien on the property  
17 and may be recovered by the municipality.

18 Sec. 29.45.450. DEED TO BOROUGH OR CITY. (a) Unredeemed prop-  
19 erty in the area of the borough outside all cities is deeded to the  
20 borough by the clerk of the court. Unredeemed property in a city is  
21 deeded to the city subject to the payment by the city of unpaid bor-  
22 ough taxes and costs of foreclosure levied against the property before  
23 foreclosure. The deed shall be recorded in the recording district in  
24 which the property is located.

25 (b) Conveyance gives the municipality clear title, except for  
26 prior recorded tax liens of the United States and the state.

27 (c) If unredeemed property lies in a city and if the city has no  
28 immediate public use for the property but the borough does have an  
29 immediate public use, the city shall deed the property to the borough.

1 If unredeemed property lies in the borough outside all cities and if  
2 the borough does not have an immediate public use for the property but  
3 a city does have an immediate public use, the borough shall deed the  
4 property to the city.

5 (d) No deed is invalid for irregularities, omissions, or defects  
6 in the proceedings under this chapter unless the former owner has been  
7 misled so as to be injured. Two years after the date of the deed, its  
8 validity is conclusively presumed and a claim of the former owner or  
9 other person having an interest in the property is forever barred.

10 Sec. 29.45.460. DISPOSITION AND SALE OF FORECLOSED PROPERTY.

11 (a) The municipality shall determine by ordinance whether foreclosed  
12 property deeded to the municipality shall be retained for a public  
13 purpose. The ordinance shall contain the legal description of the  
14 property, the address or a general description of the property suffi-  
15 cient to provide the public with notice of its location, and the name  
16 of the last record owner of the property as the name appears on the  
17 assessment rolls.

18 (b) Tax-foreclosed property conveyed to a municipality by tax  
19 foreclosure and not required for a public purpose may be sold. Before  
20 the sale of tax-foreclosed property held for a public purpose, the  
21 municipality, by ordinance, shall determine that a public need does  
22 not exist. The ordinance shall contain the information required under  
23 (a) of this section.

24 (c) The clerk or the clerk's designee shall send a copy of the  
25 published notice of hearing of an ordinance to consider a determina-  
26 tion required under (a) or (b) of this section by certified mail to  
27 the former record owner of the property that is the subject of the  
28 ordinance. The notice shall be mailed within five days after its  
29 first publication and shall be sufficient if mailed to the last record

1 owner of the property as the name appears on the assessment rolls of  
2 the municipality.

3 (d) The provisions of (c) of this section do not apply with  
4 respect to property that has been held by the municipality for a  
5 period of more than 10 years after the close of the redemption period.

6 Sec. 29.45.470. REPURCHASE BY RECORD OWNER. (a) The record  
7 owner at the time of tax foreclosure of property acquired by a muni-  
8 cipality, or the assigns of that record owner, may, within 10 years  
9 and before the sale or contract of sale of the tax-foreclosed property  
10 by the municipality, repurchase the property. The municipality shall  
11 sell the property for the full amount applicable to the property under  
12 the judgment and decree, with interest not to exceed 15 percent a year  
13 from the date of entry of the judgment of foreclosure to the date of  
14 repurchase, delinquent taxes assessed and levied as though it had  
15 continued in private ownership, and costs of foreclosure and sale.

16 (b) After adoption of an ordinance providing for the retention  
17 of tax-foreclosed property by the municipality for a public purpose,  
18 the right of the former record owner to repurchase the property  
19 ceases.

20 Sec. 29.45.480. PROCEEDS OF TAX SALE. (a) On sale of fore-  
21 closed real or personal property the municipality shall divide the  
22 proceeds less cost of collection, between the borough and the city  
23 having unpaid taxes against the property. The division is in propor-  
24 tion to the respective municipal taxes against the property at the  
25 time of foreclosure.

26 (b) If tax-foreclosed real property that has been held by a  
27 municipality for less than 10 years after the close of the redemption  
28 period and never designated for a public purpose is sold at a tax-  
29 foreclosure sale, the former record owner is entitled to the portion

1 of the proceeds of the sale that exceeds the amount of unpaid taxes,  
2 the amount equal to taxes that would have been assessed and levied  
3 after foreclosure if the property had continued in private ownership,  
4 penalty, interest, and costs to the municipality of foreclosing and  
5 selling the property. If the proceeds of the sale of tax-foreclosed  
6 property exceed the total of unpaid and delinquent taxes, penalty,  
7 interest, and costs, the municipality shall provide the former owner  
8 of the property written notice advising of the amount of the excess  
9 and the manner in which a claim for the balance of the proceeds may be  
10 submitted. Notice is sufficient under this subsection if mailed to  
11 the former record owner at the last address of record of the former  
12 record owner. On presentation of a proper claim, the municipality  
13 shall remit the excess to the former record owner. A claim for the  
14 excess filed after six months of the date of sale is forever barred.

15 Sec. 29.45.490. PAYMENT OF TAXES UPON PUBLIC UTILIZATION. If a  
16 municipality takes title to tax-foreclosed property for a public pur-  
17 pose, the municipality shall satisfy unpaid taxes and assessments  
18 against the property held by other municipalities, with accrued inter-  
19 est but without penalty. If the amount required to satisfy the unpaid  
20 taxes and assessments exceeds the assessed value of the property, the  
21 municipality shall pay the other municipalities the assessed value,  
22 which shall be divided between the other municipalities in proportion  
23 to their respective taxes and assessments against the property at the  
24 time of foreclosure.

25 Sec. 29.45.500. REFUND OF TAXES. (a) If a taxpayer pays taxes  
26 under protest, the taxpayer may bring suit in the superior court  
27 against the municipality for recovery of the taxes. If judgment for  
28 recovery is given against the municipality, or, if in the absence of  
29 suit, it becomes obvious to the governing body that judgment for

1 recovery of the taxes would be obtained if legal proceedings were  
2 brought, the municipality shall refund the amount of the taxes to the  
3 taxpayer with interest at eight percent from the date of payment plus  
4 costs.

5 (b) If, in payment of taxes legally imposed, a remittance by a  
6 taxpayer through error or otherwise exceeds the amount due, and the  
7 municipality, on audit of the account in question, is satisfied that  
8 this is the case, the municipality shall refund the excess to the tax-  
9 payer with interest at eight percent from the date of payment. A  
10 claim for refund filed one year after the due date of the tax is  
11 forever barred.

12 (c) The governing body may correct manifest clerical errors at  
13 anytime.

14 ARTICLE 3. CITY PROPERTY TAX.

15 Sec. 29.45.550. CITIES OUTSIDE BOROUGHES. Home rule and first  
16 class cities outside boroughs may assess, levy, and collect a property  
17 tax. A property tax if levied must be assessed, levied, and collected  
18 as provided by AS 29.45.010 - 29.45.500.

19 Sec. 29.45.560. CITIES INSIDE BOROUGHES. Home rule and first  
20 class cities inside boroughs may levy a property tax. A property tax,  
21 if levied, is subject to AS 29.45.010 - 29.45.050, 29.45.090 - 29.45.-  
22 100, 29.45.250, 29.45.400 - 29.45.440 and 29.45.460 - 29.45.500. The  
23 council shall by June 15 of each year present to the assembly a state-  
24 ment of the city's rate of levy unless a different date is agreed upon  
25 by the borough and city.

26 Sec. 29.45.570. APPLICATION. AS 29.45.010 - 29.45.570 apply to  
27 home rule and general law municipalities.

28 Sec. 29.45.580. DIFFERENTIAL TAX ZONES. A city may by ordinance  
29 establish, alter, and abolish differential tax zones to provide and

1 levy property taxes for services not provided generally in the city or  
2 a different level of service than that provided generally in the city.

3 Sec. 29.45.590. LIMITED PROPERTY TAXING POWER FOR SECOND CLASS  
4 CITIES. A second class city may by referendum levy property taxes as  
5 provided for first class cities. However, levy by a second class city  
6 may not exceed one-half of one percent of the assessed value of the  
7 property taxed, except that the limit does not apply to a levy neces-  
8 sary to avoid a default upon payment of principal and interest of  
9 bonded or other indebtedness that is secured by a pledge to levy ad  
10 valorem or other taxes without limit to meet debt payments.

11 Sec. 29.45.600. COMBINING PROPERTY TAX WITH INCORPORATION OF A  
12 SECOND CLASS CITY. A petition for second class city incorporation may  
13 request that a property tax proposal be placed on the same ballot.  
14 The petition must state the proposed tax rate. The petition may re-  
15 quest that incorporation be dependent on the passage of the property  
16 tax proposition. If so, the incorporation proposition fails if the  
17 property tax fails.

18 ARTICLE 4. BOROUGH SALES AND USE TAX.

19 Sec. 29.45.650. SALES AND USE TAX. (a) A borough may levy and  
20 collect a sales tax not exceeding six percent on sales, rents, and on  
21 services provided in the borough. The sales tax may apply to any or  
22 all of these sources. Exemptions may be granted by ordinance.

23 (b) A borough levying a sales tax may also by ordinance levy a  
24 use tax on the storage, use, or consumption of tangible personal  
25 property in the borough. The use tax rate must equal the sales tax  
26 rate and the use tax shall be levied only on buyers.

27 (c) A person who furnishes proof, in the form required by the  
28 borough tax collector, that the person has paid a sales tax on the

3 ough. This subsection applies to a sales tax levied in any taxing  
4 jurisdiction whether inside or outside the state.

5 (d) If the assembly charges interest on sales taxes not paid  
6 when due, the rate of interest may not exceed 15 percent a year on the  
7 delinquent taxes and shall be charged from the due date until paid in  
8 full. This subsection applies to home rule and general law municipal-  
9 ities.

10 (e) A borough may provide for the creation, recording, and  
11 notice of a lien on real or personal property to secure the payment of  
12 a sales and use tax, and the interest, penalties, and administration  
13 costs in the event of delinquency. When recorded, a lien authorized  
14 under this section has priority over other liens except those for  
15 property taxes and special assessments.

16 Sec. 29.45.660. NOTICE OF SALES AND USE TAX. (a) If the bor-  
17 ough levies and collects only a sales tax and use tax, the assembly  
18 shall provide a notice substantially in the form set out in AS 29.45.-  
19 020. In providing notice under this subsection, the assembly shall  
20 substitute for the millage equivalency its estimate of the equivalent  
21 sales tax rate for each of the categories of financial assistance set  
22 out in AS 29.45.020. Notice shall be provided

23 (1) by publishing in a newspaper of general circulation in  
24 the borough a copy of the notice once each week for a period of three  
25 successive weeks, with publication to occur not later than 45 days  
26 after the final adoption of the borough's budget; or

27 (2) if there is no newspaper of general circulation in the  
28 borough, by posting a copy of the notice for at least 20 days in at  
29 least two public places in the borough, with posting to occur not

2 (b) Compliance with the provisions of this section is a prereq-  
3 uisite to receipt of municipal tax resource equalization assistance  
4 under AS 29.60.010 - 29.60.080 and state aid for miscellaneous municipi-  
5 pal services under AS 29.60.100 - 29.60.180. The department shall  
6 withhold annual allocations under those sections until municipal  
7 officials demonstrate that the requirements of this section have been  
8 met.

9 Sec. 29.45.670. REFERENDUM, ADOPTION, AND MODIFICATION. A new  
10 sales and use tax or an increase in the rate of levy of a sales tax  
11 approved by ordinance does not take effect until ratified by a major-  
12 ity of the voters at an election.

13 ARTICLE 5. CITY SALES AND USE TAXES.

14 Sec. 29.45.700. POWER OF LEVY. (a) A city in a borough that  
15 levies and collects areawide sales and use taxes may levy sales and  
16 use taxes on all sources taxed by the borough in the manner provided  
17 for boroughs, except that the assembly may by ordinance authorize a  
18 city to levy and collect sales and use taxes on other sources.

19 (b) A city in a borough that does not levy and collect sales and  
20 use taxes for areawide borough functions may levy and collect sales  
21 and use taxes in the manner provided for boroughs.

22 (c) A city outside a borough may levy and collect sales and use  
23 taxes in the manner provided for boroughs.

24 Sec. 29.45.710. COMBINING SALES AND USE TAX WITH INCORPORATION  
25 OF A SECOND CLASS CITY. A petition for incorporation of a second  
26 class city may request that a sales and use tax proposal be placed on  
27 the same ballot. The petition must state the proposed tax rate. The  
28 petition may request that incorporation be dependent on the passage of  
29 the tax proposition. If so, the incorporation proposition fails if

1 the tax fails.

2 \* Sec. 12. AS 29 is amended by adding a new chapter to read:

3 CHAPTER 46. SPECIAL ASSESSMENTS.

4 Sec. 29.46.010. ASSESSMENT AND PROPOSAL. The municipality may  
5 assess against the property of a state or federal governmental unit  
6 and private real property to be benefited by an improvement all or a  
7 portion of the cost of acquiring, installing, or constructing capital  
8 improvements. The state shall pay an assessment levied, except as  
9 otherwise provided by law and subject to its right of protest under  
10 AS 29.46.020(b). If a governmental unit other than the state benefit-  
11 ed by an improvement refuses to pay the assessment, it shall be denied  
12 the benefit of the improvement. An improvement proposal may be initi-  
13 ated by

14 (1) petition to the governing body of the owners of one-  
15 half in value of the property to be benefited; or

16 (2) the governing body.

17 Sec. 29.46.020. PROCEDURE. (a) The municipality may prescribe  
18 by ordinance the procedures relating to creating special assessment  
19 districts, making local improvements, levying and collecting assess-  
20 ments, and financing improvements, including the following:

21 (1) a procedure for filing petitions;

22 (2) a survey and report by the mayor concerning the need  
23 for, desirable extent of, and estimated cost of each proposed local  
24 improvement;

25 (3) a public hearing on the necessity for the proposed  
26 local improvement;

27 (4) a resolution or ordinance determining to proceed or not  
28 to proceed with the proposed local improvement;

29 (5) a public hearing by the governing body on the special

11 less than 50 percent, except on approval of not fewer than three-  
12 fourths of the governing body.

13 (c) To the extent that the municipality does not prescribe a  
14 procedure for special assessments as permitted by this section, the  
15 municipality shall comply with the special assessment procedures set  
16 out in AS 29.46.030 - 29.46.100.

17 Sec. 29.46.030. CREATION OF DISTRICT. (a) When an improvement  
18 proposal is filed with the municipal clerk and presented to the gov-  
19 erning body, the municipality shall find by resolution or ordinance  
20 whether (1) the improvement requested is necessary and should be made,  
21 and (2) if by petition, the request has sufficient and proper peti-  
22 tioners. The findings under this section are conclusive.

23 (b) If the municipality approves an improvement proposal, it  
24 shall develop a proposed improvement plan including the total cost  
25 estimate and the percentage of the cost to be assessed against the  
26 benefited property. The improvement plan shall be filed with the

4 tributed in the municipality and shall send notice by mail to every  
5 record owner of property in the special assessment district.

6 Sec. 29.46.040. RECORD OWNER. The person in whose name property  
7 is listed on the municipal property tax roll as owner is conclusively  
8 presumed to be the legal owner of record. If the owner is unknown,  
9 the assessment roll may designate "unknown owner".

10 Sec. 29.46.050. OBJECTIONS AND REVISION. (a) Objections to an  
11 improvement plan may be filed during a period of 60 days after publi-  
12 cation of notice. The municipality may by resolution or ordinance  
13 approve the plan and order the improvement subject to the limitation  
14 of (b) of this section.

15 (b) If objections are made in writing during the period set for  
16 objections by the owners of property bearing 50 percent or more of the  
17 estimated total cost of the improvement, the governing body may not  
18 proceed with the improvement unless it revises the plan to meet the  
19 objections and the objections are reduced to less than 50 percent. A  
20 revised plan shall be approved and adopted as an original plan in  
21 accordance with AS 29.46.030.

22 Sec. 29.46.060. ASSESSMENT ROLL. (a) At any time after ap-  
23 proval of an improvement plan, the governing body shall assess the  
24 authorized percentage of the cost against property in the district  
25 included in the plan in proportion to the benefit received.

26 (b) The special assessment roll shall contain property descrip-  
27 tions, names of record owners, and assessment amounts.

28 (c) The governing body shall fix a time to hear objections to  
29 the roll. The municipal clerk shall send an assessment and hearing

1 notice by mail to each record owner of an assessed property not less  
2 than 15 days before the hearing.

3 Sec. 29.46.070. HEARING AND SETTLEMENT. After the public hear-  
4 ing, the governing body shall correct errors and inequalities in the  
5 roll. If an assessment is increased, a new hearing shall be set and  
6 notice published, except that a new hearing and notice is not required  
7 if all record owners of property subject to the increased assessment  
8 consent in writing to the increase. Objections to the increased  
9 assessment shall be limited to record owners of property on which the  
10 assessment was increased. When the roll is corrected, it shall be  
11 confirmed by resolution or ordinance.

12 Sec. 29.46.080. PAYMENT. (a) The governing body shall fix  
13 times of payment, penalties on delinquent payments, and the rate of  
14 interest on the unpaid balance of the assessment. Payment may be in  
15 one sum or by installments. If payment is to be in one sum, payment  
16 may not be required sooner than 60 days after mailing of the assess-  
17 ment statement. The entire assessment may be prepaid without interest

3 Sec. 29.46.090. EXEMPTION. (a) The real property owned and  
4 occupied by a resident 65 years of age or over, or the spouse, widow,  
5 widower, or minor heir of the original applicant, on which is located  
6 only the permanent abode of the applicant that is a single-family  
7 residence, is exempt from (1) special sewer assessments levied by a  
8 municipality after September 2, 1975, and (2) special water assess-  
9 ments levied by a municipality after September 2, 1975. Only one  
10 exemption may be granted with respect to the same property, and, if  
11 two or more persons are eligible for an exemption with respect to the  
12 same property, the parties shall decide between or among themselves

19 (b) An exemption may not be granted under this section except  
20 upon written application for the exemption on a form prescribed by the  
21 state assessor for use by local assessors and in accordance with the  
22 following requirements:

23 (1) The claimant must file the initial application during  
24 the period of time between the date the assessment roll is confirmed  
25 and the time of payment fixed by the governing body. Within one year  
26 after the date the assessment roll is confirmed the governing body for  
27 good cause shown may waive the claimant's failure to make timely  
28 initial application for the exemption and authorize the assessor to  
29 accept the application as if timely filed.

1           (2) A claimant receiving the exemption must file with the  
2 assessor by March 15 of each subsequent year a separate application  
3 proving eligibility as of January 1 in order to retain the exemption.  
4 Within the same year the assessor for good cause shown may waive the

6 tion as if timely filed.

7           (3) If an application is filed within the required time

10 tution or a member of the armed forces of the United States;

11 (2) "real property" includes, but is not limited to, mobile  
12 homes, whether classified as real or personal property for municipal

14 Sec. 29.46.100. REASSESSMENT. (a) The governing body shall  
15 within one year correct any deficiency in a special assessment found  
16 by a court. Notice and hearing must conform to the initial assessment  
17 procedures.

18 (b) Payments on the initial assessment are credited to the prop-  
19 erty upon reassessment. The reassessment becomes a charge upon the  
20 property notwithstanding failure to comply with any provision of the  
21 assessment procedure.

22 Sec. 29.46.110. ALLOWABLE COSTS. (a) When a special assessment  
23 district is created, there may be included in the assessments

24 (1) all of the cost of acquiring, installing, making, or  
25 constructing the local improvement;

26 (2) the costs of all engineering and surveying to be done  
27 in connection with creating the district or improvement;

28 (3) the cost of mailing and publishing notices;

29 (4) interest on interim financing;

1 (5) the cost of legal services and other expenses incurred

3 (6) the cost of completing the improvement and financing

5 (b) The total amount of the assessment roll may not exceed

8 Sec. 29.46.120. OBJECTION AND APPEAL. (a) The validity of an  
9 assessment may not be contested by a person who did not file with the

12 (b) The decision of the governing body on an objection may be  
13 appealed to the superior court within 30 days after the date of con-  
14 firmation of the assessment roll. If no objection is filed or appeal  
15 taken within that time, the assessment procedure is considered valid  
16 in all respects.

17 Sec. 29.46.130. INTERIM FINANCING. (a) A municipality may  
18 provide by resolution or ordinance for the issuance of notes in pay-  
19 ment of the costs of a local improvement project, payable out of  
20 special assessments for the improvement. The notes shall bear inter-  
21 est at a rate or rates authorized by the resolution or ordinance, and

13 be payable solely from the levy of special assessments against the  
14 property to be benefited. The assessments shall constitute a sinking

2 Sec. 29.47.320. NO ELECTION REQUIRED. An election is not re-

18 Sec. 29.47.400. SALE. Bonds and notes issued under this chapter

16 Sec. 29.55.010. CREATION OF LOCAL HISTORICAL DISTRICT COMMIS-

19 itself to serve as the historical district commission.

20 Sec. 29.55.020. ESTABLISHMENT OF HISTORICAL DISTRICTS. (a) In

4 (c) The commissioner of commerce and economic development shall  
5 require in negotiations and in each grant agreement that continued  
6 maintenance of the community facility is the responsibility of the  
7 municipality. The municipality must show the feasibility of continu-  
8 ing to maintain the facility before state money may be authorized for  
9 a grant.

10 Sec. 29.60.420. POWERS AND DUTIES OF THE COMMISSIONER. (a) The  
11 commissioner of commerce and economic development shall provide an  
12 annual report to the legislature about grants made under AS 29.60.400.
