For an Act entitled: "An Act making appropriations to the Department of

Education and the Department of Community and Re-

gional Affairs for fiscal year 1989 for the public

school foundation account, the school construction

account, reimbursement of school district pupil

11

transportation contracts, the tuition students pro-

gram, and the municipal assistance, state revenue

13

sharing, and senior citizens' and disabled veterans'

14

property tax and renters' equivalency rebate pro-

15

grams; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. The sum of \$446,000,900 is appropriated to the Department

18

of Education for the public school foundation account (AS 14.17.010) for

19

the fiscal year ending June 30, 1989, from the following sources:

20

\$415,923,900 from the general fund; \$8,830,900 from the public school fund

21

(AS 37.14.110); and \$21,246,100 from federal funds under Public Law 81-874.

* Sec. 2. The sum of \$117,709,976 is appropriated from the general fund

23

to the Department of Education for the school construction account (AS 14.-

24

11.100(c)) for the fiscal year ending June 30, 1989.

* Sec. 3. The sum of \$25,121,700 is appropriated from the general fund

26

to the Department of Education for reimbursement of school district pupil

27

transportation contracts (AS 14.09) for the fiscal year ending June 30,

1989.

* Sec. 4. The sum of \$14,609,000 is appropriated from the general fund

1 to the Department of Education for the tuition students program for the
2 fiscal year ending June 30, 1989.

3 * Sec. 5. The sum of \$113,737,600 is appropriated from the general fund
4 to the Department of Community and Regional Affairs for the municipal
5 assistance and state revenue sharing programs for the fiscal year ending
6 June 30, 1989, to be allocated as follows:

7	Municipal assistance	\$65,858,500
8	State revenue sharing	47,879,100

9 * Sec. 6. The sum of \$6,751,300 is appropriated from the general fund
10 to the Department of Community and Regional Affairs for the senior citi-
11 zens' and disabled veterans' property tax and renters' equivalency rebate
12 programs for the fiscal year ending June 30, 1989.

13 * Sec. 7. The unexpended and unobligated portions of the appropriations
14 made by this Act lapse into the fund from which the appropriation was made
15 June 30, 1989.

16 * Sec. 8. This Act takes effect July 1, 1988.
