A BILL

6 For an Act entitled: "An Act relating to sexual abuse of a minor."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 * Section 1. AS 11.41.434(a) is amended to read:

9 (a) An offender commits the crime of sexual abuse of a minor in
10 the first degree if

11 (1) being 16 years of age or older, the offender engages in
12 sexual penetration with a person who is under 13 years of age or aids,
13 induces, causes, or encourages a person who is under 13 years of age
14 to engage in sexual penetration with another person; or

15 (2) being 18 years of age or older, the offender engages in
16 sexual penetration with a person who is under 18 years of age and who

17 (A) is entrusted to the offender's care by authority
18 of law; [OR]

19 (B) is the offender's son or daughter, including an
20 illegitimate or adopted child, or a stepchild; or

21 (C) at the time of the offense, is residing as a
22 member of a social unit in the same household with the offender.

23 * Sec. 2. AS 11.41.436(a) is amended to read:

24 (a) An offender commits the crime of sexual abuse of a minor in
25 the second degree if

26 (1) being 16 years of age or older, the offender engages in
27 sexual penetration with a person who is 13, 14, or 15 years of age and
28 at least three years younger than the offender, or aids, induces,
29 causes or encourages a person who is 13, 14, or 15 years of age and at

1 least three years younger than the offender to engage in sexual pene-
2 tration with another person;

3 (2) being 16 years of age or older, the offender engages in
4 sexual contact with a person who is under 13 years of age or aids,
5 induces, causes, or encourages a person under 13 years of age to
6 engage in sexual contact with another person;

7 (3) being 18 years of age or older, the offender engages in
8 sexual contact with a person who is under 18 years of age and who

9 (A) is entrusted to the offender's care by authority
10 of law; [OR]

11 (B) is the offender's son or daughter, including an
12 illegitimate or adopted child, or a stepchild; or

13 (C) at the time of the offense, is residing as a
14 member of a social unit in the same household with the offender;

15 or

16 (4) being 16 years of age or older, the offender aids,
17 induces, causes, or encourages a person who is under 16 years of age
18 to engage in conduct described in AS 11.41.455(a)(2) - (6).
