1 IN THE SENATE BY THE LABOR AND  
COMMERCE COMMITTEE  
2 HOUSE CS FOR SENATE JOINT RESOLUTION NO. 64 (L&C)  
3 IN THE LEGISLATURE OF THE STATE OF ALASKA  
4 FIFTEENTH LEGISLATURE - SECOND SESSION  
5 Relating to resident hire on United  
6 States Department of Defense projects at  
7 Amchitka Island, Shemya Island, and  
8 Adak.  
9 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:  
10 WHEREAS the rate of unemployment among residents of the state is one  
11 of the highest in the nation; and  
12 WHEREAS the number of state residents who are unable to find work is  
13 considerably higher than is reflected by unemployment rates based on na-  
14 tionally accepted measures, in part because many rural state residents who  
15 wish to work do not seek employment as frequently as necessary to meet  
16 federal definitions of unemployment because of continuing lack of employ-  
17 ment opportunities in rural areas of the state; and  
18 WHEREAS chronic unemployment leads to severe social problems including  
19 alcoholism and domestic violence; and  
20 WHEREAS the state has one of the highest ratios of nonresident to  
21 resident workers in the nation; and  
22 WHEREAS nonresident workers displace a substantial number of qual-  
23 ified, available, unemployed Alaska workers; and  
24 WHEREAS section 8078 of the 1986 Defense Appropriations Act contained  
25 requirements for local hire on Department of Defense contracts in Alaska;  
26 and  
27 WHEREAS, in 1987, section 9069 of the conference report to House Joint  
28 Resolution 738 contained requirements for local hire on Department of  
29 Defense contracts in Alaska; and

1       WHEREAS section 8046 of the 1988 Defense Appropriation Act contains  
2 requirements for local hire on Department of Defense contracts in Alaska;  
3 and

4       WHEREAS employment in the Aleutian Islands is intensely seasonal and  
5 the region suffers from the effects of the high unemployment rate; and

6       WHEREAS the Amchitka Island, Shemya Island, and Adak projects of the  
7 Department of Defense are located in the Aleutian Islands;

8       BE IT RESOLVED that the Alaska State Legislature encourages the De-  
9 partment of Defense to comply with the Alaska hire provisions of the  
10 federal legislation; and be it

11       FURTHER RESOLVED that the legislature urges the Department of Defense  
12 to encourage Alaskans, including residents of the Aleutian Islands, to  
13 apply for work on the Amchitka Island, Shemya Island, and Adak projects and  
14 to give preference to them in hiring for the project.

16 Carlucci, Secretary of Defense; the Honorable William Bell, III, Secretary  
17 of the United States Navy; and to the Honorable Ted Stevens and the Honor-  
18 able Frank Murkowski, U.S. Senators, and the Honorable Don Young, U.S.  
19 Representative, members of the Alaska delegation in Congress.
