6 For an Act entitled: "An Act establishing the Alaska Commission on Chil-
7 dren and Youth; abolishing the Office of Child Advo-
8 cacy; relating to the Alaska children's trust fund;
9 and providing for an effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 * Section 1. AS 37.14.220 is repealed and reenacted to read:

12 Sec. 37.14.220. ADMINISTRATION OF THE FUND. The fund shall be
13 administered by the Alaska Commission on Children and Youth.

14 * Sec. 2. AS 37.14.220 is repealed and reenacted to read:

15 Sec. 37.14.220. ALASKA CHILDREN'S TRUST FUND BOARD ESTABLISHED.

16 (a) The Alaska Children's Trust Fund Board is established in the
17 Office of the Governor. The board is composed of four executive-
18 branch members and seven public members, who are appointed by, and
19 serve in that capacity at the pleasure of, the governor.

20 (b) The board shall elect a member to chair the board.

21 (c) The Office of the Governor shall provide staff for the
22 board.

24 Sec. 37.14.230. POWERS AND DUTIES OF THE COMMISSION [BOARD].

25 When acting as administrator of the fund, the commission [THE BOARD]
26 shall

29 ference;

16 (8) submit to the governor and the legislature by Febru-
17 ary 1 each year a report describing

18 (A) the child abuse and neglect prevention services
19 that were provided by the programs and projects to which the
20 commission [BOARD] awarded grants; and

21 (B) the annual level of contributions, income, and
22 expenses of the fund.

13 Sec. 44.19.521. CREATION OF COMMISSION. (a) There is created
14 in the Office of the Governor the Alaska Commission on Children and
15 Youth.

16 (b) The commission consists of four executive-branch members and
17 seven public members, who are appointed by, and serve in that capacity
18 at the pleasure of, the governor. At least one of the public members
19 must be under the age of 21 at the time of appointment. The com-
20 mission shall elect one of its members as chair. The chair may ap-
21 point other officers as necessary.

22 Sec. 44.19.523. TERMS OF OFFICE; COMPENSATION. (a) The term of
23 office of a member of the commission is three years.

24 (b) A vacancy shall be filled in the same manner as the original
25 appointment. A person appointed to a vacancy serves for the unexpired
26 portion of the term.

27 (c) Public members of the commission serve without compensation
28 for their services but are entitled to per diem and travel allowances
29 authorized under AS 39.20.180.

1 Sec. 44.19.525. POWERS OF THE COMMISSION. The commission may
2 (1) use legal, technical, secretarial, and administrative
3 services as may be provided by the governor;
4 (2) use voluntary and uncompensated services of private
5 persons and organizations as may be made available to the commission;
6 (3) receive, and use for operating purposes, money from the
7 federal government or other sources;
8 (4) hold public hearings;
9 (5) establish and maintain an office in Anchorage, or at a
10 location determined to be the most appropriate location by a majority
11 vote of the commissions, and hire an executive director and technical
12 and clerical staff that are necessary to perform the duties of the
13 commission; and
14 (6) take other actions reasonably necessary to carry out
15 the duties of the commission.

16 Sec. 44.19.527. DUTIES OF THE COMMISSION. (a) The commission
17 shall develop a comprehensive statewide plan that identifies the needs
18 of children and youth, individually and as they relate to their fam-
19 ilies, and makes recommendations to enhance their quality of life. In
20 meeting this charge, the commission may

21 (1) recommend the services and programs that should be
22 available for children and families in the areas of child care,
23 health, social services, education, special education, child protec-
24 tion, parent and staff training, nutrition, poverty, mental health,
25 safety, and employment of youth;
26 (2) identify the service needs of children and where gaps
27 and overlaps in services exist;
28 (3) monitor the emerging needs of and problems facing
29 children, and develop effective, comprehensive, and coordinated strat-

- 1 egies to address those needs and problems;
- 2 (4) develop and recommend adoption of a process for moni-
3 toring and evaluating children's programs;
- 4 (5) provide opportunities for the public to participate in
5 the planning and development of children's programs and policies;
- 6 (6) receive and act upon requests for recommendations from
7 parents, state officials, members of state advisory committees, legis-
8 lators, representatives of the state court system, and providers of
9 children's services on matters related to children and youth;
- 10 (7) meet with and make recommendations to state officials
11 and members of advisory committees who are responsible for the expen-
12 diture of state and federal money and provide recommendations to the
13 legislature and the department on structural and procedural changes,
14 contracting of services, establishment of standards, and the consoli-
15 dation of efforts designed to deliver services in a more cost-effec-
16 tive manner;
- 17 (8) serve as a statewide clearinghouse for government and
18 nongovernment programs and resources relating to children, youth, and
19 families;
- 20 (9) serve as an advocate for the interests of children by
21 informing the public, including leaders of the business community,
22 educators, local and state officials, the legal system, and the commu-
23 nications media of the nature and scope of problems faced by children;
- 24 (10) coordinate efforts and consult and cooperate with
25 persons, departments, organizations, and groups, including other
26 boards and commissions, interested in the problems and concerns of
27 children and youth; and
- 28 (11) make recommendations to the governor, legislature, and
29 state officials with respect to legislation, regulations, and appro-

1 priations for programs or services that benefit children and youth.

2 (b) In formulating the strategy to address the needs of and
3 problems facing children, the commission shall actively solicit advice
4 and information from children and youth of all ages and socioeconomic
5 backgrounds. The commission shall also seek advice and information
6 from parents and children's services providers, including those with
7 expertise in the areas of mental health, health care, prenatal care,
8 adolescent drug and alcohol treatment, education, special education,
9 early childhood education, early childhood special education, non-
10 profit funding sources, child abuse and neglect, domestic violence,
11 child care, dependence, delinquency and the justice system, minority
12 issues, and family support systems.

13 (c) The commission shall prepare and publish an annual report on
14 the status of children in the state and its recommendations and pro-
15 posals for change. The commission shall provide the governor and the
16 legislature with copies of the report by the 15th day of each regular
17 legislative session.

18 Sec. 44.19.529. TECHNICAL ASSISTANCE AND STAFF SUPPORT. The
19 executive branch departments shall cooperate with the commission and
20 provide technical assistance to the commission upon the request of the
21 commission.

22 * Sec. 14. TEMPORARY USE OF PRINCIPAL. Notwithstanding AS 37.14.230
23 and 37.14.240, as amended by secs. 3, 5, and 6 of this Act, until July 1,
24 1992, the Alaska Commission on Children and Youth may use not more than
25 \$50,000 from the principal of the Alaska children's trust fund for the
26 purposes specified in AS 37.14.240(b)(2) and (3).

27 * Sec. 15. REVISOR'S INSTRUCTION. To be consistent with the changes
28 made by secs. 1, 3, 6, and 8 of this Act, wherever in AS 37.14.200 - 37.-
29 14.270 and in the regulations adopted under those statutes "Alaska Chil-

1 dren's Trust Fund Board" or "board" is used, they shall be read as
2 referring to the Alaska Commission on Children and Youth and the commis-
3 sion, respectively. Under AS 01.05.031, the revisor of statutes shall
4 implement this section in the statutes and under AS 44.62.125(b)(6), the
5 regulations attorney shall implement this section in the administrative
6 regulations.

7 * Sec. 16. REVISOR'S INSTRUCTION. To be consistent with the changes
8 made by secs. 2, 4, 7, and 9 of this Act, wherever in AS 37.14.200 - 37.14.
9 270 and in the regulations adopted under those statutes "Alaska Commission
10 on Children and Youth" or "commission" is used, they shall be read as
11 referring to the Alaska Children's Trust Fund Board and the board, respec-
12 tively. Under AS 01.05.031, the revisor of statutes shall implement this
13 section in the statutes and under AS 44.62.125(b)(6), the regulations
14 attorney shall implement this section in the administrative regulations.

19 * Sec. 19. TERMS OF INITIAL APPOINTEES. Notwithstanding AS 44.19.523,
20 enacted by sec. 13 of this Act, the governor shall set the terms of the
21 members initially appointed to the Alaska Commission on Children and Youth
22 so that four members serve three-year terms, four members serve two-year
23 terms, and three members serve one-year terms.

24 * Sec. 20. REVIEW OF LAWS RELATING TO CHILDREN. The Alaska Commission
25 on Children and Youth, established under sec. 13 of this Act, may review
26 the laws of the state with regard to matters involving children. If a
27 review is done, the commission shall prepare and publish a report of its
28 findings and recommendations and provide the governor and the legislature
29 with copies by January 1, 1992.

1 * Sec. 21. Sections 2, 4, 7, 9, 11, and 16 of this Act take effect
2 June 30, 1993.

3 * Sec. 22. Except as provided in sec. 21 of this Act, this Act takes
4 effect July 1, 1990.
