A BILL

6 For an Act entitled: "An Act relating to preparation and maintenance of
7 the jury list."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 09.20.050(b) is amended to read:

10 (b) The jury list shall be based on [A LIST OF ALL PERSONS WHO
11 PURCHASED A RESIDENT TRAPPING, HUNTING OR FISHING LICENSE DURING THE
12 PRECEDING CALENDAR YEAR WHICH SHOWED AN ALASKAN ADDRESS (TO BE PRE-
13 PARED BY THE DEPARTMENT OF FISH AND GAME),] a list prepared by the
14 Department of Revenue of all persons who filed an application for a
15 distribution of Alaska permanent fund income under AS 43.23 [AS 43.-
16 23.010 - 43.23.100] during the preceding calendar year that [WHICH]
17 showed an Alaskan address [(TO BE PREPARED BY THE DEPARTMENT OF REVE-
18 NUE), A LIST OF ALL PERSONS WHO HAVE REGISTERED TO VOTE IN THIS STATE
19 (TO BE PREPARED BY THE DIRECTOR OF ELECTIONS)], and of all persons
20 who volunteer for jury duty under (d) of this section. If [, IF] con-
21 sidered necessary by the administrative director of the Alaska Court
22 System, the jury list shall incorporate [COURTS,] a list prepared by
23 the Department of Public Safety of all persons who hold a valid Alaska
24 driver's [DRIVERS'] license [(TO BE PREPARED BY THE DEPARTMENT OF
25 PUBLIC SAFETY)]. The departments [AND THE DIRECTOR OF ELECTIONS]
26 shall submit their respective lists to the Alaska Court System [DE-
27 PARTMENT OF ADMINISTRATION] not later than January 15 of each year.
28 To the extent that it is available, the [LISTS SUBMITTED BY THE]
29 departments [AND THE DIRECTOR OF ELECTIONS] shall include on the

1 lists they submit [CONTAIN] the following information for each person
2 [ON THE LIST FOR THE PRECEDING CALENDAR YEAR]: first name, middle ini-
3 tial, and last name; residence address and [AS WELL AS] mailing ad-
4 dress, including the zip code for each; birth date; and the number of
5 years and months the person has been a resident of the state. The
6 lists [SUBMITTED BY THE DEPARTMENTS AND THE DIRECTOR OF ELECTIONS]
7 shall be recorded on magnetic tape compatible with Alaska Court System
8 [DEPARTMENT OF ADMINISTRATION] data processing equipment.

9 * Sec. 2. AS 09.20.050 is amended by adding a new subsection to read:

10 (d) A person who is qualified as a juror under AS 09.20.010 and
11 is not disqualified from serving as a juror by AS 09.20.020 may volun-
12 teer for jury duty by contacting the administrative director of the
13 Alaska Court System and providing the information the administrative
14 director may require. The administrative director shall provide a
15 list of persons volunteering for jury duty to the Department of Reve-
16 nue for inclusion on the jury list under (b) of this section.

17 * Sec. 3. AS 18.50.230 is amended by adding a new subsection to read:

18 (e) To assist the Alaska Court System to remove the names of
19 deceased persons from jury lists under AS 09.20.050(c), the state
20 registrar of vital statistics shall forward to the administrative
21 director of the Alaska Court System the names of persons for whom
22 certificates of death were issued and reported to the registrar.
