A BILL

6 For an Act entitled: "An Act relating to retirement benefits for the
7 administrative director of the Alaska Court System;
8 and providing for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. AS 39.35.680(21) is amended to read:

11 (21) "member" or "employee"

12 (A) means a person eligible to participate in the
13 system and who is covered by the system;

14 (B) includes

15 (i) active member;

16 (ii) inactive member;

17 (iii) vested member;

18 (iv) deferred vested member;

19 (v) non-vested member;

20 (vi) disabled member;

21 (vii) retired member;

22 (C) does not include

23 (i) former members;

24 (ii) persons compensated on a contractual or fee
25 basis;

26 (iii) casual or emergency workers or nonpermanent
27 employees as defined in AS 39.25.200;

28 (iv) persons covered by the Alaska Teachers'
29 Retirement System;

1 (v) employees of the division of ~~public transportation~~
2 tation engaged in operating the state ferry system ~~and are~~
3 covered by a union or group retirement system to which the
4 state makes contributions;

5 (vi) justices of the supreme court or ~~judges of~~
6 the court of appeals or of the superior or ~~district courts~~
7 of Alaska;

8 (vii) [THE ADMINISTRATIVE DIRECTOR OF ~~INDUSTRIES~~
9 APPOINTED UNDER ART. IV, SEC. 16 OF THE STATE CONSTITUTION
10 UNLESS THE DIRECTOR BECOMES A MEMBER UNDER AS 39.35.158 AND

11 (viii)] members of the elected public ~~employees~~
12 retirement system (former AS 39.37);

13 (D) may include employees of the division of ~~public~~
14 transportation excluded under (C)(v) of this paragraph ~~provided~~
15 that

16 (i) the State of Alaska formally agrees to ~~their~~
17 inclusion through the process of collective bargaining and

18 (ii) no collective bargaining agreement ~~shall have~~
19 effect of obligating contributions made by the state under
20 AS 39.30.150 in the event the state resumes participation in
21 the federal social security system;

22 * Sec. 2. AS 22.25.012 and AS 39.35.158 are repealed.

23 * Sec. 3. This Act takes effect immediately under AS 01.10.070.
