A BILL

6 For an Act entitled: "An Act making a special appropriation for payment as
7 grants for development, rehabilitation, relocation,
8 or expansion of cemeteries and certain related access
9 facilities; and providing for an effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 * Section 1. The sum of \$1,982,400 is appropriated from the general
12 fund to the Department of Administration for payment as grants under
13 AS 37.05.315 to the following municipalities for the purposes and in the
14 amounts stated:

15	(1) City of Angoon - rehabilitation and expansion of	
16	Danger Point cemetery and rehabilitation of the Danger Point	
17	cemetery access road	\$170,000
18	(2) City of Haines - rehabilitation and expansion of	
19	the Haines cemetery	250,000
20	(3) City of Hoonah - development and rehabilitation of	
21	the Hoonah cemetery	150,000
22	(4) City of Kasaan - rehabilitation and expansion of	
23	the Kasaan cemetery	150,000
24	(5) City of Klawock - rehabilitation and expansion of	
25	the Klawock cemetery	100,000
26	(6) City of Thorne Bay - development of a cemetery	175,000
27	(7) City of Craig - rehabilitation of the Craig	
28	cemetery	150,000
29	(8) City of Yakutat - rehabilitation of the Yakutat	

1	cemetery and rehabilitation of access to the Yakutat cemetery	150,000
2	(9) City of Metlakatla - rehabilitation of the	
3	Metlakatla cemetery	175,000
4	(10) City of Skagway - rehabilitation of the Skagway

6	(11) City of Kake - rehabilitation and expansion of the	
7	Grave Island cemetery and rehabilitation of access to the Grave

9	(12) Matanuska-Susitna Borough - development of a	
10	cemetery at Trapper Creek	10,000
11	(13) City and Borough of Sitka - rehabilitation of	
12	the Pioneers' Home cemetery	177,400
13	(14) City of Hydaburg - rehabilitation of the	
14	Hydaburg cemetery	75,000

15 * Sec. 2. The sum of \$47,306 is appropriated from the general fund to
16 the Department of Community and Regional Affairs for payment as a grant
17 under AS 37.05.316 to the Tanacross Village Council for relocation of the
18 Tanacross cemetery.

19 * Sec. 3. The appropriation made by sec. 2 of this Act is for a capital
20 project and is subject to AS 37.25.020.

21 * Sec. 4. This Act takes effect July 1, 1990.
