Urging the Congress to amend the depen-

dent care services credit for child care

under the Internal Revenue Code.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:

WHEREAS compassionate and caring parents are the best providers of  
10 care for their children; and

11

WHEREAS recent scientific research establishes that children, in  
12 particular preschool children, are best cared for by their mother or father  
13 in the home; and

14

WHEREAS research indicates that there is no adequate substitute for  
15 the bonding and attachment that take place between a child and its mother  
16 or father; and

17

WHEREAS use of day care, in particular infant day care, presents a  
18 risk that children enrolled may develop insecure infant-parent attachment,  
19 disobedience, and aggression; and

20

WHEREAS in most families where one parent chooses to stay at home to  
21 care for children, opportunities for a second income outside the home are  
22 delayed or lost; and

23

WHEREAS skyrocketing juvenile crime is related to the absence of a  
24 parent from the home; and

25

WHEREAS the federal social services block grant makes funds available  
26 to states for child care and a range of other social services; and

27

WHEREAS existing tax law allows a tax credit of up to \$4,800 for the  
28 expense of child care services provided by others; and

WHEREAS federal policy should not discriminate against parents who

1 stay at home, but should serve to increase the economic vitality of such  
2 families; and

3 WHEREAS, according to Census Bureau data, 54 percent of American  
4 children under the age of five are primarily cared for by the mother, who  
5 stays home with her children; and

6 WHEREAS an additional seven percent of American children under five  
7 are cared for by both parents who work shifts and share the care of the  
8 children; and

9 WHEREAS another four percent of children have mothers working at home  
10 and caring for their children; and

11 WHEREAS inflation has greatly reduced the value of the dependent  
12 exemption credit for purposes of federal income taxation; and

13 WHEREAS existing tax law allows for a double dependent exemption  
14 deduction for a person who is blind or 65 or older;

15 BE IT RESOLVED that the Alaska State Legislature respectfully requests  
16 the Congress of the United States to amend the dependent care service  
17 credit to allow the claim of the credit for the services of a parent who  
18 stays at home to care for at least one child under the age of 13; and be it

19 FURTHER RESOLVED that the Alaska State Legislature requests that the  
20 dependent exemption allowance be set at an amount that is no less than  
21 full-time employment at the minimum wage.
