15 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:

16 \* Section 1. Rule 20(a) of the Uniform Rules of the Alaska State Legis-

17 lature is amended to read:

18 (a) Each house has the following standing committees with the

19 jurisdiction indicated:

20 Finance (all appropriation, revenue, capital improvement, and

21 bonding measures, the executive budget, and the programs and activ-

22 ities of the Department of Revenue)

23 Health [, EDUCATION] and Social Services (the programs and

24 activities of the Department of Health and Social Services [, THE

25 DEPARTMENT OF EDUCATION, AND THE UNIVERSITY OF ALASKA])

26 Education (the programs and activities of the Department of

27 Education and the University of Alaska)

28 Judiciary (the programs and activities of the Alaska Court

29 System and the Department of Law, and the legal and substantive review

1 of bills referred to it for that purpose)

2 Labor and Commerce (the programs and activities of the Depart-  
3 ment of Labor relating to labor-management relations, industrial  
4 safety, unemployment compensation, and workers' compensation and the  
5 programs and activities of the Department of Commerce and Economic  
6 Development)

7 Community and Regional Affairs (the programs and activities of  
8 the Department of Community and Regional Affairs and other matters  
9 relating to political subdivisions)

10 Resources (the programs and activities of the Departments of  
11 Fish and Game, Natural Resources, and Environmental Conservation)

12 Rules (interpretation of the Uniform Rules, calendar, the in-  
13 ternal administration of the house and matters pertaining to the  
14 management of the legislature as a whole)

15 State Affairs (programs and activities of the Office of the  
16 Governor and the Departments of Administration, Military Affairs, and  
17 Public Safety, and programs and activities of the Department of Trans-  
18 portation and Public Facilities relating to public facilities)

19 Transportation (programs and activities of the Department of  
20 Transportation and Public Facilities relating to transportation and  
21 other legislative matters relating to transportation).

22 \* Sec. 2. The amendment proposed by this resolution takes effect on the  
23 convening of the First Session of the Seventeenth Alaska State Legislature.
