A BILL

FOR AN ACT ENTITLED

1 "An Act relating to membership on and compensation of members of the Board of
2 Fisheries and Board of Game; relating to disclosures under the Alaska Executive Branch
3 Ethics Act by members of the Board of Fisheries and Board of Game; and repealing
4 certain references to the Board of Fisheries and Board of Game."

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

6 * Section 1. AS 16.05.221 is amended by adding a new subsection to read:

7 (c) Members of the Board of Fisheries or Board of Game serve staggered terms of three
8 years and until a successor is appointed. An appointment to fill a vacancy in the membership
9 of the Board of Fisheries or Board of Game shall be made in the same manner as the original
10 appointment and for the balance of the unexpired term.

11 * Sec. 2. AS 16.05.280 is amended to read:

12 Sec. 16.05.280. REMOVAL OF BOARD MEMBERS. The governor may only remove
13 a board member for inefficiency, neglect of duty, [OR] misconduct in office, or because the
14 member has been convicted of a misdemeanor for violating a statute or regulation related

1 to fish or game or of a felony, by delivering to the member a written copy of the charges and
2 giving the member an opportunity to be heard in person or through counsel at a public hearing
3 before the governor or a designee upon at least 10 days' notice by registered mail. The member
4 may confront and cross-examine adverse witnesses. Upon removal, the governor or a designee
5 shall file in the proper state office the findings and a complete statement of all charges made
6 against the member.

7 * Sec. 3. AS 16.05.290 is amended to read:

8 Sec. 16.05.290. COMPENSATION OF BOARD MEMBERS. Each member of a board
9 is entitled to compensation at a rate equal to Step A, Range 22, of the salary schedule in
10 AS 39.27.011(a) for Juneau, Alaska, [TRAVEL EXPENSES AND \$150 PER DIEM] for each
11 day going to and from and for each day in actual attendance at board meetings. For other
12 meetings or conferences authorized by a board a member shall receive compensation at a rate
13 equal to one-half of Step A, Range 22, of the salary schedule in AS 39.27.011(a) for Juneau,
14 Alaska, for each [\$100 PER] day going to and from and for each day in actual attendance.
15 Each member of a board is also entitled to travel expenses and per diem authorized for
16 boards and commissions under AS 39.20.180.

17 * Sec. 4. AS 39.52.120 is amended by adding a new subsection to read:

18 (c) In addition to other provisions of this section, a public officer who is a member of
19 the Board of Fisheries or the Board of Game may not act on a matter before the board if the
20 public officer has not disclosed in the manner set out in AS 39.52.220 all personal or financial
21 interests, whether significant or not, in a business or organization relating to fish or game
22 resources.

23 * Sec. 5. APPLICABILITY. A person who is a member of the Board of Fisheries or Board of Game
24 on the effective date of this Act shall serve the term to which the person was appointed, subject to
25 AS 16.05.280, as amended by sec. 2 of this Act. A person who is appointed to the Board of Fisheries
26 or Board of Game after the effective date of this Act shall be appointed for the term provided by
27 AS 16.05.221(c).

28 * Sec. 6. AS 39.05.060(a)(5) and 39.05.060(a)(10) are repealed.
