A BILL

FOR AN ACT ENTITLED

1 "An Act making supplemental appropriations to the Alaska Energy Authority for deferred
 2 maintenance projects; and providing for an effective date."

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 * **Section 1.** The sum of \$220,000 is appropriated from the general fund to the Alaska Energy
 5 Authority for the repair and rehabilitation of existing rural waste heat recovery systems.

6 * **Sec. 2.** The sum of \$162,000 is appropriated from the general fund to the Alaska Energy Authority
 7 for repair and replacement of the intertie between Oscarville and Napaskiak.

8 * **Sec. 3.** The sum of \$26,000 is appropriated from the general fund to the Alaska Energy Authority
 9 for the repair of Chester Lake penstock and facilities.

10 * **Sec. 4.** The sum of \$1,275,000 is appropriated from the general fund to the Alaska Energy
 11 Authority for redesign, removal, and replacement of the transmission line between Shungnak and Kobuk.

12 * **Sec. 5.** The sum of \$55,000 is appropriated from the general fund to the Alaska Energy Authority
 13 for right-of-way renewal and repair and establishment of a maintenance account for the Bethel to
 14 Napakiak intertie.

- 1 * Sec. 6. The sum of \$450,000 is appropriated from the general fund to the Alaska Energy Authority
2 for circuit rider maintenance and emergency repairs.
- 3 * Sec. 7. The sum of \$40,000 is appropriated from the general fund to the Alaska Energy Authority
4 for removing dangerous trees in the buffer area of the Craig to Klawock intertie.
- 5 * Sec. 8. The sum of \$560,000 is appropriated from the general fund to the Alaska Energy Authority
6 for emergency repairs to community bulk fuel systems.
- 7 * Sec. 9. The sum of \$240,000 is appropriated from the general fund to the Alaska Energy Authority
8 for repairing and replacing energy meters and providing remote data acquisition systems.
- 9 * Sec. 10. The sum of \$200,000 is appropriated from the general fund to the Alaska Energy Authority
10 for repair and replacement of the Diomedes bulk fuel system.
- 11 * Sec. 11. The sum of \$530,000 is appropriated from the general fund to the Alaska Energy Authority
12 for replacement of the Tuluksak electrical distribution system.
- 13 * Sec. 12. The sum of \$114,000 is appropriated from the general fund to the Alaska Energy Authority
14 for rehabilitation of the Rampart electrical distribution system.
- 15 * Sec. 13. The sum of \$60,000 is appropriated from the general fund to the Alaska Energy Authority
16 for repair and replacement of the Kobuk electrical distribution system.
- 17 * Sec. 14. The sum of \$200,000 is appropriated from the general fund to the Alaska Energy Authority
18 for repair, replacement, and code compliance measures for the Port Heiden electrical distribution system.
- 19 * Sec. 15. The sum of \$275,000 is appropriated from the general fund to the Alaska Energy Authority
20 for safety repairs to the Kwigillingok electrical distribution system.
- 21 * Sec. 16. The sum of \$137,000 is appropriated from the general fund to the Alaska Energy Authority
22 for reconstruction of the Eagle Village electrical distribution system.
- 23 * Sec. 17. The sum of \$175,000 is appropriated from the general fund to the Alaska Energy Authority
24 for Ouzinkie power plant repairs and code compliance measures.
- 25 * Sec. 18. The sum of \$140,000 is appropriated from the general fund to the Alaska Energy Authority
26 for bulk fuel system repairs and code compliance for Eek.
- 27 * Sec. 19. The sum of \$198,000 is appropriated from the general fund to the Alaska Energy Authority
28 for repairs and code compliance measures for the Golovin bulk fuel system.
- 29 * Sec. 20. The sum of \$350,000 is appropriated from the general fund to the Alaska Energy Authority
30 for repairs, modification, upgrade and safety code compliance measures for the Allakaket electrical
31 system.

- 1 * Sec. 21. The sum of \$215,000 is appropriated from the general fund to the Alaska Energy Authority
2 for completion of the waste heat system for Yakutat.
- 3 * Sec. 22. The sum of \$330,000 is appropriated from the general fund to the Alaska Energy Authority
4 for repair of the Kotzebue electrical distribution line and costs associated with utility easement
5 compliance.
- 6 * Sec. 23. The sum of \$84,700 is appropriated from the general fund to the Alaska Energy Authority
7 for repair and replacement of the electrical system for Karluk.
- 8 * Sec. 24. The sum of \$370,000 is appropriated from the general fund to the Alaska Energy Authority
9 for reconstruction of the community electrical system in Tetlin.
- 10 * Sec. 25. The sum of \$340,000 is appropriated from the general fund to the Alaska Energy Authority
11 for electrical system repairs in St. Paul.
- 12 * Sec. 26. This Act takes effect immediately under AS 01.10.070(c).
