A BILL

FOR AN ACT ENTITLED

1 "An Act relating to the required contribution by a sponsor of a program or project
2 funded by a grant from the Older Alaskans Commission; and providing for an effective
3 date."

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

5 * Section 1. AS 47.65.030 is amended by adding a new subsection to read:

6 (c) When awarding a grant for a pilot project under this section, the commission may
7 waive all or part of the sponsor contribution required under AS 47.65.040.

8 * Sec. 2. AS 47.65.040 is amended to read:

9 Sec. 47.65.040. REQUIRED CONTRIBUTION BY SPONSOR. (a) A sponsor receiving
10 a grant of state money under AS 47.65.010 - 47.65.050, or of federal money from Title III of
11 the Older Americans Act (42 U.S.C. 3001 - 3057) under AS 44.21.230(a)(7), shall contribute
12 to the total cost of the program or project. The contribution may be in cash or in-kind services.
13 If a municipality makes a contribution to the sponsor for the grant services, the
14 contribution may be counted as part of the required contribution by the grant sponsor.

1 **(b)** The amount of the sponsor's required contribution is determined by the application
2 of the following formula: average per capita full and true value of all property in the municipality
3 or community in which the project or program takes place divided by the average per capita full
4 and true value of all property in the state, and then multiplied by the **population factor as**
5 **determined in (c) of this section. the product to then be used as a percent to be applied**
6 **against** [CONTRIBUTION PERCENTAGE TO] the estimated total program or project cost as
7 determined by the commission at the time of approval of a grant application. However, the
8 amount of the sponsor's **required** contribution may not **exceed 20** [AMOUNT TO MORE THAN
9 10] percent of the total program or project cost.

10 **(c)** [(b)] For purposes of this section

11 (1) the **population factor** [CONTRIBUTION PERCENTAGE] for

12 (A) a program or project in a municipality or community having a
13 population of 5,000 or less is 10 percent [OF THE TOTAL PROGRAM OR PROJECT
14 COST];

15 (B) a program or project in a municipality or community having a
16 population of 5,000 to 10,000 is 20 percent [OF THE TOTAL PROGRAM OR PROJECT
17 COST]; and

18 (C) a program or project in a municipality or community having a
19 population of more than 10,000 is 30 percent [OF THE TOTAL PROGRAM OR
20 PROJECT COST].

21 **(d)** **If an application is submitted for a program or project that serves people in**
22 **several municipalities or communities but does not serve the service area of an entire**
23 **borough, the appropriate population factor shall be determined by adding the populations**
24 **of all communities to be served, then dividing the cumulative population by the number of**
25 **communities to be served, and then using that average population figure to select the**
26 **appropriate population factor in (c) of this section.**

27 **(e)** **If an application is submitted for a program or project that serves the service**
28 **area of an entire borough, the population factor to be used shall be based on the total**
29 **population of the borough.**

30 **(f)** [(c)] If an application is submitted for a program or project in a municipality or
31 community for which no average per capita full and true property value determination has been

1 made,

2 (1) if the population of the municipality or community is 750 or more, the
3 commission shall request the state assessor to compute the average per capita full and true
4 property value of that municipality or community and report it;

5 (2) if the population is less than 750, the commission may substitute for the
6 average per capita full and true value of property in the municipality or community an amount
7 equal to the average per capita full and true value of property in the smallest municipality for
8 which that amount has been determined by the state assessor.

9 ~~[(d) THE REQUIRED CONTRIBUTION RATE OF THE SPONSOR MAY NOT~~
10 ~~EXCEED THE CONTRIBUTION PERCENTAGE ESTABLISHED IN (b) OF THIS SECTION;]~~

11 (g) ~~[(e)]~~ The grant awarded by the commission may not exceed the estimated total
12 program or project cost as determined by the commission less the required contribution by the
13 sponsor determined in accordance with this section.

14 * Sec. 3. This Act takes effect on the first day of the state fiscal year that begins at least 90 days
15 after the Act becomes law.
