A RESOLUTION

1 Relating to the Persian Gulf conflict.

2 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:

3 WHEREAS the members of our Armed Forces were called upon to liberate Kuwait and defend
4 Saudi Arabia and Israel from the aggression of Iraq; and

5 WHEREAS many of the U.S. troops sent to the Persian Gulf were pulled away from civilian
6 lives at great personal sacrifice; and

7 WHEREAS the Allied troops endured the uncertainties and hardships caused by separation from
**8 their loved ones for months while stationed in the harsh climate of the Middle Eastern desert under
9 conditions that left them vulnerable to unpredictable missile attacks and terrorist activities; and**

10 WHEREAS the troops successfully performed their mission with great dispatch, exemplifying
**11 the high degree of dedication, professionalism, and training that underlies the technological and strategic
12 superiority of our military strength;**

13 BE IT RESOLVED that the Alaska State Legislature

**14 (1) commends the bravery of Alaska's military personnel, all the men and women who
15 served in the Allied Forces in the Persian Gulf, and the civilians residing in the area;**

**16 (2) congratulates the Allied commanding officers for pursuing tactics that led to a speedy
17 end to the ground war with very little loss of American or other Allied troops' lives;**

1 (3) urges President Bush, the Congress, and the United Nations to use all available
2 diplomatic means to find a permanent peaceful solution to all of the conflicts and causes of instability
3 in the Middle East; and be it

4 **FURTHER RESOLVED** that the legislature requests the Alaska Legislative Council to direct
5 the Legislative Affairs Agency to send the following message to all returning Alaskans who served in
6 the U.S. military forces in the Persian Gulf before March 1, 1991: "The Alaska State Legislature thanks
7 you heartily for your efforts in stopping Iraq's aggression, liberating Kuwait, and laying the foundation
8 for a just and lasting peace in the Middle East. You deserve a hero's welcome."

9 **COPIES** of this Resolution shall be sent to the Honorable George Bush, President of the United
10 States; the Honorable Dan Quayle, Vice-President of the United States and President of the U.S. Senate;
11 the Honorable George Mitchell, Majority Leader of the U.S. Senate; the Honorable Thomas S. Foley,
12 Speaker of the U.S. House of Representatives; the Honorable Dick Cheney, Secretary of Defense;
13 General Colin L. Powell, Chair of the Joint Chiefs of Staff; General Norman Schwarzkopf, Commander-
14 in-Chief, U.S. Central Command; and to the Honorable Ted Stevens and the Honorable Frank
15 Murkowski, U.S. Senators, and the Honorable Don Young, U.S. Representative, members of the Alaska
16 delegation in Congress.
