**A RESOLUTION**

**1 Supporting the continuation of at least the current level of all U.S. military facilities  
2 throughout Alaska, including Fort Richardson Army Post.**

**3 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

**4 WHEREAS changing world conditions and relationships have lead to pressure on the Congress  
5 and the President to reduce defense spending; and**

**6 WHEREAS reductions in defense spending would probably result in some cuts in personnel  
7 stationed at bases around the country because a very significant portion of defense spending is related  
8 to personnel costs; and**

**9 WHEREAS the U.S. military services have been reviewing the need for their current levels of  
10 military presence in Alaska, including the army post at Fort Richardson; and**

**11 WHEREAS, although military reductions have occurred in Europe and the Far East, Alaska's  
12 strategic importance should continue to grow in order to defend the interests of the United States in the  
13 Arctic and the Pacific Rim regions; and**

**14 WHEREAS in 1990, the military services in Alaska stood as the third largest industry in the  
15 state, accounting for 16 percent of the state's labor force and 13 percent of the state's payroll with  
16 expenditures on behalf of the military services in Alaska having an estimated \$2,700,000,000 effect on  
17 Alaska's economy; and**

**1        WHEREAS** Fort Richardson Army Post represents one of the largest concentrations of military  
**2 personnel in Alaska; and**

**3        WHEREAS** all of the military personnel and their families contribute significantly to the state's  
**4 economy and their presence is vital to the social fabric of the communities in which they live;**

**5        BE IT RESOLVED** that the Alaska State Legislature urges the President, the Congress, and the  
**6 U.S. military services to maintain at least the current level of all military facilities throughout Alaska,**  
**7 including the U.S. Army complement at Fort Richardson, which might be subject to closure.**

**11 Tempore of the U.S. Senate; the Honorable Thomas S. Foley, Speaker of the U.S. House of**  
**12 Representatives; Michael P. W. Stone, Secretary of the Army; H. Lawrence Garrett III, Secretary of the**  
**13 Navy; Donald B. Rice, Secretary of the Air Force; General Carl E. Mundy, Commandant, U.S. Marine**  
**14 Corps; Admiral William J. Kime, Commandant, U.S. Coast Guard; General Carl E. Vuono, Army Chief**  
**15 of Staff; Mr. Jim Courter, Chair, Defense Base Closure and Realignment Commission; General Thomas**  
**16 McInerney, Commander, Alaska Command; and to the Honorable Ted Stevens and the Honorable Frank**  
**17 Murkowski, U.S. Senators, and the Honorable Don Young, U.S. Representative, members of the Alaska**  
**18 delegation in Congress.**
