A BILL

FOR AN ACT ENTITLED

1 "An Act relating to the issuance of any class of guide-outfitter license to a person whose
2 sport fishing, hunting, trapping, or guide-outfitter license is suspended or revoked in
3 another state; and relating to the issuance of sport fishing, hunting, or trapping licenses,
4 permits, or tags to a person whose sport fishing, hunting, or trapping license is suspended
5 or revoked in another state; and providing for an effective date."

6 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

7 * Section 1. AS 08.54.310(a) is amended to read:

8 (a) The board shall

9 (1) prepare, grade, and administer

10 (A) a written and oral examination of an applicant for a guide-outfitter
11 license that requires demonstration that the applicant is qualified generally to provide
12 guide-outfitted hunts and, in particular, to guide-outfit in each game management unit the
13 applicant has selected; if an applicant demonstrates limited ability to read or write the

1 English language, the entire examination shall be administered orally; and
2 (B) an oral examination of a guide-outfitter who seeks an amendment of
3 a game management unit certification; the examination must require demonstration that
4 the guide-outfitter is qualified to provide guide-outfitted hunts in each new game
5 management unit for which the guide-outfitter seeks to be certified;
6 (2) determine qualifications of applicants for class-A assistant guide-outfitter,
7 marine mammal guide-outfitter, and assistant guide-outfitter licenses and authorize the issuance
8 of licenses to those who qualify;
9 (3) establish performance standards for providers of big game commercial services
10 and regulate the activities of these providers;
11 (4) compile, maintain, and publish an annual register of big game commercial
12 service providers subject to this chapter who have not been convicted of a violation of a state or
13 federal statute or regulation relating to the provision of big game commercial services; a big
14 game commercial services provider listed in the register whose license or permit is revoked or
15 suspended shall be removed from the register while the provider's license or permit is revoked
16 or suspended;
17 (5) prohibit guide-outfitting, transporting, and other big game commercial services
18 activities that are unsportsmanlike, unethical, unsafe, against principles of game conservation,
19 degrading to a profession subject to this chapter, or that adversely affect natural resources;
20 (6) after a hearing, revoke, suspend, or deny renewal of a license or permit under
21 AS 08.54.500 - 08.54.510;
22 (7) authorize issuance of transporter licenses;
23 (8) authorize issuance of commercial use permits;
24 (9) meet at least twice annually, once in Anchorage and once in another
25 municipality;
26 (10) provide for registration of base camps and facilities used by persons who are
27 licensed or who hold a permit under this chapter;
28 (11) require an applicant for issuance or renewal of any class of guide-
29 outfitter license to state in a written and signed document whether the applicant's right to
30 obtain, or exercise the privileges granted by, a sport fishing, hunting, trapping, or guide-
31 outfitting license is revoked or suspended in another state.

1 * **Sec. 2.** AS 08.54.350 is amended by adding a new subsection to read:

2 (d) A person may not receive a guide-outfitter license if the person's right to obtain, or
3 exercise the privileges granted by, a sport fishing, hunting, trapping, or guide-outfitting license
4 is suspended or revoked in another state.

5 * **Sec. 3.** AS 08.54.360 is amended by adding a new subsection to read:

6 (c) A person may not receive a marine mammal guide-outfitter license if the person's
7 right to obtain, or exercise the privileges granted by, a sport fishing, hunting, trapping, or guide-
8 outfitting license is suspended or revoked in another state.

9 * **Sec. 4.** AS 08.54.370 is amended by adding a new subsection to read:

10 (c) A guide-outfitter license or marine mammal guide-outfitter license may not be
11 renewed if the licensee's right to obtain, or exercise the privileges granted by, a sport fishing,
12 hunting, trapping, or guide-outfitting license is suspended or revoked in another state.

13 * **Sec. 5.** AS 08.54.380 is amended by adding new subsections to read:

14 (c) A person may not receive a class-A assistant guide-outfitter license if the person's
15 right to obtain, or exercise the privileges granted by, a sport fishing, hunting, trapping, or guide-
16 outfitting license is suspended or revoked in another state.

17 (d) A class-A assistant guide-outfitter license may not be renewed if the licensee's right
18 to obtain, or exercise the privileges granted by, a sport fishing, hunting, trapping, or guide-
19 outfitting license is revoked or suspended in another state.

20 * **Sec. 6.** AS 08.54.390 is amended by adding new subsections to read:

21 (c) A person may not receive an assistant guide-outfitter license if the person's right to
22 obtain, or exercise the privileges granted by, a sport fishing, hunting, trapping, or guide-outfitting
23 license is suspended or revoked in another state.

24 (d) An assistant guide-outfitter license may not be renewed if the licensee's right to
25 obtain, or exercise the privileges granted by, a sport fishing, hunting, trapping, or guide-outfitting
26 license is revoked or suspended in another state.

27 * **Sec. 7.** AS 16.05.330 is amended by adding a new subsection to read:

28 (d) A person may not receive a sport fishing, hunting, or trapping license or other permit
29 or tag issued under AS 16.05.330 - 16.05.430, if the person's right to obtain, or exercise the
30 privileges granted by, a sport fishing, hunting, or trapping license is suspended or revoked in
31 another state. A person who applies for a sport fishing, hunting, or trapping license or other

1 permit or tag issued under AS 16.05.330 - 16.05.430 shall sign a statement that the person's right
2 to obtain, or exercise the privileges granted by, a sport fishing, hunting, or trapping license is not
3 suspended or revoked in another state.

4 * Sec. 8. This Act takes effect January 1, 1993.
