**A BILL****FOR AN ACT ENTITLED**

1 "An Act providing for the issuance of general obligation bonds in the amount of  
2 \$314,185,454 for the purpose of paying the cost of water, sewer, waste disposal, and health  
3 care facility capital projects; and providing for an effective date."

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

5 \* **Section 1.** For the purpose of paying the cost of water, sewer, waste disposal, and health care  
6 facility capital projects, general obligation bonds of the state in the principal amount of not more than  
7 \$314,185,454 shall be issued and sold. The full faith, credit, and resources of the state are pledged to  
8 the payment of the principal of and interest and redemption premium, if any, on the bonds. The bonds  
9 shall be issued under the provisions of AS 37.15 as those provisions read at the time of issuance.

10 \* **Sec. 2.** If the issuance of the bonds is authorized by the qualified voters of the state, a special fund  
11 of the state to be known as the "1992 Water, Sewer, Waste Disposal, and Health Care Facility  
12 Construction Fund" shall be established, to which shall be credited the proceeds of the sale of the bonds  
13 described in sec. 1 of this Act except for the accrued interest and premiums.

14 \* **Sec. 3.** (a) The amount of \$80,181,989 is appropriated from the "1992 Water, Sewer, Waste

1 Disposal, and Health Care Facility Construction Fund" to the Department of Environmental Conservation  
 2 to be allocated among the following projects to enhance village safe water in the following cities and  
 3 unincorporated communities for the purposes and in the amounts stated subject to reallocation between  
 4 projects under AS 37.07.080(e):
