A BILL

FOR AN ACT ENTITLED

1 "An Act making an appropriation to the Department of Education for support
 2 of kindergarten, primary, and secondary education and community schools
 3 programs; and providing for an effective date."

4 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

5 * Section 1. (a) The sum of \$608,535,400 is appropriated from the general fund and from
 6 other funds in the amount listed to the Department of Education for the purposes expressed
 7 and allocated in the amounts listed for operating expenditures for the fiscal year ending
 8 June 30, 1994:
