**A BILL**

**FOR AN ACT ENTITLED**

1 "An Act relating to equipment, registration, and identification of custom collector  
2 vehicles; and providing for an effective date."

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 \* **Section 1.** AS 28.05 is amended by adding a new section to article 2 to read:

5 **Sec. 28.05.106. CUSTOM COLLECTOR VEHICLE EQUIPMENT. (a) A**  
6 **custom collector vehicle shall be equipped with**

- 7 (1) hydraulic service brakes on all wheels;  
8 (2) sealed beam or halogen headlights;  
9 (3) safety belts for all occupants;  
10 (4) turn signals and turn signaling switch;  
11 (5) safety glass or lexan;  
12 (6) electric or vacuum windshield wiper located in front of the driver;  
13 (7) standard or blue-dot taillights; and  
14 (8) a parking brake that operates on at least two wheels on the same

1 axle.

2 (b) Notwithstanding any other provisions of this title or regulations adopted  
3 under this title, the department may not require a custom collector vehicle to be  
4 equipped with a bumper, hood, or fenders.

5 (c) A custom collector vehicle shall be equipped in a manner that while in  
6 motion and functional on the vehicle's four rims on a flat surface, the suspension,  
7 steering, or chassis does not contact the highway, vehicular way, or area.

8 \* Sec. 2. AS 28.10 is amended by adding a new section to read:

9 Sec. 28.10.065. CUSTOM COLLECTOR VEHICLE REGISTRATION AND  
10 IDENTIFICATION. When the department is satisfied as to the ownership of a replica  
11 of a custom collector vehicle and the vehicle does not have an identification number,  
12 the department shall assign a vehicle identification number to the vehicle and have the  
13 number stamped on the vehicle. A custom collector replica vehicle shall be registered  
14 as a vehicle constructed during the period represented by the replica.

15 \* Sec. 3. AS 28.10.181 is amended by adding a new subsection to read:

16 (r) Special request custom collector plates. Upon application by the owner of  
17 a custom collector vehicle, the department may design and issue registration plates  
18 appropriate for custom collector vehicles. The department may disapprove the  
19 issuance of registration plates under this subsection when the requested plates are a  
20 duplication of an existing registration.

21 \* Sec. 4. AS 28.10.421(d)(2) is amended to read:

- 22 (2) special request plates for
- 23 (A) Alaska National Guard personnel . . . . . \$30;
- 24 (B) veterans or retired veterans . . . . . \$30;
- 25 (C) recipients of the Purple Heart . . . . . \$30;
- 26 (D) owners of custom collector vehicles . . . . . **\$50;**
- 27 (E) other special request plates . . . . . \$30;

28 plus the fee required for that vehicle under (b) of this section; the fee required by this  
29 paragraph shall be collected only on the first issuance and on the replacement of  
30 special request plates;

31 \* Sec. 5. AS 28.40.100(a) is amended by adding a new paragraph to read:

1 (23) "custom collector vehicle" means a vehicle whose body and frame  
2 were manufactured before 1949 or a replica of a vehicle whose body and frame were  
3 manufactured before 1949 and that has been modified for safe road use; in this  
4 paragraph, "modified" includes a material alteration of the drive-train, suspension,  
5 brake system, or dimensions of the body.

6 \* Sec. 6. This Act takes effect January 1, 1994.
