A BILL

FOR AN ACT ENTITLED

1 "An Act making appropriations for construction and major maintenance of
2 schools; and providing for an effective date."

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

4 * Section 1. The sum of \$107,688,000 is appropriated from the earnings reserve account
5 (AS 37.13.145) to the school construction grant fund (AS 14.11.005) and is allocated for
6 payment by the Department of Education as grants subject to AS 14.11.017(a) to the following
7 school districts and regional educational attendance areas (REAA) in the amounts listed for
8 the purposes expressed:
