**FOR AN ACT ENTITLED**

1 "An Act relating to school construction grants and major maintenance grants to  
2 school districts; providing for school district participation in the cost of school  
3 construction and major maintenance; creating a major maintenance grant fund;  
4 relating to reimbursement of school construction debt, and to school construction  
5 bonds issued by the Alaska Municipal Bond Bank Authority; creating an  
6 education facilities maintenance and construction fund; and providing for an  
7 effective date."

8 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

9 \* Section 1. AS 14.03.150(c) is amended to read:

10 (c) The department may not award a school construction or major  
11 maintenance grant under AS 14.11 to a municipality that is a school district or a  
12 regional educational attendance area that is not in compliance with (a) of this section.

16 participating share required under this section will jeopardize receipt of federal  
17 assistance, the commissioner may waive all or a portion of the required participating
