SUBJECT: Fiscal implications of HB No. 164

In response to your inquiry concerning the fiscal impact of HB 164, technically there would be no impact on the legislative budget. The bill, if passed, along with a companion Constitutional Amendment, merely seeks to clarify the fact that if a special session were called by either the legislature or the governor, the legislature must take up measures vetoed after adjournment of the last regular session.

Of course, any special session that is called always necessitates a supplemental appropriation to this office and the costs vary with the length of the session and the number of employees hired. Basic costs aside from employees include approximately \$15,000 for travel and \$2,100 per day for per diem.

CONTRACT for SERVICES

DEPARTMENT OF ENVIRONMENTAL CONSERVATION

This contract, entered into the 2nd day of July 19 74 and effective as of the 1st day of July, 19 74, between the State of Alaska, Department of Environmental Conservation, (hereinafter called the "State"), and Ken Roberts, (hereinafter called the "Contractor").

WITNESSETH that:

Whereas, the State is entering into this contract by direct negotiation and not by competitive bids because this is a contract for professional services;

Whereas, the Contractor is willing to undertake the performance of this contract under the terms of this contract;

Whereas, the Department of Environmental Conservation has the authority to enter into this contract by legislative intent as shown in State Legislative Finance committee meeting minutes of April 24, 1974.

NOW THEREFORE, the Parties hereto agree as follows:

Article I. The Service to be Performed.

Photographic documentation of the pipeline as follows:

1. Construction

Show in detail the actual construction of roads, camps, bridges, pump stations, air strips and other ancillary projects with special emphasis on engineering, actual laying of pipe, its burial and elevation.

2. Environmental Impact

Record the physical impact of pipeline construction, sites singled out by the State as environmentally significant. Show the measures taken in order to insure compliance with environmental standards set by State or federal agencies.

3. Sociological Impact

Record the construction-maturity-relocation cycle of camps and the environmental impact on camps, villages and cities of the great influx of people.

All photos, films and negatives will be the property of the State of Alaska and will be transmitted to the Pipeline Coordinator's office at frequent intervals or upon request of the Pipeline Coordinator. The Pipeline Coordinator will administer the contract, review and approve progress reports and invoices prior to payment, request specific areas of interest to be documented, and retain control of all pipeline documentation resulting from this contract. The Pipeline Coordinator will have final approval of all duplication and distribution of film, photos, etc. The Pipeline Coordinator will receive a log kept in log binders containing all negatives made, a contact proof of all negatives and a written text detailing the time, place and circumstances of the exposures shown on each contact proof sheet. Tape recorded interviews will be included where they are especially appropriate. The coordinator may request as many prints of any negatives, work prints of 16 mm movie film and final prints insofar as funds permit.

Article II. The Period for Performance.

The period of performance under this contract shall commence on July 1, 19 74, and expire on June 30, 19 75.

Performance may be extended for additional periods by the mutual written agreement of the parties.

Article III. Consideration.

In full consideration of the Contractor's performance hereunder, the State shall pay the Contractor \$35,000.00 in eleven monthly installments of \$2917 and one of \$2913. The contractor will submit an invoice each month to the Pipeline Coordinator giving a brief statement of progress and transmitting any completed film, negatives, etc. After approval the Office of the Pipeline Coordinator will forward the invoice to Environmental Conservation for payment.

Article IV. Additional Contract Provisions.

This contract is subject to all applicable laws of the State of Alaska.

Appendix A attached hereto and made a part hereof sets forth additional general contract provisions of this contract.

TRANS-ALASKA PIPELINE PHOTO HISTORY

Alaska history may well be written in terms of "before pipeline" and "after pipeline".

Because of the obvious historic importance of Trans-Alaska Pipeline construction ~~audits far reaching impact~~, the 8th Alaska Legislature provided for photo history to be made to record "the social, environmental and construction impact" of the Pipeline and provided \$35,000 toward that end.

As the project took shape it became apparent that even a minimal photo history could not be funded with this amount. This shortfall was not a surprise and had been anticipated. A Federal matching grant seemed certain to be forthcoming from the Bicentennial Commission. However that grant has not materialized and the shortfall is now jeopardizing the photo history project.

In keeping with the intent of the 8th Legislature, it is suggested that the State make up the dollar shortfall by means of a supplementary.

While the photo-history project has gotten off the ground and there has been produced a growing amount of photo documentation (often accompanied by taped interviews). The project is overseen by the Department of Environmental Conservation.

Exactly half of the original \$35,000 grant has been expended and the project has reached an impasse. Further progress will require the recommended sum of \$35,000 for the present fiscal year.

The accompanying fiscal data are rounded figures but represent conservative estimates rather than generous ones.

Not since the Rush of '98 has Alaska faced an historical turning point of the magnitude of the TransAlaska Pipeline. Future histories of Alaska will probably be written as "before Pipeline" and "after Pipeline". The coincidence of the construction of the TransAlaska Pipeline and the celebration of America's Bicentennial presents an unusual opportunity to document history in the making, history of major importance to both Alaska and the Nation.

A photographic documentary of the many phases and impacts of the Pipeline construction will be of invaluable assistance in explaining to present-day and future generations the significance and meaning of this unusual period of Alaska's history.

Undoubtedly other photographic logs will be kept in some fashion by interested groups. However, their motives and results could, and most likely will, disqualify their work from being free from bias.

The State of Alaska alone possesses the three essential qualities needed to produce an equitable, bona fide, historical documentary: 1) the financial resource; 2) legal access to the construction sites, and 3) the interests of all the people of Alaska.

For these reasons, an impartial third-party account of the construction of the Pipeline will be made from beginning to end for the State through a contract providing the necessary services.

Obviously, an in-house photographer will spare the State the expenses of purchasing photographs from other sources at inflated prices. And this documentary log will contribute heavily toward an information resource for the State of a sort that other states have both failed to provide for themselves and have been unable to secure from oil companies.

With these considerations in mind, the Alaska State Legislature has provided the sum of up to \$35,000 for documenting the construction of the TransAlaska Pipeline. These funds, or a part of them may be released by the Office of the Governor to match Federal funds to be authorized by the Bicentennial Commission.

The following, therefore, is a general proposal for a photographic documentary of the TransAlaska Pipeline.

Three concepts must be borne in mind within any similar proposal. First: a good proposal must leave room for both the unforeseen and the unforeseeable. Hence, this proposal does not pretend to be detailed; secondly, the goals set out in the proposal are intended to span the entire duration of the construction period. Consequently, some of the goals cannot be hoped to be realized in the single fiscal year that this proposal covers; thirdly, the documentary will chronicle the events occurring during the construction of the Pipeline, not to make a judgement on any other considerations relating to the Pipeline.

A "before-during-after" approach is used in virtually all documentary undertakings. This procedure will not only give an accurate representation of the immediate impact of pipeline construction but will also serve as a benchmark for long-range evaluation.

The proposed areas of particular interest in the documentary will be divided into three general headings: 1) Construction, 2) Environmental Impact, and 3) Sociological Impact.

Research resource material (such as the Environmental Assessment Atlas) will be sought from state and federal agencies and used to place the photographer in the right places at the right times.

CONSTRUCTION

The documentary will show in detail the actual construction of roads, camps, bridges, pump stations, air strips, and other ancillary projects. Equipment and techniques employed in dealing with the unique problems that confront arctic construction will be recorded. A special emphasis will be placed on the engineering excellence of the project.

Of course, the actual pipe laying, burial and elevation will receive thorough documentation.

ENVIRONMENTAL IMPACT

The documentary will record the environmental impact of Pipeline construction. Photos will show sites singled out by the State as environmentally significant. These photos will show the measures taken in order to insure compliance with environmental standards set by state or federal agencies.

Photographic techniques usually associated with biology and architecture will be added to supplement the standard documentary style. Visual and aesthetic impact will also be shown.

SOCIOLOGICAL IMPACT

The number of people working on the Pipeline will represent the largest work force ever assembled in Alaska. The effects of this large work force can be expected to drastically affect the Alaskan life style. The number of workers from other states who will claim Alaska as a permanent or semi-permanent home will undeniably contribute to the quality of life on nearly every level.

Camp life, the construction-maturity-relocation cycle of a camp, the daily routine, entertainment, emergencies and interesting personalities will be recorded. Equipment, lodging, meals, transportation,

impromptu engineering specialities, moments of triumph and disappointment will be included.

The life of the Pipeline workers off the job will also have a place in the documentary. The role that Pipeline workers and their families will play in various communities will have a direct immediate impact on the quality of Alaskan living.

Likewise, life in the villages along the line will be affected in significant ways and will be photographed.

SUGGESTED TERMS OF THE CONTRACT

The contract should be a standard State contract and should include the following:

- (a) The photographer-documenter will contract to the Bicentennial Commission.
- (b) The contract shall provide an annual salary of \$25,000 to be paid in equal monthly installments.
- (c) The contract shall provide for an expense account of \$25,000 to cover the costs of film, processing, chemicals, paper, subsistence and travel.
- (d) The work year will be eleven months long and will provide for a one-month sabbatical. Work time will be divided into two categories: approximately two thirds of the work time will be spent in the field making exposures and approximately one third of the work time will be spent in the laboratory producing prints.
- (e) The State shall receive a log kept in log binders containing copies of all negatives made for the documentary, a contact proof of all negatives, and a written text detailing the time, place and circumstances of the exposures shown on each contact proof sheet. Tape recorded interviews will be included where they are especially appropriate. Additionally, the State will receive as many prints of any negative made for the documentary and work prints of 16mm movie film and final prints insofar as the expense account permits.
- (f) The Office of the Governor will supply the photographer with authorization that will assure him of legal access to all Pipeline construction activities.
- (g) The State will provide \$25,000 of the total and the Bicentennial Commission will match this sum with an additional \$25,000.
- (h) There shall be time provided to present a progress report to the Legislature during the legislative session, if the Legislature so desires.

BUDGET APPENDIX

This Appendix is a revised budget. Several conditions of the "Proposal" will be changed to stay in line with this budget. These changes will be noted below.

Two features of this revision of the proposal deserve mention: first, this proposal asks that a grant of \$35,000 federal dollars (matching \$35,000 from the State of Alaska) be made to the Environmental Conservation Commission for the purpose of the Photographic Documentary of the Pipeline as outlined in the proposal and the following budget.

Second, the Environmental Conservation Commission, and eventually, perhaps, the Division of Libraries will administer the project. The Division of Libraries will be the eventual recipient of the work.

Several categories appear in this budget appendix that require perhaps, some comment:

Secretarial service names a part time service that would keep the photographer documenter in the field aware of incoming communications and assure him that essential paper work will be done without recalling the photographer from the field.

A 16 mm film technician is a part time job that will provide a trained person to assist in filming in those circumstances where two film makers are required (eg. sound synch.). This same technician could be charged with seeing to the processing and making of a work print of the 16 mm movie film.

Operative names a part time assistant who would be able to stand in for the documenter when either two or more events calling for documentation occur simultaneously or when an event that calls for documentation does not justify

an expenditure of time or travel by the documenter. These operatives will be preselected on a geographic basis, eg. Anchorage, Valdez, Fairbanks, Prudhoe should each have an operative.

All of these positions will be filled on the recommendation of the documenter with the approval of the administrating agency head (eg. Commissioner of Environmental Conservation) on a contract basis.

The "Proposal" should be amended in the following way. Under "Proposed Terms of Contract"--

(a) The Photographer-documenter will contract to the Environmental Conservation Commission who will administer the project. The final product however will be delivered to the Division of Libraries.

(b) same

(c) The contract shall provide for an expense account of \$45,000, to cover Transportation, Materials, Assistants and Lodging (see appendix).

(f) The State will supply \$35,000 of the total and the Bicentennial Commission will match this sum with an additional \$35,000 in Federal dollars.

A GUIDE TO PHOTOGRAPHICALLY RECORDING THE PIPELINE PROJECT AND A REFERENCE OUTLINE FOR FUTURE RESEARCH USE OF THE MATERIAL AS COMPILED.

PREFACE

A BRIEF HISTORICAL PERSPECTIVE ALONG WITH EXPLANATORY NOTES ON THE APPROACH USED IN DRAFTING THE SYLLABUS.

GENERAL OUTLINE

1. THE RECORD SHOULD BE AURAL AS WELL AS VISUAL, A TAPE RECORDER BEING USED TO RECORD SOUNDS ASSOCIATED WITH STILL PHOTOGRAPHS; FURTHER, IT SHOULD BE AS COMPREHENSIVE AS POSSIBLE BY COVERING EVERY UNUSUAL PHASE OF THE PROJECT FROM STEEL MILLS, TO WALL STREET TO THE IMPACT ON WISEMAN OR MARSHALL.
2. THIS AUDIO/VISUAL RECORD WOULD, IN ADDITION TO STILL AND MOTION PICTURE FILMS, INCLUDE ENGINEERING DRAWINGS OF INNOVATIVE DESIGNS AND A COPY OF THE "AS-BUILT" OF THE COMPLETED PIPELINE.
3. THE MATERIAL WILL BE AS ORGANIZED AND COORDINATED AS POSSIBLE BUT NOT A "DOCUMENTARY." THAT IS, MOVIE FILM IS TO BE CATALOGED IN SIMILAR FASHION TO NEWSREEL CLIPS AND STILL PHOTOGRAPHS WILL BE PHYSICALLY OR INDEX-LINKED TO IDENTIFYING CAPTION MATERIAL.
4. A LARGE PART OF THIS EFFORT IS TO BE IN THE FORM OF RESEARCH AND COMPILATION OF MATERIAL FROM ALYESKA PIPELINE SERVICE CO., NEWS MEDIA ANY OTHER AVAILABLE SOURCES TO FILL OUT THE RECORD OF THIS HISTORIC EVENT BACK TO THE 1968 PRUDHOE BAY DISCOVERY.

ASPECTS FOR COVERAGE

1. MECHANICAL--THE TOTAL TRANSPORTATION SYSTEM FROM WELLHEAD TO REFINERY INCLUDING DRILLING - GATHERING AND TREATING SYSTEM - PIPELINE TERMINAL - SHIPS - RECEIVING FACILITIES.

4. PHYSICAL IMPACT--FLORA AND FAUNA EXPERIMENTS AND PROTECTION SCHEMES - BEFORE AND AFTER PICTURES AT VARIOUS POINTS ALONG PIPE ROUTE - EMPHASIS ON POINTS OF SPECIAL CONCERN SUCH AS GRAPEFRUIT ROCK AND KEYSTONE CANYON.
5. SOCIAL IMPACT-- PICTURES OF THE SOLE NATIVE RESIDENCE AT FRUDHOE BAY.- PHOTOS AND RECORDINGS IN ALL COMMUNITIES ALONG THE PIPE ROUTE AFFECTED, INCLUDING ANCHORAGE - ALSO BUSH COMMUNITIES FROM WHICH LARGE NUMBERS OF WORKERS DRAWN.
6. FUTURE SOCIOECONOMIC FACTORS--THE HAUL ROADS, THE RCA COMMUNICATIONS NETWORK - LARGE NEW AIRFIELDS THAT ARE EXPECTED TO BECOME NEW COMMUNITIES.

CHRONOLOGICAL SUMMARY

1. FOR THE CONVENIENCE OF FUTURE STUDENTS OF THE SUBJECT, MATERIAL WILL BE ARRANGED, OR CROSS INDEXED, IN THE CHRONOLOGICAL ORDER IN WHICH KEY EVENTS OCCURRED.

The Division of State Libraries will have final approval of all duplication and distribution of film, photos, etc. The Contractor shall maintain a log kept in log binders containing all slides, negatives made, a contact proof of all negatives and a written text detailing the time, place and circumstances of the exposures shown on each contact proof sheet. Tape recorded interviews will be included where they are especially appropriate.

for

ALASKA PIPELINE BOOM

DOCUMENTATION PROJECT

This is a proposal to document the boom expected in Alaska in connection with the construction of the Alaska Pipeline, for the benefit of historians, sociologists, economists and other scholars. There is no known previous planned attempt to document a boom as it happens, and experience gained should be of value to others who need to record major socio-economic events.

Principal characteristics of the project are:

1. Planning. An attempt is made to ascertain which specific kinds of information are needed, in what form they will exist, and where they may be obtained.

2. Aggressive collection. There will be no reliance on chance, no assumption that the information will be available at a later date. Instead, data will be actively sought.

3. Comprehensive indexing. Materials collected will be indexed so as to permit retrieval by discipline, geographic area, ethnic group and information source.

This is a four-year project beginning in the spring of 1974.

Project director: H. Theodore Ryberg, Director of Libraries, University of Alaska.

Background

In the fall of 1969 the State of Alaska sold oil lease rights in the Prudhoe Bay area to a number of oil companies. The size of the oil field is indicated by the fact that the oil companies paid about \$900,000,000 for the leases. The oil is, however, located in a remote region with no railroads, roads, or navigable waterways, and the companies immediately began research to find the best way to get the oil to market. One highly publicized experiment was that in which the tanker Manhattan tested the feasibility of a northwest passage through the Arctic ice.

And result of the experiments was a decision to build an 800-mile long pipeline from the Prudhoe Bay area to Valdez, the only ice-free port on the south coast of Alaska. Tankers are to pick up the oil in Valdez and transport it to West Coast ports. In order to begin recouping their investment, the oil companies formed a consortium to build the pipeline, made tentative commitments to contractors, and began shipping in pipe. Construction was to begin in 1970, but suits filed by environmentalist organizations forced repeated postponement of the \$2,500,000,000 project.

Recent developments in the international oil market, combined with fuel oil shortages in some areas of the United States during the winter of 1972-73 and gasoline shortages in 1973, brought about Congressional realization that action was imperative. A bill to exempt the pipeline from provisions of the environmental impact law has passed both houses of Congress and all indications are that pipeline construction will begin in 1974.

Alaska expected an influx of out-of-state oil workers as the pipeline got underway, and experience in the summer of 1970 confirmed this expectation. For a short time oil field equipment firms opened expediting offices in Fairbanks, high-level company executives rented suites of offices in Anchorage, and construction workers and college students from all over the country began arriving and looking for work. (One group of college students from New England even bought an old bus which they drove all the way to Fairbanks.)

Unemployment is high in Alaska in the winter. In the summer a short, highly intensive construction season, tourist business, and some mining combine to reduce the rate of unemployment among permanent residents and afford jobs to some out-of-state transients. The normal job market in the summer of 1970 was far from being able to handle the throngs of job-seekers. As it became clear that the environmentalist challenge to the pipeline was not an easily-solved problem most of the newcomers left, and so far few have returned. There is little doubt that Congressional approval of the pipeline and the resulting construction will bring them back.

Predictions

Alaska is in for a boom. Unscrupulous "overseas employment" firms, advertising "high-paying jobs in Alaska," exaggerated word-of-mouth accounts of roughnecks earning \$20,000 a year, the romantic aura of the Last Frontier, and even the simple unadorned truth about Alaska will combine to bring a flood of job-seekers, small businessmen, adventurers, drifters and gamblers into the state.

If past experience is any guide many will fly up (some in luxurious first-class comfort), others will put a camper on a pickup truck and drive the Alaska Highway, and probably a few families will load all of their belongings on a converted school bus or 1 1/2-ton van and creep slowly over the 4,000-5,000 miles between home and Alaska. Almost certainly college students will crowd into elderly cars or hitchhike up the Alaska Highway.

Housing will be scarce, schools overcrowded, community services strained. Alaska residents will in some cases feel that the outsiders are depriving them of the better jobs, local businessmen will resent competition from newcomers, there will be sharp controversy as to whether the transients are paying their fair share of the tax burden, and accusations of price gouging will fill the air.

How long will the boom last? No one is quite sure, and estimates depend to some extent on guesses as to the amount of local construction which will be postponed until maximum pipeline impact is over, the number and kind of subsidiary enterprises (including refineries) which the pipeline will attract, whether a natural gas pipeline is also built, and the proportion of jobs falling to permanent Alaska residents. The best estimates at this date indicate a leveling-off about four years from the time pipeline construction begins.

Seldom in American history has there been as much clear forewarning of a boom. The California and Klondike gold rushes, the Oklahoma land rush, even the Miami boom of the 1920's simply exploded. Delay of the Alaska pipeline by environmentalist suits, however, has made it possible not only to predict that there will be a boom but also to tell with some certainty when it will start and about how long it will last.

Documentation of previous booms was unplanned and spotty. Newspapers started and folded (or moved on to the next strike), diaries were kept--and often lost or thrown away on the death of the diarist, broadsides and handbills were preserved accidentally, if at all, and memoirs appearing in later years were often colored by self-justification or showed that memories are fallible. Modern electronic recording technology did not exist. In the absence of a project such as this, documentation of this boom will follow a similar pattern.

Proposal

This is a proposal to document the Alaska pipeline boom as it happens, so that future historians and other scholars may have the primary source materials so necessary for their work--and which too often are sorely lacking. Documentation to be sought will include all printed ephemera: handbills, broadsides, signs, mimeographed newsletters and bulletins; photographs, both commercial and amateur; menus, timetables, manuscript diaries, journals and letters. Clipping files from newspapers and magazines will furnish continuity and give coverage of broader scope.

Much of what happens never gets into print. In order to record non-print facets of the boom there will be a series of interviews, recorded on audio tape or film. This will not be the "oral history" kind of recording currently popular, since tapes made years after the event are of little value for the purposes above for memoirs. Rather, interviewees will be reporting their current observations, hopes and fears, and the same person interviewed at the beginning, middle, and end of the boom may produce three quite different stories. Film will also be used to record such matters as life in construction camps, supply flights to the oil fields, strikes, and temporary encampments.

Plan

The project plan calls for an aggressive collection effort. Members of the History Department, University of Alaska at Fairbanks, will establish collection guidelines. The Director of Collections will then, in consultation with the Project Director, Assistant Directors, and two librarians on the project staff, prepare specific instructions as to the kinds of materials to be collected and the geographical areas of collection. Conferences between these individuals and History Department professors will be utilized to iron out any differences and ensure that all concerned are operating on the same premises.

As presently envisioned, the Director of Collections, two librarians, secretary and student assistants will work in the Elmer E. Rasmuson Library, University of Alaska at Fairbanks. This will also be the home base for two collectors and two interviewer/photographers.

The pipeline impact area will be divided into two sectors: northern sector, Fairbanks-North Pole to Prudhoe Bay area; and southern sector, everything south of North Pole. A team of one collector and one interviewer/photographer will be assigned to each sector and will make repeated trips in it. It is anticipated that much of the time in the first few trips will be devoted to establishing a network of volunteer informants and collectors who will furnish information and gather materials for the team.

Upon return from a trip the team will turn in its collections, be debriefed, and be briefed for the next trip. Materials collected will be cataloged and filed by one of the two librarians, with the aid of student assistants. Cataloging will follow usual Library of Congress procedures, except that there will always be a geographic location index card. (Geographic indexing will also aid the Director of Collections to ensure that no significant areas are left unreported.)

The other librarian on the project will be responsible for the newspaper and magazine clipping files. Student assistants will do the actual clipping and filing under the librarian's supervision. The indexing system used will be identical with that used for the other materials, so that everything containing a specific subject or geographical location may be drawn together.

Upon completion of the project all materials and files will be housed in the Elmer B. Rasmuson Library of the University of Alaska at Fairbanks. The collection will be available for use by researchers. Microfilms of printed and written materials and copies of films and tapes will be sold at cost to any library or other non-profit agency.

The project will be directed by the Director of Libraries of the University of Alaska, H. Theodore Ryberg.* Assistant directors will be Paul H. McCarthy, Jr., University Archivist and Curator of Manuscripts; and Charles H. Parr, Arctic Bibliographer. Professors William Hunt, Claus Laske, Orlando Miller, James Foster, and Herman Slotnick of the History Department, University of Alaska at Fairbanks, will prepare the guidelines for the collection effort and act as an advisory board for the duration of the project.

CONTRACT for SERVICES

DEPARTMENT OF ENVIRONMENTAL CONSERVATION

This contract, entered into the 2nd day of July 19 74 and effective as of the 1st day of July, 19 74, between the State of Alaska, Department of Environmental Conservation, (hereinafter called the "State"), and Ken Roberts, (hereinafter called the "Contractor").

3. Sociological Impact

Record the construction-maturity-relocation cycle of camps and the environmental impact on camps, villages and cities of the great influx of people.

All photos, films and negatives will be the property of the State of Alaska and will be transmitted to the Pipeline Coordinator's office at frequent intervals or upon request of the Pipeline Coordinator. The Pipeline Coordinator will administer the contract, review and approve progress reports and invoices prior to payment, request specific areas of interest to be documented, and retain control of all pipeline documentation resulting from this contract. The Pipeline Coordinator will have final approval of all duplication and distribution of film, photos, etc. The Pipeline Coordinator will receive a log kept in log binders containing all negatives made, a contact proof of all negatives and a written text detailing the time, place and circumstances of the exposures shown on each contact proof sheet. Tape recorded interviews will be included where they are especially appropriate. The coordinator may request as many prints of any negatives, work prints of 16 mm movie film and final prints insofar as funds permit.

Article II. The Period for Performance.

The period of performance under this contract shall commence on July 1, 19 74, and expire on June 30, 19 75.

Performance may be extended for additional periods by the mutual written agreement of the parties.

Article III. Consideration.

In full consideration of the Contractor's performance hereunder, the State shall pay the Contractor \$35,000.00 in eleven monthly installments of \$2917 and one of \$2913. The contractor will submit an invoice each month to the Pipeline Coordinator giving a brief statement of progress and transmitting any completed film, negatives, etc. After approval the Office of the Pipeline Coordinator will forward the invoice to Environmental Conservation for payment.

Article IV. Additional Contract Provisions.

This contract is subject to all applicable laws of the State of Alaska.

Appendix A attached hereto and made a part hereof sets forth additional general contract provisions of this contract.

for

ALASKA PIPELINE BOOM

DOCUMENTATION PROJECT

This is a proposal to document the boom expected in Alaska in connection with the construction of the Alaska Pipeline, for the benefit of historians, sociologists, economists and other scholars. There is no known previous planned attempt to document a boom as it happens, and experience gained should be of value to others who need to record major socio-economic events.

Principal characteristics of the project are:

- 1. Planning. An attempt is made to ascertain which specific kinds of information are needed, in what form they will exist, and where they may be obtained.
- 2. Aggressive collection. There will be no reliance on chance, no assumption that the information will be available at a later date. Instead, data will be actively sought.
- 3. Comprehensive indexing. Materials collected will be indexed so as to permit retrieval by discipline, geographic area, ethnic group and information source.

This is a four-year project beginning in the spring of 1974.

Project director: H. Theodore Ryberg, Director of Libraries, University of Alaska.

Background

In the fall of 1969 the State of Alaska sold oil lease rights in the Prudhoe Bay area to a number of oil companies. The size of the oil field is indicated by the fact that the oil companies paid about \$900,000,000 for the leases. The oil is, however, located in a remote region with no railroads, roads, or navigable waterways, and the companies immediately began research to find the best way to get the oil to market. One highly publicized experiment was that in which the tanker Manhattan tested the feasibility of a northwest passage through the Arctic ice.

End result of the experiments was a decision to build an 800-mile long pipeline from the Prudhoe Bay area to Valdez, the only ice-free port on the south coast of Alaska. Tankers are to pick up the oil in Valdez and transport it to West Coast ports. Eager to begin recouping their investment, the oil companies formed a consortium to build the pipeline, made tentative commitments to contractors, and began shipping in pipe. Construction was to begin in 1970, but suits filed by environmentalist organizations forced repeated postponement of the \$2,500,000,000 project.

Recent developments in the international oil market, combined with fuel oil shortages in some areas of the United States during the winter of 1972-73 and gasoline shortages in 1973, brought about Congressional realization that action was imperative. A bill to exempt the pipeline from provisions of the environmental impact law has passed both houses of Congress and all indications are that pipeline construction will begin in 1974.

Alaska expected an influx of out-of-state oil workers as the pipeline got underway, and experience in the summer of 1970 confirmed this expectation. For a short time oil field equipment firms opened expediting offices in Fairbanks, high-level company executives rented suites of offices in Anchorage, and construction workers and college students from all over the country began arriving and looking for work. (One group of college students from New England even bought an old bus which they drove all the way to Fairbanks.)

Unemployment is high in Alaska in the winter. In the summer a short, highly intensive construction season, tourist business, and some mining combine to reduce the rate of unemployment among permanent residents and afford jobs to some out-of-state transients. The normal job market in the summer of 1970 was far from being able to handle the throngs of job-seekers. As it became clear that the environmentalist challenge to the pipeline was not an easily-solved problem most of the newcomers left, and so far few have returned. There is little doubt that Congressional approval of the pipeline and the resulting construction will bring them back.

Predictions

Alaska is in for a boom. Unscrupulous "overseas employment" firms, advertising "high-paying jobs in Alaska," exaggerated word-of-mouth accounts of roughnecks earning 220,000 a year, the romantic aura of the Last Frontier, and even the simple unadorned truth about Alaska will combine to bring a flood of job-seekers, small businessmen, adventurers, drifters and gamblers into the state.

If past experience is any guide many will fly up (some in luxurious first-class comfort), others will put a camper on a pickup truck and drive the Alaska Highway, and probably a few families will load all of their belongings on a converted school bus or 1 1/2-ton van and creep slowly over the 4,000-5,000 miles between home and Alaska. Almost certainly college students will crowd into elderly cars or hitchhike up the Alaska Highway.

Housing will be scarce, schools overcrowded, community services strained. Alaska residents will in some cases feel that the outsiders are depriving them of the better jobs, local businessmen will resent competition from newcomers, there will be sharp controversy as to whether the transients are paying their fair share of the tax burden, and accusations of price gouging will fill the air.

How long will the boom last? No one is quite sure, and estimates depend to some extent on guesses as to the amount of local construction which will be postponed until maximum pipeline impact is over, the number and kind of subsidiary enterprises (including refineries) which the pipeline will attract, whether a natural gas pipeline is also built, and the proportion of jobs falling to permanent Alaska residents. The best estimates at this date indicate a leveling-off about four years from the time pipeline construction begins.

Seldom in American history has there been as much clear forewarning of a boom. The California and Klondike gold rushes, the Oklahoma land rush, even the Miami boom of the 1920's simply exploded. Delay of the Alaska pipeline by environmentalist suits, however, has made it possible not only to predict that there will be a boom but also to tell with some certainty when it will start and about how long it will last.

Documentation of previous booms was unplanned and spotty. Newspapers started and folded (or moved on to the next strike), diaries were kept--and often lost or thrown away on the death of the diarist, broadsides and handbills were preserved accidentally, if at all, and memoirs appearing in later years were often colored by self-justification or showed that memories are fallible. Modern electronic recording technology did not exist. In the absence of a project such as this, documentation of this boom will follow a similar pattern.

Proposal

This is a proposal to document the Alaska pipeline boom as it happens, so that future historians and other scholars may have the primary source materials so necessary for their work--and which too often are sorely lacking. Documentation to be sought will include all printed ephemera: handbills, broadsides, signs, mimeographed newsletters and bulletins; photographs, both commercial and amateur; menus, timetables, manuscript diaries, journals and letters. Clipping files from newspapers and magazines will furnish continuity and give coverage of broader scope.

Much of what happens never gets into print. In order to record non-print facets of the boom there will be a series of interviews, recorded on audio tape or film. This will not be the "oral history" kind of recording currently popular, since tapes made years after the event have the same value as described above for memoirs. Rather, interviewees will be reporting their current observations, hopes and fears, and the same person interviewed at the beginning, middle, and end of the boom may produce three quite different stories. Film will also be used to record such matters as life in construction camps, supply flights to the oil fields, strikes, and temporary encampments.

Plan

The project plan calls for an aggressive collection effort. Members of the History Department, University of Alaska at Fairbanks, will establish collection guidelines. The Director of Collections will then, in consultation with the Project Director, Assistant Directors, and two librarians on the project staff, prepare specific instructions as to the kinds of materials to be collected and the geographical areas of collection. Conferences between these individuals and History Department professors will be utilized to iron out any differences and ensure that all concerned are operating on the same premises.

As presently envisioned, the Director of Collections, two librarians, secretary and student assistants will work in the Elmer E. Rasmuson Library, University of Alaska at Fairbanks. This will also be the home base for two collectors and two interviewer/photographers.

The pipeline impact area will be divided into two sectors: northern sector, Fairbanks-North Pole to Prudhoe Bay area; and southern sector, everything south of North Pole. A team of one collector and one interviewer/photographer will be assigned to each sector and will make repeated trips in it. It is anticipated that much of the time in the first few trips will be devoted to establishing a network of volunteer informants and collectors who will furnish information and gather materials for the team.

Upon return from a trip the team will turn in its collections, be debriefed, and be briefed for the next trip. Materials collected will be cataloged and filed by one of the two librarians, with the aid of student assistants. Cataloging will follow usual Library of Congress procedures, except that there will always be a geographic location index card. (Geographic indexing will also aid the Director of Collections to ensure that no significant areas are left unreported.)

The other librarian on the project will be responsible for the newspaper and magazine clipping files. Student assistants will do the actual clipping and filing under the librarian's supervision. The indexing system used will be identical with that used for the other materials, so that everything pertaining to a specific subject or geographical location may be drawn together.

Upon completion of the project all materials and files will be housed in the Elmer E. Rasmuson Library of the University of Alaska at Fairbanks. The collection will be available for use by researchers. Microfilms of printed and written materials and copies of films and tapes will be sold at cost to any library or other non-profit agency.

The project will be directed by the Director of Libraries of the University of Alaska, E. Theodore Nyberg.* Assistant directors will be Paul H. McCarthy, Jr., University Archivist and Curator of Manuscripts; and Charles H. Parr, Arctic Bibliographer. Professors William Hunt, Claus Laske, Orlando Miller, James Foster, and Herman Slotnick of the History Department, University of Alaska at Fairbanks, will prepare the guidelines for the collection effort and act as an advisory board for the duration of the project.

Attached is a letter I received from Mr. Ken Roberts concerning an initial payment in the amount of \$2,917.00.

I am not in a position to pass judgment on the appropriateness of this billing as I have never seen a copy of the contract nor was I asked for an opinion on the finalization of any contract. As we discussed earlier, the production of a documentary film of the pipeline construction would not seem to fall within the jurisdiction of my office. We did not request money for such an endeavor in the budget that was agreed to by Alyeska. You will recall that Easy Gilbreth advised you by phone during the legislative session that Alyeska would not agree to this being a reimbursable expense particularly since they already have their own photographic contractor. To include it at this time without their concurrence would seem to definitely put us in the position for their auditors to make an exception for such expenditures.

I am not certain as to the reason the Department of Environmental Conservation suggested to Mr. Roberts that he submit his billings to us for approval. Brief Statement of Progress

Progress for the month of September breaks down into three divisions.

First, an arrangement was at last made with the Coordinators Office and Alyeska to give the Photo-Documenter authorized access to whatever site locations he sees as necessary to the documentary effort.

Secondly, seven days were spent in the Valdez to Isabel section of the line. Slides and negatives were made and a good number of interviews were conducted with a wide spectrum state and city agencies including the city manager, the dept. of highways, the superintendent of schools and the terminal project engineer as well private business people.

Thirdly, a format and an organization have taken shape. First the format. People with expertise ("experts") in various areas relating to pipeline impact are contacted. Using whatever information they supply, photographs are taken with a view to represent the understanding that our "expert" has of impact. The photos are next returned to the "expert" for comment. If the expert finds that the photos fall short of showing his understanding, they are reshot with his suggestions. When an acceptable set of photos are produced, the expert is then asked to make a statement on why these photos show impact as he believes it to be. His statement and "his" photos will be introduced into the final documentary file. Altho the process is time consuming, it appears to offer the best means of achieving an honest account of the many perspectives of pipeline impact.

Now for the organization. I have hired, on a part time basis, two competent writer-photographers to supplement my efforts. One will work in the Anchorage-Kenai area, keeping files of what is published by the media, and researching federal, state, city and borough agencies for evidence of impact. He will then shoot photos of impact using the above technique. The other writer-photographer will cover the Fairbanks-Richardsons Highway Community, again using the same technique and with a special view to impact on native communities.




The Department of Environmental Conservation requests authority to allocate \$35,000 in general funds from State services pipeline impact. The funds will be allocated to the department's indirect impact appropriation, and will be used to pay for a contract to provide photographic documentation of construction of the trans-Alaska pipeline. The contract is for the entire fiscal year, and is made with the Department of Environmental Conservation based on legislative intent as shown in State Legislature finance committee meetings of April 24, 1974 as further clarified by a letter from the Senate finance committee chairman dated July 29, 1974.

The contract was initially approved on the assumption that the funds to pay for the contract would be provided from Alyeska on a reimbursable basis. Subsequent to the approval of the contract, notification was received from Alyeska that the contract did not fall within the "Fair and Reasonable Expense" reimbursement clause of the pipeline right-of-way agreement. Therefore, general funds are required to fund the contract.

Your approval is recommended in accordance with the provisions of SLA 1974, Ch. 147. Sec. 12 (b).





The attached RP provides \$35,000 from the Departments indirect pipeline account to fund a contract with Ken Roberts to document construction of the Trans-Alaska pipeline. Attached is a letter I received from Mr. Ken Roberts concerning an initial payment in the amount of \$2,917.00.

I am not in a position to pass judgment on the appropriateness of this billing as I have never seen a copy of the contract nor was I asked for an opinion on the finalization of any contract. As we discussed earlier, the production of a documentary film of the pipeline construction would not seem to fall within the jurisdiction of my office. We did not request money for such an endeavor in the budget that was agreed to by Alyeska. You will recall that Easy Gilbreth advised you by phone during the legislative session that Alyeska would not agree to this being a reimbursable expense particularly since they already have their own photographic contractor. To include it at this time without their concurrence would seem to definitely put us in the position for their auditors to make an exception for such expenditures.

I am not certain as to the reason the Department of Environmental Conservation suggested to Mr. Roberts that he submit his billings to us for approval. At this time, I have no doubt that the making of a film by the State of Alaska does not fall within the "fair and reasonable expenses" clause of Section 18 of the Trans Alaska Pipeline Right-of-Way Agreement.
