We are requesting that you amend CSHB 593 by adding \$536,800 in general fund to implement capital and operating budget recommendations made by the Governor's Task Force on Corrections for implementation during the current fiscal year.

The attached capital budget and revised program forms display the requested supplemental amount. Of the total, \$438,500 is for capital projects and \$98,300 is for part year operating costs.

The FY 77 Governor's budget is also being amended to include \$953,400 which will continue these and other Task Force recommendations. Department of Public Safety FY 76 operating costs were absorbed by releasing funds earlier restricted by the Governor.

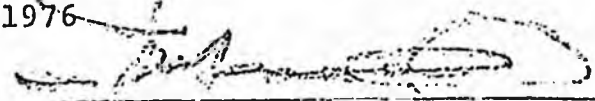
More positions will be included in the FY 76 supplemental, but action on these four positions is in our opinion of highest priority.

**DESCRIPTION** This facility is presently used as a halfway house and an overflow short term detention facility, operating in a minimum to medium security environment. The plan calls for moving the halfway house function into the community and converting the facility for medium to maximum security use. The conversion will require extensive renovations before medium/maximum security prisoners should be held. The renovation should not take more than three (3) months to complete once bid awards are made. Effective completion will be accomplished within six (6) months of funding.

The FY '76 Capital appropriation included 25.6 which was allocated for a smoke detention system and self-extinguishing range hood installation for 3rd Ave. The bids for this fire protection system which were opened on February 10 exceeded the capital appropriation balance by 32.8/

DESCRIPTION This facility currently serves the full range of correctional security functions for the Fairbanks area with short term detention and local intake as its primary mission. The facility also has a new maximum security prisoner housing unit. A 900 lineal foot double security fence is planned in the capital budget for the perimeter of the exercise yard. It is now thought that a 3400 lineal foot fence which could encompass the total facility site area would provide a greater measure of physical security from potential escapes. The fence would include a razor ribbon crown, electronic gates and lighting. It is not expected that the completion of the fence will seriously interrupt the follow-on construction planned for the physical plant, since that construction will take place within the perimeter of the fence.

Per your telephone call yesterday, February 4th, I will try to clarify in greater detail the basis for our requested supplemental.

Replace interagency receipts with General Fund - 151.6

The appropriation for Juvenile Confinement BRU components for local facilities and out-of-state facilities was based on \$151.6 in estimated (federal) interagency receipts. These receipts were to come from the Division of Social Services based upon the ability of Corrections' juveniles to meet federal eligibility requirements. These receipts will not be totally realized in FY76 for several reasons. The ratio of eligibles has dropped drastically and the interpretation of eligibility is being challenged. This \$151.6 request will not increase the Division of Corrections spending authority, but rather it is intended to give notice that the source of funding for our existing appropriation should be changed due to the anticipated shortfall in (federal) interagency receipts. Receipts from eligibility, if any, will be credited to the General Fund as revenue when received. (See latest federal interpretation letter from Joseph McGavick, 1-5-76, attachment #1).

Full Cost of Care to 70 beds - 42.6

The current FY76 budget provides for 66 private institution beds at our standard cost of \$39.00 per day. Our utilization projections after the first quarter indicated that we would need approximately 70 beds for the balance of the fiscal year. (365 days x .75 x \$39.00/day x 4 needed beds).

Prior year charges to current year - 35.0

The Juvenile Confinement BRU experienced \$23,200 worth of medical bills and \$13,000 worth of private institution and various other bills being processed after year end closing. Funds were available in the prior year so the bills could be charged to current year. This request seeks to replace current year funds which were expended on prior year bills to maintain the integrity of our current year appropriation. (See attachment #2, expenditure journal listing of prior year charges).

Federal Bureau of Prisons - 25.5

Two invoices remain unpaid for services rendered by Lompoc. One is for \$12,260 which was received after fiscal year closing but should have been encumbered. The other is for \$6,900 which is in error. Lompoc has been notified to rebill, which on the basis of our computation would bring the invoice to \$13,249. (See attachment #3).

Nome Jail Renovations - 9.0

The previously submitted package of documents traces the history of the Nome Jail Renovations. The funds were not encumbered when they were appropriated on last fiscal year's supplemental nor could the invoices be found to process payment before the year end expired. There was no conscious effort on our part to spend those appropriated funds on other projects or hide the Nome Jail invoices. When the books were closed this item was left over. If it hadn't been, another 9.0 worth of invoices would have been left over; undoubtedly the last 9.0 worth of invoices that were paid at the time of year end closing. In an eight million dollar BRU budget it is difficult to identify any one specific cause of a one-half of one percent variance in spending.

Juvenile Confinement totals \$229,200 for all three areas.

Program receipts totaling \$151,600 were appropriated for FY 76 based on projections of AFDC eligibility for juveniles under institutional custody of the Division of Corrections. No eligibility determinations have been made as of December 15, 1975, and the arrangement has been questioned by federal officials. Any revenues realized would be transmitted to the State General Fund as unrestricted receipts instead of used as program receipts if the supplemental is approved.

Unpaid bills from prior years may not be paid from current authorizations unless sufficient funds were lapsed in prior years to allow theoretical payment from prior year funds. Besides the de facto overexpenditure of last year's appropriation, an \$8,971 bill, approved for payment under last year's supplemental, was not paid.

Full-cost-of-care projections show a net requirement of \$42,600. The original agency request was \$185,000 but was acknowledged as overstated by \$142,400, because the population projections were too high.

Full-cost-of-care supplemental request, 250.0; revised to 237.8.

Private institution beds will probably average 70 for the fiscal year assuming we open the fourth cottage at MYC as planned, out-of-state placements remain stable, and Alcantra doesn't close. On that basis our supplemental request is overstated by 10 full-cost-of-care beds, i.e., 10 beds x \$39 per day x 365 = \$142.4.

However, other current influences offset the over-statement.

1. 35.0 worth of prior year bills have been charged to the current year juvenile confinement budget.
2. 85.2 worth of interagency receipts, which have not been previously discounted, probably will not be realized. Eligibility determinations dropped off drastically (none processed so far this fiscal year) and federal representatives are questioning the propriety of existing interagency agreements.

In summary, it seems that our request is more likely overstated by \$22.2 (142.4 - 120.2) rather than \$168.0. Adjusted accordingly, our request should be revised to \$237.8 (250.0 - 22.2).

Unpaid bills supplemental request, 18.8; revised to 32.6.

The Federal Bureau of Prisons produced a second late billing for 6.9 which is chargeable to prior year. That particular billing contains a serious computation error which, when corrected, will double the invoice amount. The authorities have been asked to re-invoice, however, the new amount will be 13.2, which must be added to our outstanding request if payment is to be made.

Your FY 76 supplemental appropriation request will be \$168,300 overstated if the number of juveniles in private institutions stays at the same level as it was during the first quarter of FY 76.

The first quarter actual count was 68 beds of in-state private institutional care. There are no known past seasonal variations that would project the rate rising to an average count of 80 beds for the entire year. It is noted that need was reduced from the 85 beds budgeted to the supplemental request of 80 beds. However, if the first quarter experience holds true for the whole year, then the supplemental request will be overstated by \$168,300 or  $(80 - 68) \text{ beds} \times \$36.42/\text{day} \times 365 \text{ days/bed}$ .

If there are major cost increases expected, that should be taken into account in calculations, as should any other expected variable.

Please advise why your supplemental request should not be reduced by \$168,300.

As we discussed at our last meeting in November, our office is reviewing your claim for Federal Financial Participation under AFDC-FC for delinquent children committed to the Department of Health & Social Services.

We have received an interpretation from our Central Office which has been cleared through the Office of General Counsel which will allow some FFP under certain conditions. I believe you received a copy of this interpretation during my visit in November.

In order to be eligible for AFDC-Foster Care, all the conditions in 45 CFR 233.110 must be met, not just 233.110(a)(1)(iii) which requires that the placement and care of the child be the responsibility of the State agency administering or supervising the AFDC plan, or, at States' election, the responsibility of another public agency with whom the State agency has an agreement.

The Department of Health and Social Services in Alaska is the umbrella agency for health, welfare and corrections and as such is responsible for administering or supervising the AFDC plan. If the court in removing the children in question from their homes has given the Department of Health and Social Services responsibility for their placement and care it follows then that their placement and care is the responsibility of the State agency, administering or supervising the AFDC plan, as specified in the regulation section referred to above.

However, within the Department of Health and Social Services, responsibility must be fixed for determining the initial eligibility of the child for AFDC-FC, for developing a plan for the child and providing necessary services, for redetermining eligibility, for reviewing the continued need for and appropriateness of care every 6 months and for meeting all the requirements of the State plan as specified in 45 CFR 233.110. Also, eligibility for each child would have to be established in accordance with 45 CFR 233.110(a)(1).

in the Department of Health and Social Services the welfare unit responsible for the AFDC program and, as such, is responsible for the AFDC-FC program. However, if the Department assigns responsibility of the delinquent child to the corrections unit, there must be an agreement between the two operating units which includes provision for assuring development of a plan, satisfactory to the welfare agency, for such child. } RSA

\* [ Federal matching for any current claims would be dependent on the existence of such an agreement.

- We do want to clarify that removal from the home because of delinquency does not in itself exclude a child from eligibility for AFDC-FC.

Federal regulation in 45 CFR 233.110(a)(1) provides that: "AFDC-FC will be given in the form of foster care for each otherwise eligible child:

- (1) Who was removed after April 30, 1961, from the home of a relative specified in the AFDC plan, as a result of a judicial determination that continuance in the home of the relative would be contrary to his welfare, for any reason, and who has been placed in foster care as a result of such determination;"

You will note that the child may have been removed "for any reason". This has been interpreted broadly to include situations where the child's behavior, as well as that of parents, may be the basis for the court's determination to remove the child.

Therefore, because a child is delinquent is not in itself a basis for denying AFDC-FC as long as all conditions specified in 45 CFR 233.110 are met. (In other words; the court order must also indicate that in addition to delinquency, there were dependency factors involved in the removal of the child from the home.)

If the court however, has given responsibility for care and placement to the corrections agency in the State which is completely separate and apart from the agency administering the State plan for AFDC, the requirement in 45 CFR 233.110(a)(1)(iii) would not be met and such child would clearly not be eligible. Moreover, a child placed in a detention facility or correctional institution, i.e., a public facility, is not eligible for AFDC-FC. Under the Statute, AFDC-FC is limited to children in a licensed or approved foster family home or private non-profit child care institution.

Juvenile Confinement totals \$229,200 for all three areas.

Program receipts totaling \$151,600 were appropriated for FY 76 based on projections of AFDC eligibility for juveniles under institutional custody of the Division of Corrections. No eligibility determinations have been made as of December 15, 1975, and the arrangement has been questioned by federal officials. Any revenues realized would be transmitted to the State General Fund as unrestricted receipts instead of used as program receipts if the supplemental is approved.

Unpaid bills from prior years may not be paid from current authorizations unless sufficient funds were lapsed in prior years to allow theoretical payment from prior year funds. Besides the de facto overexpenditure of last year's appropriation, an \$8,971 bill, approved for payment under last year's supplemental, was not paid.

Full-cost-of-care projections show a net requirement of \$42,600. The original agency request was \$185,000 but was acknowledged as overstated by \$142,400, because the population projections were too high.

As we discussed at our last meeting in November, our office is reviewing your claim for Federal Financial Participation under AFDC-FC for delinquent children committed to the Department of Health & Social Services.

We have received an interpretation from our Central Office which has been cleared through the Office of General Counsel which will allow some FFP under certain conditions. I believe you received a copy of this interpretation during my visit in November.

In order to be eligible for AFDC-Foster Care, all the conditions in 45 CFR 233.110 must be met, not just 233.110(a)(1)(iii) which requires that the placement and care of the child be the responsibility of the State agency administering or supervising the AFDC plan, or, at States' election, the responsibility of another public agency with whom the State agency has an agreement.

The Department of Health and Social Services in Alaska is the umbrella agency for health, welfare and corrections and as such is responsible for administering or supervising the AFDC plan. If the court in removing the children in question from their homes has given the Department of Health and Social Services responsibility for their placement and care it follows then that their placement and care is the responsibility of the State agency administering or supervising the AFDC plan, as specified in the regulation section referred to above.

However, within the Department of Health and Social Services, responsibility must be fixed for determining the initial eligibility of the child for AFDC-FC, for developing a plan for the child and providing necessary services, for redetermining eligibility, for reviewing the continued need for and appropriateness of care every 6 months and for meeting all the requirements of the State plan as specified in 45 CFR 233.110. Also, eligibility for each child would have to be established in accordance with 45 CFR 233.110(a)(1).

In the Department of Health and Social Services the welfare unit is responsible for the AFDC program and, as such, is responsible for the AFDC-FC program. However, if the Department assigns responsibility of the delinquent child to the corrections unit, there must be an agreement between the two operating units which includes provision for assuring development of a plan, satisfactory to the welfare agency, for such child. Federal matching for any current claims would be dependent on the existence of such an agreement.

- We do want to clarify that removal from the home because of delinquency does not in itself exclude a child from eligibility for AFDC-FC.

Federal regulation in 45 CFR 233.110(a)(1) provides that: "AFDC-FC will be given in the form of foster care for each otherwise eligible child:

- (1) Who was removed after April 30, 1961, from the home of a relative specified in the AFDC plan, as a result of a judicial determination that continuance in the home of the relative would be contrary to his welfare, for any reason, and who has been placed in foster care as a result of such determination;"

You will note that the child may have been removed "for any reason". This has been interpreted broadly to include situations where the child's behavior, as well as that of parents, may be the basis for the court's determination to remove the child.

Therefore, because a child is delinquent is not in itself a basis for denying AFDC-FC as long as all conditions specified in 45 CFR 233.110 are met. (In other words, the court order must also indicate that in addition to delinquency, there were dependency factors involved in the removal of the child from the home.)

If the court however, has given responsibility for care and placement to the corrections agency in the State which is completely separate and apart from the agency administering the State plan for AFDC, the requirement in 45 CFR 233.110(a)(1)(iii) would not be met and such child would clearly not be eligible. Moreover, a child placed in a detention facility or correctional institution, i.e., a public facility, is not eligible for AFDC-FC. Under the Statute, AFDC-FC is limited to children in a licensed or approved foster family home or private non-profit child care institution.

### CSHB 593 Letter of Intent

It is the intent of the House Finance Committee that the supplemental appropriation be allocated as follows:

1. \$151,600 to fund an anticipated shortfall in Federal receipts for juveniles under institutional custody of the Division of Corrections.
2. \$42,600 to fund full cost of care of four juveniles' beds in private institutions for three-fourths of FY 76 (365 days X .75 X \$39.00/day X 4 beds).
3. \$9,000 to pay for Nome jail renovation that was authorized in 1972 and took place during 1973. Through various circumstances the FY 73 funds lapsed without the bill being paid. The Department of Health and Social Services requested funds to pay the bill and their request was fulfilled in a supplemental appropriation [SLA 75 Ch 51 (CSHB 251)], but the bill was not paid from that appropriation. The money was used to pay other prior year bills. To ensure that the department does finally pay for the jail renovation it has been set out as a specific item.
4. \$58,600 for prior year bills. The department did not encumber FY 75 funds for these bills. But, for the most part they were paid with the FY 76 appropriation. The agency sought funds to replace this FY 76 money.

Originally the Nome jail renovation debt was part of the \$76,600 requested for prior year bills. The committee does not feel the department has exercised diligent accounting practices in dealing with prior year billings. To encourage the department to alter this situation, the committee has appropriated \$9,000 less than the department requested.

The committee does not feel the department has exercised diligent accounting practices in dealing with prior year billings.
