9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. (a) There is created the Interim Joint Legislative Committee
11 on Land Use. The committee is composed of three members from the House,
12 appointed by the speaker of the House, and three members from the Senate,
13 appointed by the president of the Senate. At least one of the members from
14 each house shall be appointed from the minority party.

15 (b) The committee shall consider the feasibility of replacing the Joint
16 Federal-State Land Use Planning Commission (AS 41.40.010 - 41.40.120), and,
17 if replacement is feasible, recommend methods to accomplish it. The committee
18 shall hold hearings as appropriate to accomplish its purpose.

19 (c) The committee shall report its findings and recommendations to the
20 legislature by January 31, 1976.

21 * Sec. 2. This Act takes effect July 1, 1975.

22 * Sec. 3. This Act terminates January 31, 1976.

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. (a) There is created the Interim Joint Legislative Committee
11 on Land Use. The committee is composed of three members from the House,
12 appointed by the speaker of the House, and three members from the Senate,
13 appointed by the president of the Senate. At least one of the members from
14 each house shall be appointed from the minority party.

15 (b) The committee shall consider the feasibility of replacing the Joint
16 Federal-State Land Use Planning Commission (AS 41.40.010 - 41.40.120), and,
17 if replacement is feasible, recommend methods to accomplish it. The committee
18 shall hold hearings as appropriate to accomplish its purpose.

19 (c) The committee shall report its findings and recommendations to the
20 legislature by January 31, 1976.

21 * Sec. 2. This Act takes effect July 1, 1975.

22 * Sec. 3. This Act terminates January 31, 1976.
