For years we have prepared annual reports to the APUC which require data that we have to submit to the Rural Electrification Administration, U.S. Dept. of Agriculture but in different form.

It amazes me why each government agency which regulates or otherwise controls non-profit cooperative utilities periodically requires a different set of forms. The ultimate result does nothing more than raise the cost of utility service to the consumer.

I am enclosing a copy of my letter of April 13, 1979 to the APUC which addresses this problem. As a matter of interest, the letter was never answered.

This is in response to your annual reports required by all utilities as referenced in Alaska Statutes 42.05.451 and prepared with the perspective of both Nushagak Electric Co-operative, Inc. (NEC) and Nushagak Telephone Co-operative, Inc. (NTC).

In the calendar year 1978, NTC had \$375,000 gross operating revenues. This sum has the dubious distinction of qualifying this Co-operative organization as a Class B telecommunication utility which substantially changes our reporting requirements. Your agency requires over 70 pages of miscellaneous statistics in the Class B annual report. This requirement is particularly onerous especially in view of the fact that our banker, the Rural Electrification Administration, is fully satisfied with a much more compact and readable form that you do not utilize. This would seem to be not only an unnecessary waste of taxpayer's money but, more importantly, the subscriber's investment in this Co-operative.

On January 25, 1979, Governor Hammond addressed "duplication" in his statement on Over Regulation. This is a very real problem now that is facing all utilities but having the greatest effect on the smaller utilities. It should also be recognized that a major contribution to the overwhelming paperwork buildup in recent years are problems associated with the easement and rights of way acquisition. This is not an area of your responsibility obviously, but I believe that you should be aware of all trends that affect utility operations to any significant degree.

We have discussed the possibility of the APUC utilizing various REA forms but the major objection has been that the REA forms are not common to all utilities. This is certainly true, but it would appear that the public good would still be served, perhaps even better, if all REA financed utilities were allowed to submit copies of all applicable REA year end forms to the APUC. After all, they are standardized over all

rural areas of the nation and have presumably served the Rural Electrification Administration as well as the subscriber/consumer well. It is pretty hard to set one's sights any higher than that for the public good.

In conclusion, I do wish you would reconsider some of your reporting requirements. They are time consuming and expensive especially so to the smaller utilities. They add to the expanded burden of work required to keep the phones working and the lights on.



At its meeting of September 12, 1979, the City Council of Kaltag responded to your card as enclosed.

Spoke with Terry Earley, C&RA, 465-4730, today regarding the proposed regulation on property tax exemptions for senior citizens. No regulation has been drafted yet, but the AG's office suggests that they clarify the statute.

The statute says that senior citizens are exempt on permanent place of abode. Right now permanent place of abode is defined as their home and such land surrounding it for convenient use. C&RA wants to clarify that to mean 1 acre urban or 5 acres rural.

The exemptions are granted by the municipalities and are reimbursed by the state. The local assessors got together and decided on these figures, so C&RA wants to clarify their position and make it the same for everyone.

They will send us a copy of the regulation when it's drafted.

(a) It is unlawful to operate a motor vehicle with studded tires or tires with chains attached on a paved highway or road from May 1 through September 15, inclusive, north of 60° North Latitude and from April 15 through September 30, inclusive, south of 60° North Latitude. The commissioner of public safety shall by emergency order provide for additional lawful operating periods based on unusual seasonal or weather conditions. An emergency order adopted under this section is not subject to the Administrative Procedure Act (AS 44.62). Upon application a special individual traction permit may be issued allowing the operation of a motor vehicle with studded tires or chains at any time at the discretion of the vehicle owner. The fee for the special individual permit is one-third of the annual license tax applicable to that class of vehicle under AS 28.10.200. The department may provide an appropriate sticker or other device identifying the vehicle to which the permit applies.

(b) In this section "studded tire" means a tire with metal studs or spikes imbedded in the periphery of the tire surface, and protruding not more than one-fourth inch from the tire surface. (§ 9 ch 241 SLA 1976)

No more slack may be left in safety chains, cables or equivalent devices than is necessary to permit proper turning, and the safety chains, cables or equivalent device shall be connected to the towed and towing vehicle and to the drawbar so as to prevent the drawbar from dropping to the ground if the drawbar fails and shall be of sufficient strength to retain control of the towed vehicle in the event of failure of the regular hitch or coupling. Dear Senator Bennett:

I have been an Alaska resident for over 32 years. There is one Law or regulation that has upset my over all plans for my continued residence in Alaska. I plan on retiring from my present position in about two years. If at all possible, I intend to remain in Alaska. I cannot imagine living any other place. In order to continue living in Alaska I will of course need some additional income. The law that upsets my plans for supplementing my retirement income is the Limited Entry law.

Since coming to Alaska in 1947, I have always had it in my mind to do a little trolling or gill netting after I retired. The reason I did not get into fishing as an occupation then was that I felt that I needed to have a more reliable income to raise my family on. I have raised six children, the last of which graduated and left home last year. Now I am facing my retirement years and I find that I will need to spend in excess of \$10,000.00 for a permit if I wish to get into Salmon fishing. I cannot afford that amount and buy a boat too.


I would like to see legislation that would allow the issuance of Salmon fishing permits to long time Alaska residents. This should be a one person non re-salable permit. It could be awarded to persons who have lived in Alaska for 20, 25 or 30 years, retired and are over 50 years of age and continue to make Alaska their principal place of residence.

Legislation of this type would not cost the State one cent but would help some long time Alaskans. The few who would take advantage of it would not create any hardship to the Salmon industry.

I personally do not believe that any resident Alaskan should be denied the right to fish commercially in Alaskan waters.

I would really appreciate it if you would advise me if this proposal is feasible or not.
