CS FOR SENATE BILL 574

MR. PRESIDENT, I MOVE THE ADOPTION OF CS FOR SB 574, WHICH IS IDENTICAL, AT THIS POINT, TO THE HOUSE BILL FOR THE SAME BOARD. WE HAVE WORKED JOINTLY TO TRY TO PREVENT AN UNNECESSARY AND OFTEN TIME-CONSUMING FREE CONFERENCE COMMITTEE.

THIRD READING

I will attempt to cover the changes ^{to current law} by section as quickly as possible

(Sec. 08.54.010) ● SECTION 1 ESTABLISHES THE GUIDE LICENSING AND CONTROL BOARD SOLELY IN THE DIV. OF FISH AND WILDLIFE PROTECTION OF THE DEPT. OF PUBLIC SAFETY. CURRENTLY, THE BOARD IS ESTABLISHED IN THE DIV. OF OCCUPATIONAL LICENSING OF THE DEPT. OF COMMERCE AND ECONOMIC DEVELOPMENT AND THIS DIVISION PLUS THE DIV. OF FISH AND WILDLIFE PROTECTION OF THE DEPT. OF PUBLIC SAFETY SHARE THE RESPONSIBILITY FOR STAFF SUPPORT. THIS SECTION ALSO ENSURES THAT THREE MEMBERS OF THE BOARD WILL BE ACTIVELY INVOLVED IN GUIDING AND THE REMAINING FOUR WILL HAVE NO INVOLVEMENT IN THE GUIDING BUSINESS. CURRENTLY, THREE MEMBERS ARE JUST REQUIRED TO HAVE A GUIDE LICENSE AND THE OTHER FOUR A GENERAL KNOWLEDGE OF GAME RESOURCES.

(Sec. 08.54.020) ● SECTION 2 PROVIDES THAT THE MEMBERS OF THE BOARD MAY NOT BE APPOINTED FOR MORE THAN TWO CONSECUTIVE TERMS. A TERM IS FOR THREE YEARS. CURRENTLY, THERE IS NO LIMIT TO HOW MANY CONSECUTIVE TERMS A MEMBER MAY SERVE *if appointed.*

(SEC. 08.54.030) ● SECTION 3 REQUIRES THAT THE BOARD MUST ELECT A CHAIRMAN AND A VICE-CHAIRMAN ANNUALLY. THE CHAIRMAN MAY NOT SERVE FOR MORE THAN TWO CONSECUTIVE TERMS. TESTIMONY INDICATED THAT SUCH ROTATION WOULD ASSURE THAT THE BOARD WOULD BE MORE RESPONSIVE TO THE PUBLIC INTEREST. CURRENTLY, THERE IS NO LIMIT TO HOW LONG A CHAIRMAN CAN SERVE.

(SEC. 08.54.070(A)) ● SECTION 4 REQUIRES GUIDE LICENSE FEES TO BE PAID BIENNIALLY AND GENERALLY INCREASES THEM 25 TO 30 PERCENT.

(SEC. 08.54.182) ● SECTION 5. PERSONS SEEKING REGISTERED AND MASTER GUIDE LICENSES MUST PASS AN EXAMINATION, AND THAT EXAMINATION SHALL BE HELD TWICE A YEAR AT BOTH JUNEAU AND ANCHORAGE FOR THE CONVENIENCE OF APPLICANTS. CURRENTLY, THE EXAMINATIONS ARE ADMINISTERED ONLY IN ANCHORAGE.

(SEC. 08.54.190(A)) ● SECTION 6 ELIMINATES A LICENSURE PROVISION FOR AIR TRANSPORTERS AND IT ASSURES THAT ALL GUIDE LICENSES ARE VALID FOR AT LEAST ONE FULL YEAR. UNDER EXISTING LAW, ALL LICENSES EXPIRE ON DECEMBER 31 FOLLOWING ISSUANCE REGARDLESS OF WHEN THEY WERE ISSUED. PERSONNEL IN THE DIV. OF FISH AND WILDLIFE PROTECTION CONSIDER THE "TRANSPORTER LAWS" CONFUSING AND DIFFICULT TO ENFORCE. IN ADDITION, THE INFORMATION AND REPORTS THAT TRANSPORTERS ARE REQUIRED TO FILE ARE NOT BEING ACCOMPLISHED AND ARE NOT NEEDED TO MANAGE THE GAME RESOURCES OF THE STATE. *Testimony was unanimous that the transporter license should be eliminated.*

(Sec. 08.54.190(b)) P. 2, L. 23 ● SECTION 7 REQUIRES THAT AN ASSISTANT GUIDE OR A CLASS-A ASSISTANT GUIDE THAT HAS NOT RENEWED HIS LICENSE FOR FOUR YEARS MAY NOT BE RENEWED UNTIL HE MEETS THE QUALIFICATIONS FOR AN INITIAL LICENSE. CURRENTLY, THE GRACE PERIOD IS FOR ONLY TWO YEARS.

(Sec. 08.54.200(a)) P. 2, L. 28 ● SECTION 8. UNDER EXISTING LAW, THE BOARD IS REQUIRED TO HOLD A HEARING TO CONSIDER DISCIPLINARY ACTION IF IT RECEIVED COMPLAINTS FROM THREE OR MORE SEPARATE PARTIES TO WHICH A LICENSEE HAS PROVIDED SERVICES. NO TIME PERIOD WAS INDICATED; IT COULD BE THREE COMPLAINTS IN THIRTY YEARS, ^{which is impractical} SECTION 8 PROVIDES A TIME PERIOD OF FIVE YEARS WITHIN WHICH THESE COMPLAINTS MUST BE RECEIVED BEFORE THE BOARD IS REQUIRED TO HOLD A DISCIPLINARY HEARING. THIS SECTION ALSO PROVIDES THAT THE BOARD IS NO LONGER OBLIGATED TO HOLD A DISCIPLINARY HEARING WHEN A LICENSEE IS MERELY CHARGED WITH A VIOLATION OF FEDERAL OR STATE SPORT FISH, GAME OR GUIDE STATUTES OR REGULATIONS. HOWEVER, UPON A CONVICTION, THE BOARD IS STILL REQUIRED TO HOLD A DISCIPLINARY HEARING.

(Sec. 08.54.200(c)) P. 3, L.9 ● SECTION 9 PROVIDES THE BOARD THE OPTION OF REVOKING, SUSPENDING, OR DENYING RENEWAL OF A LICENSE IF THE BOARD FINDS THAT THE LICENSEE DOES NOT MEET CERTAIN REQUIREMENTS. UNDER EXISTING LAW, THE BOARD WAS REQUIRED TO REVOKE THE LICENSE UPON SUCH A FINDING. THIS SECTION ALSO PROVIDES THAT SPECIFIED DISCIPLINARY

ACTION MUST BE TAKEN BY THE BOARD ONLY WHEN A LICENSEE HAS BEEN CONVICTED OF TWO VIOLATIONS OF FEDERAL OR STATE SPORT FISH, GAME OR GUIDE STATUTES OR REGULATIONS WITHIN THE PAST FIVE YEARS. UNDER CURRENT LAW, TWO VIOLATIONS TRIGGER MANDATORY DISCIPLINARY ACTION REGARDLESS OF THE TIME PERIOD.

(Sec. 08.54.210(A)(1)) ● SECTION 10 REMOVES REFERENCE TO A TRANSPORTER P. 3, L. 20 BECAUSE TRANSPORTERS WILL NO LONGER BE LICENSED UNDER THIS ACT. (SEE SECTION 6 AND SEC. 08.54.142 AND 144)

(Sec. 08.54.210(A)(2)) ● SECTION 11 REMOVES REFERENCE TO A TRANSPORTER. P. 3, L. 26

(Sec. 08.54.210(A)(4)) ● SECTION 12 REMOVES REFERENCE TO A TRANSPORTER. P. 4, L. 5

(Sec. 44.41.020) ● SECTION 13 PROVIDES THAT A NEW DUTY OF THE DEPT. OF PUBLIC SAFETY SHALL BE THE SOLE RESPONSIBILITY FOR ADMINISTRATIVE STAFF SUPPORT OF THE GUIDE LICENSING AND CONTROL BOARD (SEE SECTION 1).

(Sec. 08.03.010(c)) ● SECTION 14 PROVIDES FOR JUNE 30, 1984, AS THE TERMINATION DATE FOR THE GUIDE LICENSING AND CONTROL BOARD.

P. 4, L. 16 ● SECTION 15. THIS SECTION REPEALS PROVISIONS WHICH ARE INCONSISTENT WITH THIS ACT,

AS 08.01.010(20) REMOVES THE GUIDE LICENSING AND CONTROL BOARD FROM THE LIST OF BOARDS TO WHICH CHAPTER 01 APPLIES, SINCE THIS BOARD

WILL NO LONGER BE ADMINISTERED BY THE
DEPT. OF COMMERCE AND ECONOMIC DEVELOPMENT.

SUBJECT: Section-by-section analysis of SB 574 dealing with the Guide Licensing and Control Board (Work Order No. 8526)

TO: Senator Brad Bradley

You have requested a section-by-section analysis of Senate Bill 574 entitled "An Act continuing the existence of the Guide License and Control Board and amending the law relating to its powers and responsibilities; and providing for an effective date."

Section 1. The Guide Licensing and Control Board is established in the division of fish and wildlife protection, Department of Public Safety. This amendment ensures that three members of the board will be involved in guiding and that the remaining four members will have no involvement in the guiding business.

Section 2. This amendment provides that members of the board may not be appointed for more than two consecutive terms. Since a term is for three years, a person would have to wait three years before being reappointed to the board after serving two terms. There is no limitation on the total number of terms which a person may serve on the board.

Section 3. The board must elect a chairman and a vice-chairman annually.

Section 4. This section generally increases fees required for licenses to engage in the profession of guiding.

Section 5. Persons seeking licenses must pass an examination, and that the examination shall be held twice a year at both Juneau and Anchorage for the convenience of applicants.

Section 6. This section is amended to eliminate a licensure provision for transporters and to assure that a license is valid for at least one full year. Under existing law all licenses expire on December 31st following issuance regardless of when they were issued.

Section 7. An assistant guide license which has not been renewed for four years may not then be renewed until the applicant meets the qualifications for an initial license. Under the existing statute only a two-year grace period is provided.

Section 8. Under existing law the board is required to hold a hearing to consider disciplinary action if it receives complaints from three or more separate parties which a licensee has provided services to. The amendment provides a time period of five years within which these complaints must be received before the board is required to hold a disciplinary hearing. This section is also amended so that the board is no longer obligated to hold a disciplinary hearing when a licensee is merely charged with a violation of federal or state sport fish, game or guide statutes or regulations. Upon a conviction, however, the board is still required to hold a disciplinary hearing.

Section 9. The board is permitted the option of revoking, suspending, or denying renewal of a license if the board finds that the licensee does not meet certain requirements. Under existing law the board was required to revoke the license upon such a finding. This section is also amended to provide that specified disciplinary action must be taken by the board only when a licensee has been convicted of two violations of federal or state sport fish, game or guide statutes or regulations within the past five years. Under current law, two violations trigger mandatory disciplinary action regardless of the time period between the violations.

Section 10. This section is amended to remove reference to a transporter because transporters will no longer be licensed under this act.

Section 11 A reference to a transporter is deleted.

Section 12 A reference to a transporter is deleted.

Section 13 A new duty of the Department of Public Safety shall be the administration of the Guide License and Control Board.

Section 14. June 30, 1984 is set as the termination date for the Guide License and Control Board.

Section 15. This section repeals provisions which are inconsistent with this act.

AS 08.01.010(20) removes the Guide Licensing and Control Board from the list of boards to which Chapter 01 applies, since this board will no longer be administered by the Department of Commerce and Economic Development;

AS 08.03.010(b)(7) repeals the sunset provision for this board;

AS 08.54.100(5) eliminates the board's discretion to set qualifications in addition to those established by statute for licensure of master guides;

AS 08.54.110(12) eliminates the board's discretion in establishing qualifications for registered guide licenses in addition to those established by statute;

AS 08.54.142 repeals the section dealing with licensure of transporters;

AS 08.54.144 repeals the restrictions on transportation of hunters;

AS 08.54.146 repeals the section requiring preparation and filing of transporter reports;

AS 08.54.170(c) eliminates the license fee for a transporter;

AS 08.54.240(5) removes the definition of "transporting" and "activity of transporting";

AS 16.05.340(e) eliminates fees charged to master guides and registered guides for the taking of specified game animals;

Section 16. This act takes effect June 30, 1980, the date on which the board is scheduled to terminate.

5. Expiration and renewal (08.54.190)

Change license renewal from the existing one year to two years.

6. Appointment and terms of office (08.54.020)

Members of the board may not serve more than two consecutive terms.

7. Creation and membership of board. (08.54.010)

There is created the Guide License and Control Board consisting of seven members. [NO MORE THAN THREE MEMBERS OF THE BOARD SHALL HAVE A GUIDE LICENSE] Three members of the board shall be active licensed guides receiving a substantial portion of their income from guiding activities.

8. Sec. 08.54.030 Chairman of Board. The board shall annually elect one of its members as chairman [.] and one of its members as vice chairman.

9. AS 16.05.340(e) repeal of head tax.

10. Sec. 08.54.170. License fees. (a) License fees for engaging in the profession of guiding are:

(1) master guide license, biennial	[75]	\$200
(2) registered guide license, biennial	[75]	\$200
(3) class A assist and guide, biennial	[15]	\$50
(4) assistant guide license, biennial	[10]	\$30

11. Sec. 08.54.100(5) eliminate this section.

[MEETS ADDITIONAL QUALIFICATIONS WHICH THE BOARD MAY REQUIRE.]

This change will mean that all guides will be operating by law and not isolated regulations.

12. Examinations: Instead of one exam per year for registered and master guides there should be two exams per year in two different areas of the state-i.e., one in Anchorage, one in Juneau.

III. ANALYSIS (See Fiscal Note Preparation Instructions, Section III)
 Operational funding for the Guide Licensing and Control Board would be required to include the establishment of two positions, an Administrative Assistant I (range 12) and a Clerk-Typist III (range 8) and associated costs. These two positions would be located in Anchorage under the Director of the Fish & Wildlife Protection Division, and would provide administrative and clerical support to the Board. Travel costs are estimated for five members of the Board plus the Administrative Assistant for three meetings (approximately twelve days each) annually. The costs shown for FY81 also include office equipment for the new positions and an audio recording system to be used to document testimony and Board actions in cases of license suspension, revocation, or denial which are litigated. Dollar amounts shown after FY81 include a 7% inflation factor.

If the Board membership is increased, travel costs will be correspondingly higher than the estimates indicated.

The Department currently does not have sufficient clerical staff to adequately administer the Guide Licensing and Control Board.

This position would be responsible for all clerical support to the Board, including transcriptions of Board meetings for use in possible hearings and litigations. At present, some of this work is being accomplished by the Director's staff to the detriment of other duties and obligations. Approximately 15,000 financial remuneration statements submitted by guides annually are currently being filed by professional level investigators, decreasing their time available for program operations.

Some of the functions, in part, are currently being accomplished by the Dept. of Commerce. When the Board is transferred to this Department, however, clerical support will not be transferred. Denial of this position will result in program ineffectiveness, as professional level staff will have to be diverted to clerical work as indicated above.

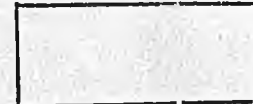

Request: Legal Review of the Powers, Duties and Performance of the State Guide Licensing and Control Board

The House Resources Committee is considering the merits of continuation or termination of the Guide Licensing and Control Board under the Sunset review process. Because the Guide Board's mandate and procedures have been the subject of numerous legal questions, it seems appropriate to request that your department review certain issues which are beyond the expertise of Legislative audit.

A substantial portion of the Guide Board's time, since its creation, has been devoted to the development and implementation of a limited entry system under the terminology of "exclusive guide areas". Specific questions include:

- 1) Does the exclusive guide area system comply with the provisions of Article I, Section I of the State Constitution and the further provisions of Article VIII, Section 17 in concept (if carried out properly).
- 2) If the system is conceptually within Constitutional bounds, does the method of implementation used by the Guide Licensing and Control Board comply with all applicable Constitutional and Statutory provisions.

These two questions are basic to the entire area system which has been in place for several years:

- 1) If guide A is cited for guiding in an area assigned to guide B, and guide A is willing to go through the entire legal appeal process, will he win if he is in every other way legal to guide in the area in question?
- 2) Do the broad protections applied to a guide's license in the Herscher case logically extend to the exclusion from using that license under the exclusive areas?

It would also be useful to have copies of all past correspondence between your office and the Department of Public Safety or the Guide Board on this subject.



Dear Senate Members:

In regard to the subject on the Guide Licensing and Control Board hearing, we wish to make our opinions, suggestions and recommendations known.

There is no doubt in our mind that the Guide Board does have a vital purpose to help properly control and manage the guiding industry, undoubtedly if the board were terminated chaos would arise. It is however evident that the board has not succeeded in properly fulfilling its objectives and unless significant changes are made we would favor its termination.

Its initial purpose was greatly needed however soon after its inception there followed continued inconsistencies in its procedures and policies. In its efforts to try and protect our investment and livelihood it actually has reduced it. We have been treated fairly in some regard and very unjust in others and thus it has been difficult to maintain proper objectives to stabilize our guiding business. More consideration should be given to full time guide operators. They have most invested and the most to lose. Use of areas should be more accurately established. Greater consideration should be given to game population for establishing areas. When areas are "joint use" harvest restrictions should be established between guides so that abuse does not arise out of uncooperativeness.

We are also concerned with the powers that have a dominant force superior to normal court proceedings, violations are not treated in proportion to their severity. Guide laws and regulations are often unclear and ambiguous which need revision. If the D2 legislation remains unresolved we can expect more complications with the increased pressure on the remaining hunting areas. Some guides will infringe on areas by unjust means, creating unbalanced harvest.

A We hope that you will recommend that unless the board establishes more positive and consistent policies that a new alternative be found to manage the guiding industry.

Dear Senator Bradley,

I was one of the three people who attended the tele-conference this afternoon at Wasilla regarding the hearing on the GUIDE LICENSING & CONTROL BOARD. Unfortunately, I didn't have the packet containing the information on the hearing until arriving at the Wasilla office so I was ill prepared to give any testimony to you over the air.

To begin with, I would like to go on record by stating that I fully support the continuance of the Guide Licensing & Control Board as an appropriate method of maintaining a system of checks & balances pertaining to Guide related activities. I began working for Pinnell & Talifson of Kodiak, Alaska at the age of 18 and was fully in their employ until being drafted and upon my return from Vietnam until the present, I have been working for them on a part time basis, now as a Registered Guide during either the Spring or Fall season. Although I have been a State employee for nearly 12 years, the Guiding Profession still holds a very high priority with me.

During the tele-conference this afternoon, I kept somewhat of a score-card of those who called in their testimony with the result being, approximately 3 to 1 in favor of keeping the Guide Licensing & Control Board. It seemed to me as those opposed, were individuals who for one reason or other, had had a confrontation with the Board. Some of their reasoning as to why they shouldn't be held accountable for their actions, i.e. "minor" violations e.g. snagging fish etc., could, in my opinion, be likened to being "little bit pregnant". Now while I believe that most of us sometime in our lives probably have slipped somewhat, I can hardly believe that it is any excuse to use if brought before such a body as the Guide Licensing Board. I would intend to believe that there was more to it than 'snagging a fish'.

Some other areas of interest to me were the collection of Trophy Fees and Protection. I feel that if Trophy Fees are necessary to be collected, these monies should go towards game management rather than placed into the General Fund. Also, Protection should be of a high priority as it is virtually impossible to have Management without Protection. Lastly, I would like to express my views in regards to Exclusive Areas. It would seem logical that if these areas were broken down into smaller units, there would be more hunting pressure as, more guides equals more hunters equals more hunting equals more pressure in increasingly smaller areas. In spite of seemingly unfairness to those who don't have an exclusive area, by maintaining a larger area, a more ideal conservation practice is effected. (Although there may be exceptions). The "heat" for lack of sufficient hunting areas should be more directed towards the Federal Government's land lock-up rather than the Guide Licensing & Control Board.

Dear Governor Hammond:

Since 1973 I have been chairman of the State Guide Licensing and Control Board. As chairman it has been necessary for me to work closely with the staff in the Licensing Department under the Department of Commerce. Our particular board is handling the correspondence and problems of about 420 registered guides and over 500 assistant guides, plus over 120 Class A guides. There is a wide variety of correspondence to answer. I personally have willingly given generously of my time to see that the questions that come up are properly answered.

My chief reason for writing this letter is to bring to your attention the fact that since my contact with the Department there has been a steady turn-over of help in the Department. The turnover in the guide section has been at the rate of about 1 each year. My observation places the turnover on the other desks representing the other twenty boards at a very similar rate. In all the cases of where the Guide Board had a change of secretarial help the change was related to the workload required and the lack of salary connected with that workload. The amount of time it takes to acquaint a new secretary with the work, and have her assume responsibility of moving the correspondence smoothly, is a major factor in how good, and smoothly, our Board functions. All the girls I have worked with in the Department have been very good and competent. In some cases, however, some have taken more responsibility than others, which certainly brings the workload up to a higher efficiency.

The Administration is now in the process of building up the new budget, and I would sincerely hope the proper agency would evaluate the increased workload that has occurred in the Licensing Division in the last five years, and also a recap of the turn-over of help in this division. If this is recapped I am certain that the rate of turn-over would be many times the state's normal average. That alone should raise some questions that require answers. We are all interested in good government and the way we get it is attention to the state employee problem when needed.





Guide Licensing and Control Board proposed program for Fiscal Year 1981:

Three meetings between Juneau, Anchorage, and Fairbanks, from three to four days for each meeting. A possible meeting at Nome or Kotzebue if the Arctic ;guide kprogram moves ahead on schedule.

If the D-2 land bill changes the status of over one hundred guides as to their exclusive guide areas, I think that the Board will be able to handle this work load within the regular three meetings.

I am going to make a line item report, which pretty well identifies the Board's activities during the 1981 FY:

1. Give written and oral guide examinations. Approximately 20 to 25 guides have been taking this exam yearly.
2. The Board would sit as a jury on violation cases presented by the Attorney General's office.
3. Hear petitions from guides on boundary changes.
4. Hear petitions on transfer of guide areas to other ;qualified guides.
5. Hear testimony for Master Guides.
6. Act on proposed guide areas in Game Units 1 through 4.
7. Hear testimony on impact of D-2 land legislation where guide areas are involved.
8. Testify on S.B. 101 and H.B. 405 requiring changes on the Guide statutes.
9. Make survey of Arctic villages to explain Arctic guide programs, which would involve the taking of marine mammals.
10. Finalize the upgrading of Master guide area maps in the Anchorage office.

It would repeal Part C, Line 3 in Sec. 08.54.200. This line made it mandatory that the Board revoke a license if guide was convicted of two violations. 
regarding the transfer of the Guide Licensing functions to the Department of Public Safety.

Travel costs are estimated for five members of the Board plus the Administrative Assistant for three meetings (approximately twelve days each) annually. You have requested a section-by-section analysis of Senate Bill 574 entitled "An Act continuing the existence of the Guide License and Control Board and amending the law relating to its powers and responsibilities; and providing for an effective date."

Section 1. The Guide Licensing and Control Board is established in the division of fish and wildlife protection, Department of Public Safety. This amendment ensures that three members of the board will be involved in guiding and that the remaining four members will have no involvement in the guiding business.

Section 2. This amendment provides that members of the board may not be appointed for more than two consecutive terms. Since a term is for three years, a person would have to wait three years before being reappointed to the board after serving two terms. There is no limitation on the total number of terms which a person may serve on the board.

Section 3. The board must elect a chairman and a vice-chairman annually.

Section 4. This section generally increases fees required for licenses to engage in the profession of guiding.

Section 5. Persons seeking licenses must pass an examination, and that the examination shall be held twice a year at both Juneau and Anchorage for the convenience of applicants.

Section 6. This section is amended to eliminate a licensure provision for transporters and to assure that a license is valid for at least one full year. Under existing law all licenses expire on December 31st following issuance regardless of when they were issued.

Section 7. An assistant guide license which has not been renewed for four years may not then be renewed until the applicant meets the qualifications for an initial license. Under the existing statute only a two-year grace period is provided.

Section 8. Under existing law the board is required to hold a hearing to consider disciplinary action if it receives complaints from three or more separate parties which a licensee has provided services to. The amendment provides a time period of five years within which these complaints must be received before the board is required to hold a disciplinary hearing. This section is also amended so that the board is no longer obligated to hold a disciplinary hearing when a licensee is merely charged with a violation of federal or state sport fish, game or guide statutes or regulations. Upon a conviction, however, the board is still required to hold a disciplinary hearing.

Section 9. The board is permitted the option of revoking, suspending, or denying renewal of a license if the board finds that the licensee does not meet certain requirements. Under existing law the board was required to revoke the license upon such a finding. This section is also amended to provide that specified disciplinary action must be taken by the board only when a licensee has been convicted of two violations of federal or state sport fish, game or guide statutes or regulations within the past five years. Under current law, two violations trigger mandatory disciplinary action regardless of the time period between the violations.

Section 10. This section is amended to remove reference to a transporter because transporters will no longer be licensed under this act.

Section 11 A reference to a transporter is deleted.

Section 12 A reference to a transporter is deleted.

Section 13 A new duty of the Department of Public Safety shall be the administration of the Guide License and Control Board.

Section 14. June 30, 1984 is set as the termination date for the Guide License and Control Board.

Section 15. This section repeals provisions which are inconsistent with this act.

AS 08.01.010(20) removes the Guide Licensing and Control Board from the list of boards to which Chapter 01 applies, since this board will no longer be administered by the Department of Commerce and Economic Development;

AS 08.03.010(b)(7) repeals the sunset provision for this board;

AS 08.54.100(5) eliminates the board's discretion to set qualifications in addition to those established by statute for licensure of master guides;

You have requested an opinion as to the status of statutory provisions relating to the responsibilities of a board or commission terminated under the provisions of AS 44.66.

I recall discussion of that issue during the hearings and meetings involved with setting up the "sunset" concept and legislation. The legislature intentionally modeled this portion of our law after the Colorado statute (CS 24-34-104). Under this version of sunset the statutory provisions relating to the responsibilities of a board or commission are rendered ineffectual by the termination of the board or commission. It is expected that the legislature would subsequently act to expressly repeal those statutes. The revisor's bill is considered a likely vehicle for that purpose.

Under the sunset concept the legislative committee of reference identifies problems and needs addressed by board and agency programs and evaluates among other things, whether or not continued regulation of the activity is in the public interest. One purpose of sunset legislation is to subject the programs and activities of all agencies, boards and commissions to a regular system of legislative scrutiny. When the investigating committee determines that an agency activity should be modified, or the activity continued but transferred to another agency, it introduces a bill to effect the recommended change. It recommends a measure of deregulation of an activity by doing nothing - allowing the regulating agency to terminate under the terms of AS 44.66.

If, for example, the legislature allowed the Alcoholic Beverage Control Board to terminate and no additional legislation was introduced to transfer responsibilities, etc., I believe a person could sell alcoholic beverages without a license but that it would remain a misdemeanor to sell alcoholic beverages to a person under the age of 19 years.

It is my opinion that statutes which depend upon the exercise of a power of a board or commission for their execution are rendered ineffectual by the termination of that board or commission under AS 44.66.

You have asked if it is within the scope of the Sunset Law to continue the normal exercise of the powers of the ABC Board at least until March 1980 and then, absent any statutory resurrection, phasing it out.

We believe that you are acting within the scope of the law.

The 1977 Legislature enacted a sunset law for two classes of agencies. §§ 2 and 3, ch. 149, SLA 1977. One section applies to 22 expressly designated professional and occupational licensing boards. It has been codified as AS 08.03.010. The other applies, first, to five expressly designated regulatory commissions and then to certain other agencies. It is codified as AS 44.66.010, 020. The latter, over a period of years, provides for review and potential termination of all state agencies and institutions. */ The ABC Board is one of the regulatory agencies specified in AS 44.66.010.

Both provide for "termination" on dates certain, e.g., June 30, 1979, in the case of the ABC Board. Both provide for a terminated agency to "continue in existence until June 30 of the next succeeding year for the purpose of concluding its affairs." Compare AS 08.03.010(c) with AS 44.66.010(b). It is at this point, however, that an apparent distinction arises.

Under AS 08.03.010(c), during its year of continued "existence," the terminated agency's powers expressly remain undiminished. A similar provision does not occur in AS 44.66.010(b). It is silent on the matter. Ordinarily,

when two provisions are enacted together on related matters and are distinguishable in this manner, the distinction is considered to intend a substantial difference, i.e., here, that agencies terminated under AS 44.66.010 do not continue to possess their powers during this closing-out year. There is no reason, however, to perceive such a difference here. The situation is the same for both classes of agencies and for the objects of regulation and public protection. Indeed, AS 08.03.010(d) provides that the provisions of AS 44.66.050 govern the termination of agencies under AS 08.03, a rather persuasive indication that the same rules are to apply to both classes of agencies.

Our conclusion is, therefore, that the difference in wording is inadvertent and that there was no intention to strip the regulatory boards terminated under AS 44.66 of their powers during the year in which they are closing out. If the boards are not resurrected during that last year, then their powers cease to exist, and they cannot -- absent new legislation -- be delegated to the departments in which the boards were located.
